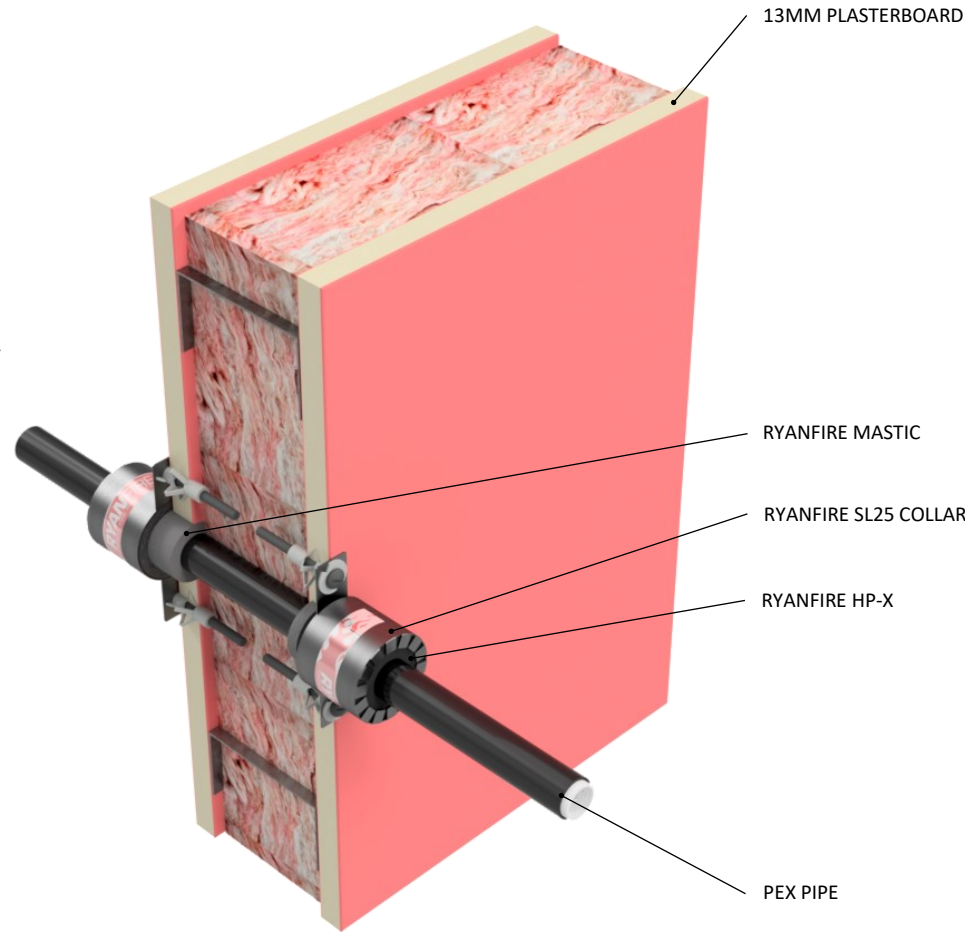


INSTALLATION INSTRUCTIONS

1. ENSURE THE APERTURE IS CLEAN AND FREE OF DUST AND DEBRIS.
2. APPLY RYANFIRE MASTIC TO THE ANNULAR GAP BETWEEN THE PEX PIPE AND THE WALL.
3. SELECT THE RYANFIRE SL25 COLLAR TO FIT AROUND THE PEX PIPE.
4. FIX THE SL COLLAR AROUND THE PIPE AND SLIDE IT UP TO THE FACE OF THE PLASTERBOARD WALL. FIX THE COLLAR INTO PLACE USING 55MM HOLLOW WALL ANCHORS. ENSURE ALL FIXING POINTS ARE USED.
5. APPLY HP-X INTO THE ANNULAR GAP BETWEEN THE PIPE AND THE COLLAR TO THE FULL DEPTH OF THE COLLAR.
6. REPEAT THIS PROCESS TO THE OPPOSITE SIDE OF WALL.
