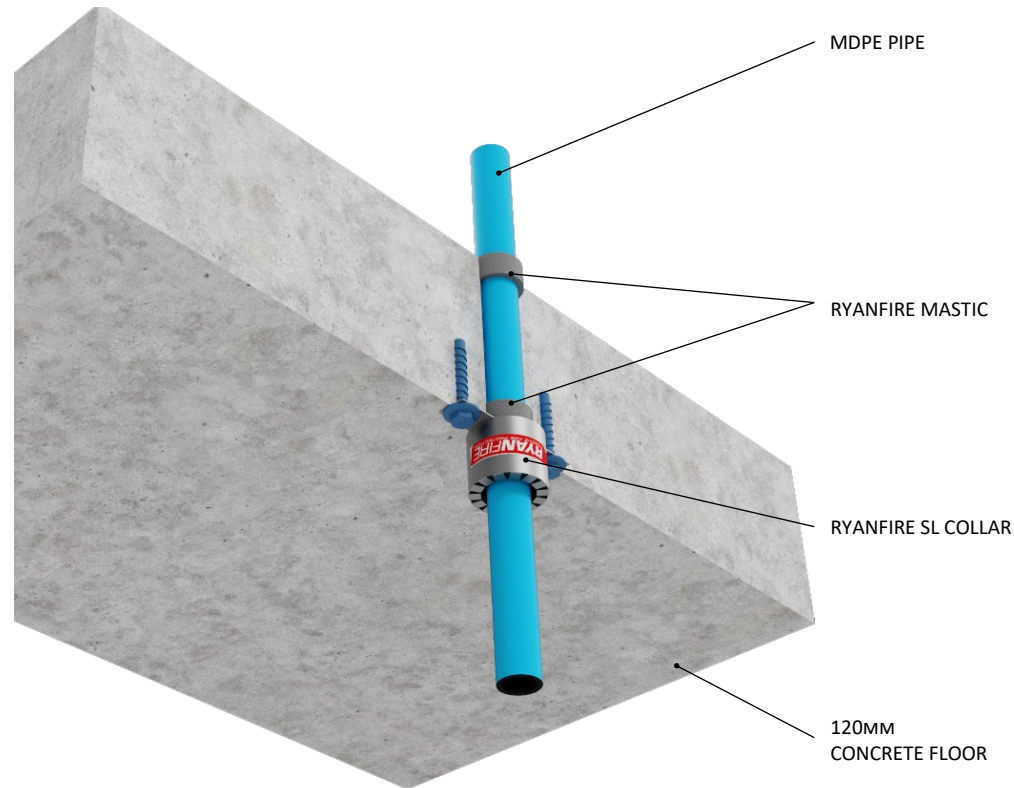


INSTALLATION INSTRUCTIONS

1. ENSURE THE APERTURE IS CLEAN AND FREE OF DEBRIS AND DEBRIS.
2. SELECT THE CORRECT SIZE COLLAR TO FIT AROUND THE MDPE PIPE.
3. APPLY RYANFIRE MASTIC INTO THE ANNULAR GAP BETWEEN THE PIPE AND THE FLOOR, ON BOTH SIDES OF THE FLOOR.
4. POSITION THE RYANFIRE SL COLLAR AROUND THE PIPE AND SLIDE IT UP UNTIL IT IS FLUSH WITH THE BOTTOM OF THE FLOOR.
5. FIX THE SL COLLAR TO THE CONCRETE FLOOR USING 32MM CONCRETE ANCHOR BOLTS. ENSURE ALL FIXING POINTS ARE USED.
