AGM Update

We have just completed the annual general meeting (AGM). During this meeting, we provided a brief summary of our AGM report. We also covered the formalities of being a not-for-profit association, and a few resolutions were presented and voted on by members. We required a quorum for this, and—as the records show—we exceeded the minimum number of members required to constitute a quorum for the AGM. The following resolutions were presented and voted on:

- 1. That the minutes of the 2019 AGM be approved.
- 2. That the 2019–2020 annual reports as circulated be adopted.
- 3. That the audited accounts for the year ending 30 June 2020 be adopted.
- 4. That Crowe be re-appointed as the association's auditors for the year ending 30 June 2021.

All resolutions were unanimously passed by the members present at the AGM or by way of the proxy votes submitted to the chair to cast. I would like to thank those who attended in person (no small feat in Auckland), those who attended via Zoom, and those who read the AGM report and sent in proxy votes. The AGM report will be uploaded to the website in the next week or so, but just email us to request one if you would like a copy before then.

If you wish to check this, please get in touch so we can confirm who we sent it to and reissue it if necessary. We intend to seek more member engagement via short surveys to get feedback from members who can't make it to SIG meetings, so if you get surveys in the future, be sure to have a read and send your responses so we can hear the voices of as many members as possible in the development and running of the association.

Membership Process

As with any organisation, we need to ensure we manage the growth of the association and its long-term objectives match the needs of our long-term, current, and future members. As I mentioned in October's newsletter, we are reviewing both the process and membership levels now and holding off on processing new memberships until this is complete. The board has agreed in principle to some minor changes in the membership application process, and these changes are now being drafted for legal review. Once this is complete, we will re-start processing new applications under the new procedures.

Managing growth and direction is an important part of any organisation, and FPANZ is no different. With the success and achievements we have delivered in the past few years, we are seeing significant increases in enquiries about and applications to be part of this organisation. We also need to be able to uphold our values and commitments under the Code of Ethical Conduct and ensure that both current and future members of this professional body will also continue to do so.

In closing, we still have a busy few weeks ahead of us with the desire to close out some of our projects and to prepare others for starting in the new year. We will publish one final newsletter in December before closing the office for the year.




