

A Message from our National President

At the end of my first year as President, I am pleased to report on the activities of the Fire Protection Association New Zealand Inc (the Association) over the past 12 months.

Financially, the Association is going from strength to strength and we are now in a position to reinvest some of our surplus funds back into the industry. All sectors of the construction industry are facing recruitment pressures and building quality pressures, exacerbated by the sparsity of qualified and experienced engineers. It is somewhat paradoxical that during this construction boom, where companies should be generating good profits, it appears that they cannot afford to train, due to the lack of resources. Therefore our initial investment focus will be to assist in recruiting and developing staff, and particularly youth, as future leaders of the industry. Our next emphasis will be on the development of technical leadership for the future.

As I write this annual report, the fire at the New Zealand International Conference Centre is all but extinguished. This fire will likely be one of the most expensive fire losses that our nation has experienced and, due to its nature, will have far reaching consequences. (My own Auckland apartment, approximately 100 metres away from the complex, will need to be decontaminated due to smoke ingress - which is relatively insignificant but indicative of how far this has impacted, and potential complex liability implications.)

At our Council meeting prior to the fire, we discussed the possibility of promoting a Code of Practice for Construction Fire Safety. In association with our affiliated organisations (including Society of Fire Protection Engineers (SFPE) and Institution of Fire Engineers (IFE)), along with a drive from sectors of the Government and other construction sectors, we expect that we will see a renewed emphasis on producing such a document.

With respect to this Conference Centre fire, there has been some uninformed press. Journalists were questioning why the alarm system did not work, not realizing the impracticability and challenges of commissioning an alarm system on a working construction site. One well known radio commentator was asking why sprinklers did not control a fire on the roof of the building! We are taking active steps to improve community understanding and ensure that our industry gains some quality publicity which reflects the real value of what we do to improve fire safety and reduce the impact of fire in New Zealand.

The Association and its members have been active in promoting standards and standardisation within



our industry. To that end, the Association has been instrumental in forming the Fire Protection Charitable Trust, whose primary purpose is to fund the development of fire protection standards. Its secondary purpose is to assist in funding industry training. This Trust is funded by the Standards Levy (which Aon has been collecting on the Trust's behalf) for the development of mechanical fire protection standards, as well as a new levy being collected by all accredited inspection companies, for the development of electronic fire protection standards. With respect to these electronic fire standards, the manufacturers have provided seed funding to ensure that NZS 4512 can be amended or revised without a delay and to allow the fund to be built up. While the Trust has been set up by the Association, going forward, it will be its own separate entity.

The Association and its members have also been instrumental in developing a revision to NZS 4541 Automatic Fire Sprinkler Systems, which will be published early next year. In addition, we have been promoting a revision of NZS 4512 (Fire Detection and Alarm Systems in Buildings) which is anticipated to commence next year. We will also be assisting both the Building Sector Performance Group (of the Ministry of Building Innovation and Employment) and Fire and Emergency New Zealand in revising NZS 4510 (Fire hydrant systems for buildings).

Association members have also been instrumental in coordinating several Codes of Practice that should be published next year, including:

- Code of Practice for the Specification and Application of Intumescent Coatings
- Code of Practice for the installation of Passive Fire protection
- Code of Practice for Integrated Building Systems

I would like to highlight how well received this year's Fire NZ Conference was. This conference is a collaborative event hosted by the Association, the Society of Fire Protection Engineers and the Institution of Fire Engineers. It was managed and coordinated by the Association. The general feedback, including from our international speakers, was that this conference was one of the best and most educational fire conferences that they have attended. Certainly, the

quality of speakers was better than several conferences I have attended overseas. If you have not been to a FireNZ Conference before, I urge you to consider attending next year's conference at the Rotorua Energy and Events Centre which will be held on 2-4 September 2020.

The Association's staff, Board and Council are committed to minimising the impact that fire has on New Zealand. We actively work with our members, government and the wider community to achieve continuous improvement in regulations, standards, education, awareness, products and services for the protection of life, property and the environment from fire.

We urge all members to get involved in the Association and to suggest positive future initiatives that the Association should get involved in. You will gain more from your membership if you participate, than if you do not.

In closing, I would like to thank all those who have contributed to the Association this year, including our team of Scott, Elaine and Vicki, our Board and Council Members, and those who have contributed to our various working groups, developing Codes of Practice and Standards.

Together, we make a positive difference.

A Message from our Chief Executive Officer

Welcome to the annual report for the Fire Protection Association of New Zealand (FPANZ). Having successfully completed another financial year and our independent audit of the accounts, it is again time to reflect on some of the more significant milestones we have achieved over the past 12 months and hint at what the 2019/2020 membership year holds for the association and its members.

First, though, I would like to take a moment to offer my sincere thanks to our small FPANZ team of Elaine Christy and Vicki Alach, both of whom are integral to the running of the association. I also thank the members who sit on the FPANZ board and national council for their personal commitment and time invested in helping the association grow, directing our efforts and shaping the future of our industry. I offer my thanks to all the financial members of FPANZ; your continued support helps us deliver on our mission and vision for the fire protection industry in New Zealand.

Special thanks must go to both Mitchell Brown and Keith Blind. As many of you know, these men have been actively involved with the association in various positions, including president, for many years. This year, the board awarded these dedicated men honorary lifetime membership status for the considerable contributions they have made to our association and the wider fire protection industry.

Without shortcutting the reports of the special interest group (SIG) chairs, I would like to touch on some of the work we have undertaken and provide a holistic picture of the association.

Government Review of Vocational Education

One significant but unplanned area of work this year related to "on-the-job industry training". On Wednesday 13 February, the government announced proposals for major structural changes to New Zealand's Vocational Education and Training (VET) system. These proposed reforms will affect all industries, including fire protection. While review and improvement were definitely needed, the proposals were far more wide reaching than we expected. The association spent considerable time canvasing members about the possible implications of the various propositions tabled by the government. We also provided an industry submission to the Tertiary Education Commission (TEC) and our current industry training organisation (ITO) Competenz to ensure our message was relayed.

The government has since provided updates on the proposals, which will now see workforce development

councils being established and the current ITO structure dismantled. I would like to assure our members that we



will continue to strongly advocate for industry in this area to ensure that the voices of our members and the wider industry are heard during these reforms. This process will likely be ongoing for the next two to three years and possibly have an impact on not only how we train but also the training providers that will deliver our current and future qualifications. We encourage our members to continue to respond to us and attend any future workshops that we facilitate on this topic to ensure we get more favourable outcomes over the coming year or two.

Codes of Practice

The association continues to see the need for further development of FPANZ codes of practice (CoP). Over this last year, we started work on three CoP:

- Specification and Application of Intumescent Coatings
- Installation of Passive Fire Protection
- Integrated Building Systems

Part of the association's strategy is to fill voids where they exist in standards or where we see a significant need for clarification in specific areas. We use a process that is very similar to that used in the development and updating of NZ standards. While a CoP can often take a year or more to develop, the process is often quicker and lower cost than that for a formal NZ standard. Once developed, these CoPs are reviewed and commented on by other stakeholders then submitted to the FPANZ council for review and adoption. We will continue to expand on our suite of CoP and build on areas where the industry needs clarity and direction. As I write, the CoP for the Specification and Application of Intumescent Coatings has completed development and is undergoing a final review of the comments. We are hoping it will be released before the end of the year. I would like to acknowledge and thank all the members of the Passive SIG Coatings Working Group, who are also referenced in the front of this document.

Standards Revisions

This year saw the development and formation of the Fire Protection Charitable Trust, which was a significant milestone. This trust is a separate legal entity, but FPANZ was responsible for its inception and the adoption of a voluntary levy system for sprinkler and alarm systems to enable us to continue to develop NZ standards. It is satisfying to note that NZS4541 is

now in the final stages after public comment and that the submissions are being reviewed and considered before the final release of the document. We have now also started the selection process for the committee for the update of NZS4512 and NZS4514 and aim for kick off in December 2019 or January 2020, with a project timeframe of up to 15 months. These are significant projects for the association and ensure we can keep enhancing and updating the standards we all work to.

FireNZ Updates

Those who were fortunate enough to attend FireNZ 2019 will have seen that, yet again, we put on a tradeshow and conference on a par with or even better than some international fire protection conferences. We run FireNZ with our partners, the Society of Fire Protection Engineers (SFPE) and the Institution of Fire Engineers (IFE), but FPANZ carries out all management functions for the event on behalf of the FireNZ committee. The positive feedback we receive is reinforced by the international speakers from Dubai, Australia, the USA and the United Kingdom who agree to attend. The positive comments we receive are obviously not people just being polite but genuine praise for the event and acknowledgement of how far it has come in recent years. Without a doubt, the line-up of international speakers was the most extensive yet, and they were well-received by our delegates. The full-panel Q&A session on Friday morning was also very successful and clearly allowed a far greater level of interaction with the audience than is possible during standard one-on-one Q&A sessions. We hope you will attend FireNZ 2020, which will be held from 2nd to 4th September at the Rotorua Energy Events Centre. It is already shaping up to be a great event.

Summary of the year

I am pleased to once again be in a favourable position to report to our members on all of the good work done in the past year. While our objective is not to deliver financial surpluses each year, it has been important in the past few years to contain and manage our operating expenditure with an eye on the longer-term goals of the association. Our surplus this year was higher than expected or budgeted because we did not proceed with the anticipated Fire101/

Gateway project. This would have been a significant project with expenditure of \$70,000; however, our prudent management process and due diligence indicated the deliverables would not be realized as planned, so we decided to retain and reallocate the funds for another financial year. Instead, we explored a more realistic and deliverable project that has now been approved by the board. This project is a nationwide pilot of "Careers Recruiting and Industry Development" involving schools, careers advisors and school leavers and including a student-placement programme.

The association is now in a strong financial position and, with continued careful and considered future initiatives and financial investment, we will be able to continue to deliver more objectives in the coming years. There is, and I suggest always will be, much work to do on behalf of industry. However, in the past five years, the association has made significant improvements not just to our organisation but to the wider industry and the community of New Zealand. Not all these changes have proved easy or been welcomed by some naysayers, but the proof is in the deliverables being produced by FPANZ, the growing membership base, the level of member engagement and the financial stability, improved transparency, strategic direction and wider profile of the fire protection industry and its members.

This coming year, the main focus areas and development projects for the association include an update of the suite of equipment registers, the Careers Recruiting and Industry Development project, promotion of the passive installers qualification, pursuing industry regulation, training and professional development, additional CoP, and release of industry position statements. I strongly encourage you to read our monthly newsletter to keep up with our industry news and for regular updates on these projects and how you can provide input.

Thank you once again to our members for the continued support of the association in our 2019/2020 financial year. I look forward to making this year another great step forward for FPANZ, its members, and the wider community we all support.

FPANZ Events

The FPANZ Events Department aims to educate industry members and the broader community by delivering current information on all matters relevant to the fire protection industry and related industries. FPANZ events cover a wide range of industry related topics and feature highly engaging speakers to enable attendees to stay up-to-date and meet continuous professional development requirements.

These events include an annual national conference "FireNZ" with FPA, SFPE and IFE seminars that provide ideal forums to meet and socialise with industry members and key stakeholders.

For FireNZ 2019, "The Future of Fire Protection" was the key theme. It proved to be a successful event, held in the Vodafone Events Centre in Auckland, with over 280 delegates and some 150 exhibitors, drawing good support from those who have a keen interest in fire protection.


SIGs

Special Interest Groups

FPANZ has the following special interest groups (SIGs):

- Alarm and Sprinkler Contractors Group
- Passive Fire Protection Group
- Evacuation Consultants Group
- Hand Operated Fire Fighting Equipment Group
- Inspectorate Group

Membership of these groups is open to Individual, Corporate & Organisation members who are able to demonstrate a professional connection to the work of the particular group. Their purpose is to provide a forum for members to raise issues and concerns to bring together FPANZ members with allied interests, keeping them up to date and improve the flow of industry-specific information to and from members. They are also a mechanism for instigating projects (e.g. position papers, codes of practice) relevant to their specific spheres of interest.



The following SIG updates represent the opinions and views of the SIG Chairs and do not necessarily reflect the official position of the Fire Protection Association.

Passive Fire Protection SIG Report

This is the last report of my tenure as Passive Fire Protection Special Interest Group Chair.

Back in 2016 when I chaired my first meeting, it was agreed by the group that too many years had been spent discussing the problems rather than tackling them, so we decided on a number of key initiatives that we felt would pave the way for improvement in our industry.

The initiatives were -

- FPA Product Register which would form a central record of products with test data that meet standards set within the NZ Building Code – and be a key tool in the process of knowing when an "Alternate Solution" with non specific test data should be considered.
- A new industry qualification which would help ensure products are installed by a suitably qualified person.
- Code of Practice providing technical guidance to industry surrounding passive fire protection.

In 2018 we successfully launched the Passive Equipment Register. In 2019 not only have we developed a Code of Practice for Intumescent Coatings, which early indications show will bring huge change and improvement to this very technical area of passive fire protection, but October saw the launch of the new NZQA Level 3 Passive fire protection installers qualification, a joint venture between Competenz and FPANZ.

However, as always, the "job is never done". 2020 will hopefully see the SIG focus on more codes of practice tackling varied topics such as Fire Dampers, Smoke Curtains, Fire Doors to name but a few.

Passive fire protection membership grew yet again, averaging two new members per month, and is now the largest special



interest business sector within the association.

FireNZ 2019 saw strong passive industry exhibitor and attendee support.

As a final note, I'd like to thank the SIG for the support I have received over the last three years. Without the "team" these initiatives couldn't have been delivered - a special thanks goes out to Scott Lawson for his commitment to the "passive cause" as well as a small group who I can almost bank on to volunteer when it comes to taking on voluntary work that needs to be done to enable us to deliver the "goods".

It's taken three years to get where we are today, I believe industry is better for our hard graft, I can't wait to see what the next three years will bring!

Hand Operated Fire Fighting Equipment (HOFFE) SIG Report

The last year has been a mixed bag for the HOFFE group, with progress being made in some areas but still much work to be done to ensure continued development of the sector.

- We have launched the HOFFE product register in 2019 and had some positive feedback on this and a new version is due to be released soon with additional suppliers.
- that provides clarity and recognition of the importance of the role that our fire equipment often plays. This is important for both the FPA's member companies and those utilizing the FPA's website. The education and endorsement of all fire equipment to form a fire protection package is surely the end goal. Ultimately this statement benefits both the FPA member companies, commercial interests and the public.
- The Virtual Reality Training programme has the support of our members and is progressing in terms of development and possible future uses in the sector.
- We have attracted some new members to the group - the insurance sector is proving to be a strong supporter of the group and encourages the installation of hand-held firefighting equipment.
- We are once again allowed to import mobile fire extinguishers, as this has been a sticking point for some time so clarity and a final decision on this is welcomed.
- We have achieved a closer alliance with the Cylinder Testing Laboratory Association, including attending each other meetings and making joint proposals (united front) to Worksafe.
- More direct contact with Worksafe and the message delivered several times to their representatives that, as large-scale importers of pressure vessels, we need to be informed of proposed regulatory changes in our industry.
- Interested parties such as insurers are in regular contact discussing their concerns with us regarding both service and products.

- The HOFFE Service Code of Practice has been distributed again and our members are aware that, barring any
 - serious problems, the active part of the group would like it endorsed and in use sooner rather than later.
- We have been pushing for NZS4503:2005 to be revisited as it is our opinion that the wording of several parts of the standard need updating and refining to be more concise, especially around the definition of "Competent Person". We know that other fire protection sectors like sprinkler and alarms have the same concerns and these definitions should be addressed and clarified in future revisions of the standards.

Unfortunately, we have had a decline in attendance at the SIG meetings, for several reasons. It costs time and money to be an active member of the group, and our members are busy in their businesses as there is plenty of work at present. Industry groups are not seen as a priority that give immediate benefit, but this is often a short term view that doesn't serve the industry well. We will be revisiting how to have stronger engagement in the next year.

The authorities seem to continue to allow those who are not abiding by the rules (Hazardous Substances etc.) to actively operate eg. trade stores, online shopping. We need to take a stronger view on these to ensure the public is not being misinformed.

Little pro-active auditing or follow-up from the authorities (local council, LTSA) on fire equipment matters means that companies prioritise their time and effort differently. eg. no penalty for non-compliance enables those fire equipment companies who operate in the more opportunistic and often unethical part of the industry to exist without significant penalty.

Evacuation Consultant SIG Report

The Evacuation SIG has had a busy and productive year. There have been several ways in which the revised evacuation regulations have impacted the way in which we plan and prepare our evacuation schemes, along with heightened emphasis on trial evacuations and reporting.

Working with FENZ, the SIG has managed to answer many of the queries that have been presented by our members, ranging from acceptable content of fire action notices, through to the use of evacuation chairs.

I am glad to be able to say that we now see a number of fire risk officers attending our meetings when their time allows, and we have regular input from the FENZ fire information unit, plus support from senior staff. With this input, we are kept up to speed on organisational change and process, such as the review of the online portal for scheme application. It would be great to welcome fire engineers, fire protection engineers and installers to our meetings to understand some of the challenges they face and how we can work together to help ensure our new and renovated buildings are fit for purpose.



This year we have revised the certified evacuation consultant qualification, updated the code of practice and seen several guest speakers at our meetings. I have been working on a project which will hopefully see several of our meetings next year hosting short workshops to deliver fire engineering knowledge updates for evacuation consultants.

Inspectorate SIG Report

Reflecting on my first year as Inspectorate Special Interest Group Chair, I believe that our industry has some things that it needs to work on.

Firstly, there is the standard of workmanship and quality of installation we are seeing done. This can be partly attributed to a lack of training or supervision, coupled with a number of contractors that are new to the industry and do not understand the implications that their decisions have on the safety of the pubic and property. This is an issue that we will continue to struggle with until we are able to have our industry recognised as a specialist trade, and have a means of sanctioning those contractors that are not completing the installations to an acceptable quality.

Training is another area where I believe we as an industry should be doing better than we are. While the FPA puts on "Get it Right" seminars when it can, there are other training opportunities out there that just need to be researched. I am a believer that you are never too old to learn.

Like a lot of companies, the number of Inspectors seems to continue to grow, with inspectors changing companies and new inspectors coming to our side of the industry. What we must remember though is that where an experienced technician becomes an inspector, a gap needs to be filled. It is up to the Inspectorates to also look for and employ staff that need to be trained. Certainly, my employer is bringing youth into our sector.

The review of NZS4541 has been completed, with the last of the public submissions having been

reviewed recently. Now we wait for the revised standard to be formally accepted in the new year. The FPA will be putting on some more Seminars to cover changes made to NZS4541. Watch out for dates and times for your region.



At the time of writing this, the nominations for the FPA members for the review committee for NZS4512 have closed, with voting to be undertaken in November. Until the committee is formed and the scope of review is agreed, I cannot say timewise when the new standard may be published but watch this space for updates along the way.

Finally, it has been an interesting year seeing how the FPA works behind the scenes, the committees, the public consultation, the changes to legislation that affect our industry. It is also surprising the number of changes proposed by the government that results in the FPA putting a submission in for consideration. A valuable resource that would result in our industry being left in the dark otherwise.

For those who get to have a break over the Christmas period, take care, as our industry needs you in the New Year. See you all in 2020.

FINANCE REPORT

For the year ended 30 June 2019



The association has had another busy and successful year, once again producing a good financial result while undergoing several changes in the areas of reporting and administration.

The decision was taken to transition from Westpac Bank to Bank of New Zealand in early 2019 to provide easier access and management of the accounts. This process is now well underway, with the last remaining Westpac account to be closed before year end. The BNZ site allows the relevant board members greater visibility and is proving to be far more adaptable, with an increasing need for systems that can be accessed in any location. We also have the ability to manage term deposits within our account structure, which will mean that we can easily allocate our funds for maximum return.

We are pleased to report that once again we have had no debt to write off, and our collection rate is closely managed to ensure that our cashflow is unaffected. The payroll is also now completed "in house" which has simplified the process for all concerned, a cost-effective change implemented without sacrificing the appropriate controls.

Vicki Alach joined FPANZ in mid-2018 as our Administrative Assistant and has become a valuable member of the team, streamlining administrative processes and providing a friendly and helpful first point of contact to our members and the public.

The external audit of our Financial Statements for the year ended 30 June 2019 was once again completed by Crowe Horwath, a process which was made easier by their familiarity with our systems, this being the third

year they have been charged with auditing our accounts. We are pleased to report that the Auditor's Report was extremely positive.

FPANZ produced another strong surplus for the year of \$127,214. Although this was 22% down on the surplus of



\$162,623 for the year ended 30 June 2018, primarily due to the difficulties encountered with presenting the training seminars planned for the year, the result was better than expected and continues the positive trend.

The financial position of the Association continues to strengthen with the Working Capital (ie. Current Assets less Current Liabilities) increasing substantially from \$329,738 in 2018 to \$452,110 in 2019. Accumulated funds have increased also from \$337,743 to \$464,956, once again ensuring that the Association has funds to enable the implementation of planned projects within the industry.

STATEMENT OF

ACCOUNTING POLICIES

For the year ended 30 June 2019 in New Zealand Dollars

1. Basis of Preparation

FIRE PROTECTION ASSOCIATION (NEW ZEALAND) INCORPORATED has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Basis of Measurement

The financial statements are prepared on the historical cost basis except certain items for which specific accounting policies are identified.

Presentation Currency

The financial statements are presented in New Zealand dollars (\$).

2. Significant Accounting Policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

(a) Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the entity and revenue can be reliably measured. Revenue is measured at the fair value of consideration received, excluding GST, rebates, and any trade discounts.

Revenue from services rendered is recognised in profit or loss in proportion to the delivery of the service at the reporting date. Under this method, revenue is recognised in the accounting periods in which the services are provided.

Interest income is recognised on an accrual basis.

(b) Goods and Services Tax (GST)

All amounts are recorded exclusive of GST, except for Accounts Receivable and Accounts Payable which are stated inclusive of GST.

(c) Income Tax

FIRE PROTECTION ASSOCIATION (NEW ZEALAND) INCORPORATED is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

(d) Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

(e) Receivables

Receivables are stated at expected realisable value. Bad debts are written off during the period in which they are identified.

(f) Liabilities

Liabilities are stated at the estimated amounts payable and include all obligations that can be reliably estimated. Current liabilities include the amount payable within twelve months of these financial statements.

3. Changes in Accounting Policies

There have been no changes in accounting policies during the financial year (2018 - nil).









