# A Message from our National President

I am pleased to provide our members with this year's President's Report for the 2018 Annual General Meeting of the Fire Protection Association NZ. The year in reflection has seen various initiatives being completed and others started by the team of volunteers and the FPANZ office.

Financial, Operational, and Technical reports from our Executive Director and special interest groups (SIG's) are tabled which provide further overviews of the areas of interest to members.

Our strategic direction taken to provide the reinvestment of funds over the last 2 years has seen continual operational improvements and member benefits.

We are growing as an association in areas of revenue, membership and profitable returns.

It is encouraging to see the range of organisations, both local and overseas, that are seeing value in becoming engaged with our association. Membership renewals are stronger this year particularly in the passive market which has seen a number of new entrants.

Today FPANZ is deeply involved in the organising and management of FireNZ. This year Tauranga hosted the event and we have seen another level of improvements in the scope and delivery of this annual industry highlight. In addition, our involvement with government and the need to work with the development and delivery of industry training has become much more prevalent. The monthly newsletter continues to inform and remains an important link with members.

The website has been popular as well with many members choosing to use this as part of their resource material especially for product listing in the alarms/ detection area and the new passive content. We are seeking new investment in this area to provide more benefits to listing other key product groups in the future.

With the role of Executive Director headed by Scott Lawson for the last 2 years we have seen further evidence of process improvements and financial returns. We have more capital to reinvest and now have a separate charitable trust to provide ongoing funding for training and standards development. The association has invested further time and resources in nurturing key relationships with those who remain engaged in the mainstream areas of fire protection.

The FPANZ Board and council, as a group, work collectively to ensure that the governance needs and strategic goals and

direction of the FPANZ are being achieved.

FPANZ has been very fortunate to have had the services of its board and the support from Chris Orr within the Fire Protection Association Australia to work in key strategic areas. Chris has signalled his time with us is now coming to a close and we thank him for his commitment of time, energy and insight over the past 3 years.

The SIG committees have worked throughout the year in strategic areas of importance to each sector group.

Separate reports from each SIG Chairperson are included with the annual report. The Passive group is led by Paul Ryan as chairperson. Paul is passionate and focussed on delivering results, which is an indicator of the value members are experiencing along with new business being created. The SIG chairs also continue to promote their positive outcomes, with progress being made in all areas . From my desk, the contractors group continue to lack some cohesive elements and therefore some wins on the board. They need to step up their future game plans.

We continue to have close working relationships with other countries – particularly The Fire Protection Association in Australia with which we have much in common. Scott Lawson and Chris Mak (who is the newly appointed FPANZ President for 2019) have been fortunate to visit the Australian office and share opportunities for both organisations.

This has been my final year as President of FPANZ and I am excited at the future possibilities facing the new board, and governance roles we have introduced. The opportunity to refresh and update the constitution is a key deliverable outcome. To those members who have now served their terms in office we appreciate your contributions. To those members continuing or now joining the Board or Council be prepared for another very busy year ahead as you lead our industry and shape its future.

#### **Training and Seminars**

FPANZ liaises with a number of training organisations, manufacturers, suppliers and industry specialists both in New Zealand and globally to bring training and development seminars to its members.

#### **Industry Communications**

FPANZ Communications Department is responsible for producing the monthly FPANZ Member Newsletter along with two FireNZ Industry Magazines per year. The Communications Department also oversees development and delivery of all FPANZ external communications, including media releases and important announcements and is also responsible for the ongoing enhancement of the FPANZ website www.fpanz.org, as well as related sites and social media channels.

#### **FPANZ** Events

The FPANZ Events Department aims to educate industry members and the broader community by delivering current information on all matters relevant to the fire protection industry and related industries. FPANZ events cover a wide range of industry related topics and feature highly engaging speakers to enable attendees to stay up-to-date and meet continuous professional development requirements.

These events include an annual national conference "FireNZ" with FPA & SFPE seminars that provide ideal forums to meet and socialise with industry members and key stakeholders.

For FireNZ 2018, "EVOLUTION OF FIRE, Reflecting on the Past, Looking to the Future" was the key theme. It proved to be a successful event, held in ASB Baypark Stadium Mount Maunganui, with over 230 delegates and some 45 exhibitors, drawing good support from those who have a keen interest in fire protection.

With the continued support from FPA Members IFE & SFPE, we continue to see a bright future for the event in 2019 next year at the Vodafone Events Centre back in Auckland.

# A Message from our Executive Director

Welcome to the annual general report. I am pleased to summarise the activities of the last financial year and give an update on the future direction of our association.

First, I offer my thanks to the FPANZ members who volunteer their skills, experience and time to assist with the ongoing development of the association. To all of you who turn up and contribute to the special interest group (SIG) meetings, thank you for your valuable contributions and helping us achieve the objectives we set for our association. Special thanks to the SIG chairs and council members who donate so much of their expertise and time over and above the SIG meetings. I would also like to specifically mention the board of directors for their support of myself and the FPANZ staff.

Our President, Keith Blind, has completed his term and deserves special mention for his contribution to the association during his time both as executive director and as president. Keith will remain on the board in the immediate past president role to offer continuity in the handover to Chris Mak, the incoming president.

In addition to the president's report and more detailed updates from the SIG chairs, other areas of the association's work deserve special mention.

#### IT and Infrastructure

The association was well overdue to invest in IT and infrastructure, as our hardware and software were all significantly outdated. Phase one of this project worked to address the immediate issues, replacing all computers and switching to an office 365 environment. This ensured staff could perform their daily tasks with ease and the computers and software were fit for purpose. As a result, the team can also now operate remotely at meetings, training and events such as FireNZ, which has resulted in significant cost reductions. We have also embraced the technology necessary to enable members to use video conferencing to attend meetings. This is a significant step for members located outside the main centres and has proven to be one of the best things we have done for member engagement.

We are now exploring phase two, which would see a complete replacement of our outdated and dysfunctional customer relationship management (CRM) system. We intend to offer enhanced member services and greater functionality for members and staff alike. As



a former independent project manager, I am all too aware that these kinds of projects can be notoriously costly if not investigated, planned and implemented well. Therefore, we are spending significant time and effort in the pre-planning phase before making any commitments. We are also very fortunate to have been working with the FPAA to see whether the systems and processes they use can be replicated in New Zealand, thus saving us time, effort and development dollars. I look forward to being able to progress this area for our members and the benefits it will bring.

#### The Fire Protection Charitable Trust

Creation of the Fire Protection Charitable Trust is a significant milestone for our members and the wider fire protection industry, and I am pleased to advise that we have been successful in this project. My intent for the trust was to have one primary and one secondary function: standards development and industry training. FPANZ has been the driving force in getting this trust off the ground, but now it is up and running it is completely separate from FPANZ, with its own board of trustees. FPANZ continues to donate administration, accounting and other services to assist the trust in achieving its objectives. I thank the founding trustees: David Prosser - Chairperson; Jacqui Bensemann - Treasurer; Nicky Marshall - Secretary; Chris Mak; and Mitchell Brown for their involvement in the final development of the trust and execution of its duties.

# Industry Training, Recruitment and Regulation

Training and development require significant time, effort and financial commitment from the association.

Over this last year, we ran some hugely successful "Get it Right" seminars for members and other key stakeholders, delivering 8 sessions to more than 232 people. We are now working on more content to deliver even more seminars this year.

We continue to work on getting Fire101 delivered. Lack of performance from the polytechnic we were engaged

with saw this project delayed, but I am committed to delivering it in the near future.

We also see significant value in raising the profile of FPANZ, our members and the wider industry in the eyes of school leavers, careers advisors, recruitment companies and immigration specialists. To this end, the association has conducted several activities, including attending school careers days and the Careers And Transition Education (CATE) conference, which exposed us to some 800 careers advisors over three days. Raising our profile in this way is a key strategy in our work to address the need for skilled labour in the industry.

During the "Get it Right" seminars, we also canvased members for their views on the regulation and licensing of parts of our industry. I strongly support our need to attend to this, and we are working on both self-regulation and models including regulators. Other aspects such as qualifications and enough skilled employees must be in place before this can happen, and this takes time and significant background work before concrete results can be seen. Timeframes will be longer than many would like, myself included, but we are breaking completely new ground, and I am positive that our efforts will see some real tangible results in the coming years.

#### Standards Development

This year, we conducted workshops on both NZS4541 and NZS4512. We obtained places for three members on the NZS4541 committee, ensuring great representation in the redevelopment of this important standard. We are also in discussions with Standards New Zealand about the next redevelopment of NZS4512 and will update members on progress as it happens. These are important areas that will significantly affect a wide range of our members.

#### **Modernised Branding**

Those of you who have been members for many years will have seen how our brand has grown since 2014. Like any business, our brand is our livery that makes us stand out and represents not only the professionalism of our members but also our values. As such, investment in the FPANZ brand is critical, and we continue to do so, updating marketing material as it becomes outdated and polishing the logo and collateral material from time to time to ensure the brand is consistent, recognisable and professional. This also forms an important part of the promotion of our industry to careers advisors, members and clients.

#### FireNZ 2018

This year we held FireNZ in Mount Maunganui and maintained close to last year's numbers despite holding it outside a main centre. This event goes from strength to strength and continues to receive overwhelmingly positive feedback. This year, we attracted not only outstanding international speakers who complemented our solid local talent but also 45 tradeshow booths, 380 delegates and exhibitors each day, 189 external tradeshow visitors, 255 attendees at the gala dinner and 33 presentations. Plans for FireNZ 2019 in Auckland are well underway.

#### Passive Equipment Register

This year, we successfully launched the Passive Fire Equipment Register. This is a great step forward in the passive market, and its growth and uptake has been well above expectation. We continue to work on many key initiatives with further developments of the platform and delivery of the register and improving ease of use.

#### Halon Project

The completion of the Halon project saw us recover and safely dispose of 3818 kgs of Halon 1211 and 1301. The project itself is now complete, but we continue to maintain strategy around the collection and safe disposal of Halon although this is now more time consuming as we coordinate the shipments ourselves.

In closing, I am genuinely excited by how far we have come and the association's prospects for the future. We have a solid financial base with which to continue the current projects, start new ones and keep working to build our brand and what it delivers for our members. We have a small but supportive staff and a large volunteer pool passionate about our industry and improving it. Together, we produce some amazing results for our size, and the next year will prove even more successful.

Once more, my unreserved thanks go to the council, the board and the staff of FPANZ as well as to the members who contribute financially and donate their time and skills to our association and our industry.


#### **Special Interest Groups**

### Hand Operated Fire Fighting Equipment (HOFFE) SIG Report

Well as another year draws to a close we can look back on the year that was. Here are the main issues which arose this past year;

- a) The Fire Safety and Evacuation of Buildings Regulations submissions weren't as successful as we would have liked, that said, thankfully they do include the requirement to at least maintain the equipment to NZS4503 which is great to see.
- b) Foam issues, PFOS and PFOA, this issue was blown up in the media as a great big issue for fire-fighting companies that affected all foam products. Thankfully it had long been telegraphed to our industry. The result was that we were well prepared, and steps had already been taken (many years ago) by our member companies to develop environmentally acceptable alternative solutions.
- c) The fire extinguisher usage survey which FPA member companies widely participated in has been a useful tool in gaining recognition of the important role Hand Operated Fire Fighting Equipment (HOFFE) plays in protecting people and property. It is also very pleasing to see that Fire & Emergency New Zealand have not only taken this survey's results on board but used this information on their website, so the public can be informed of the valuable first response role often played by this equipment.
- d) The Hazardous Substances new Regulations came into effect requirements spelt out in plain terms including the requirement that Clearance Certificates and FERN numbers "must" be gained for fire extinguishers. This has implications for many companies both small and large if enforced.

- e) We continue be concerned that fire extinguishers to able be
  - purchased from outlets where those supplying them may not have the amount of expertise or information that would be available if those products were purchased from a reputable fire equipment company.
- f) It was pleasing to see that the Commerce Commission has prosecuted Aero Fire, they were bringing our industry into disrepute with their actions and consequences were long overdue.
- g) We have expressed concern that the idea of removing the requirement for HOFFE from NZS4541 was put forward, in simple terms it is hard to see how lessening the requirement for fire protection equipment would be beneficial.
- h) Overall it has been a steady year, unfortunately I have frequently had to be out of the country for family reasons which hasn't helped some matters progress as fast as we would like.

# Passive Fire Protection SIG Report

2017–2018 has been a very busy year for the Passive Special Interest Group (SIG).

We have achieved many goals – such as the launch of the Passive Equipment Register in May – and in just six months have six major manufacturers listed with a number of others preparing paperwork for inclusion.

We carried out launch seminars across the country with well over 600 attendees – with many councils adopting the register as a "go to" to easily find systems that meet the AS 1530.4-2005 / AS 4072.1 2005 test standards.

The register has also been referenced in the latest Auckland Council Passive Position Statement.

Another major step forward for the SIG this year was the invitation of our first ever International Passive Fire Protection subject matter expert speaker at FireNZ 2018 – Niall Rowan from the UK – CEO of the ASFP – he did a great job of delivering his industry experiences from across the globe to the conference.

Many compliments were paid to him and us for attending the show – Niall was very impressed how we punch above our weight with the organisation and attendance of New Zealand's premier fire exhibition – we hope this now sets the scene for more International

passive fire speakers to visit the expo in the coming years.

Passive fire protection

membership has grown significantly over the last twelve months – averaging around two new members per month – we have even attracted members from outside the traditional passive fire "space" in the form of main construction companies who want to be a part of the changes and initiatives we are working on to improve the passive fire protection industry within New Zealand.

The focus for the coming year is the creation of a formal qualification for passive fire protection installers – that process has already started with our collaboration with Competenz – we hope to be able to deliver that mid-way through next year along with our other major task of creating a code of practice for passive fire protection industry.

Its going to be another busy year – with lots of hard work ahead – the SIG group has a strong team spirit and am sure working together we will achieve our goals and improve the industry still further.


#### Certificate of Attendance in Fire Technology

The Certificate was approved in January 2018 by NZQA. We had initially planned a course in April and then then in August. Unfortunately, the first course did not take place due to the redundancy of the administrator at MIT and then the second course, the new person did not understand the process. There was also an issue with MOU/Contracts that was beyond the control of the group. A new training organisation has to be sourced to allow this programme to continue. This will be followed up in the November 6th meeting.

Scott and I attended a careers day in Wellington. It was for a cluster of 5 schools. Unfortunately, it was not successful as the target audience was too young and it was not a very structured event. There was no opportunity to do a presentation to the students as they were drip fed through the event over the 2 days. It was a learning curve which proved that we should be targeting the careers advisors instead. We are planning to speak at the CATE conference and have a stand there to promote both courses as there will be over 800 careers advisors in one place

to get the ball rolling. This will be run by Dr

Neel Pandey and his staff from MIT.

We are also working with the Polytechnics to get them to start advertising the course. Even though the fire modules are still being developed they can start the course because the first semester courses are all compulsory engineering papers. There is only one course in the second semester that is a new fire module. That will be our priority heading into next year. It is as you say a chicken and egg situation with the Polytechnics. Most of them made a loss last year so there is a reluctance to set up/advertise for a new diploma. They want numbers before they commit, however, they need to advertise to get an idea on numbers.

#### **Future Steps**

The next step is to work with E2E and their connections in the Tertiary Education Commission to get our pathway listed on the careers website. We have made the initial contact and now we are following that up.

Others steps are the BEngTech Fire and BSc Fire courses for Universities.

### Evacuation Consultant SIG Report

As I approach the end of my second year as the Evacuation SIG (Special Interest Group) chair, I have been reflecting on the vast changes we have seen in the last 12 months with new legislation being introduced, and I note the increased amount of diverse integration we have seen within the group over the last two years.

Last year I recall writing a piece talking about the short time frame the (Department of Internal Affairs) had given us to prepare our submissions around the changing FSEB (Fire Safety and Evacuation of Building) Regulations. This year has seen no change with short timeframes, with the Fire and Emergency New Zealand (Fire Safety, Evacuation Procedures, and Evacuation Schemes) Regulations 2018 being gazetted on the 28th May, prior to coming into play on the 1st July 2018.

As many of you will have experienced first-hand these had a significant impact on how schemes are prepared, the procedures within them, and the increased processing times that we all noted whilst the FIU (Fire Information Unit) developed process to apply the legislation whilst increasing their responsibilities and workload at the same time. Fortunately we

have been able to work alongside FENZ to answer queries, and there have been workshops which have allowed our members to fast-track their queries.



Our group continues to grow, and we invite persons from all disciplines and roles to come along and share their learnings of the evacuation process. There has been further increased interest in the certified evacuation consultant qualification, and we are also looking forward to seeing the New Zealand Diploma in Engineering opening up the world of all things fire in the future.

There is little doubt that with a focus on competency, training and liability that it is vital we continue to share our learnings within the industry in order to provide a professional service to the public. I would like to thank you for your contributions to the group this year, and look forward to working with you in the future.

### Inspectorate SIG Report

The Inspectorate SIG has had another challenging but successful year. Last year's redistribution of Inspectorates, and this year's continued growth within the fire protection sector has seen expansion on all fronts. Our series of Get It Right seminars focusing on lifting the game of the industry seems to be paying dividends. We are already seeing a marked improvement in workmanship in a number of areas, and much better awareness of what constitutes "a workmanship like manner".

As a group we have come up with several Formal Interpretations which, once they have gone through due process and are distributed, should provide greater clarity on issues that have come to the fore during the year. This, along with providing guidance for the current

review of NZ4541 and the upcoming review of NZS4512, has been our major focus of the group this year.

Going into 2019 we will be looking to assign a



new SIG Chair and hope to follow up on the ground work that has been put in to date providing the industry with clear and consistent guidelines around what the industry needs to be aiming for when installing and maintaining fire and life safety systems that are not only compliant but are designed to work well into the future.

# FINANCE REPORT

For the year ended 30 June 2018



This Finance Report is presented in lieu of a Treasurers Report in the 2017–2018 Annual Report. Our Treasurer, Kerry Ludlam, resigned as of the 25 March 2018 as a result of an increase in his personal workload and commitments. Kerry was instrumental in ensuring that the Finance and Administration function was successfully transitioned back into the Association and establishing rigorous processes and methods of reporting, and we are grateful for his contribution.

The Accounting functions previously undertaken by the Treasurer are now completed 'in house' and monthly reporting to the Board remains unchanged. We continue to develop and improve accounting and secretarial processes to provide accurate and meaningful reporting and to identify areas of concern in a timely manner.

The external audit of our Financial Statements for the year ended 30 June 2018 was completed by Crowe Horwath. Their approach was thorough, and we are pleased to report that once again we have received a positive Auditor's Report.

FPANZ produced another strong Surplus for the year of \$162,623, an 80% improvement on the surplus of \$90,208 for the year ended 30 June 2017. Revenue from successful Seminars held during the year and a marked increase in Fire Contractor Certifications were the largest contributors to this result.

The financial position of the Association continues to strengthen with the Working Capital (ie Current Assets less Current Liabilities) increasing substantially from \$181,137 in 2017 to \$329,738 this year. Accumulated funds have increased also from \$175,120 to \$337,743. This strong financial position will enable the Association to continue to plan and execute projects and programs within the industry and ensures the continued strength and viability of the organisation.

# **ACCOUNTING POLICIES**

For the year ended 30 June 2018 in New Zealand Dollars

#### 1. Basis of Preparation

FIRE PROTECTION ASSOCIATION (NEW ZEALAND) INCORPORATED has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

#### **Basis of Measurement**

The financial statements are prepared on the historical cost basis except certain items for which specific accounting policies are identified.

#### **Presentation Currency**

The financial statements are presented in New Zealand dollars (\$).

#### 2. Significant Accounting Policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

#### (a) Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the entity and revenue can be reliably measured. Revenue is measured at the fair value of consideration received, excluding GST, rebates, and any trade discounts.

Revenue from services rendered is recognised in profit or loss in proportion to the delivery of the service at the reporting date. Under this method, revenue is recognised in the accounting periods in which the services are provided.

Interest income is recognised on an accrual basis.

#### (b) Goods and Services Tax (GST)

All amounts are recorded exclusive of GST, except for Accounts Receivable and Accounts Payable which are stated inclusive of GST.

#### (c) Income Tax

FIRE PROTECTION ASSOCIATION (NEW ZEALAND) INCORPORATED is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

#### (d) Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

#### (e) Receivables

Receivables are stated at expected realisable value. Bad debts are written off during the period in which they are identified.

#### (f) Liabilities

Liabilities are stated at the estimated amounts payable and include all obligations that can be reliably estimated. Current liabilities include the amount payable within twelve months of these financial statements.

#### 3. Changes in Accounting Policies

There have been no changes in accounting policies during the financial year (2017 - nil).

The fund accounts represented in the Provisions are monies held on behalf of the Fire industry for the development of the fire industry. These are detailed below:

(a) Sprinkler Standard 4541 Fund:
This is collected via a levy provided on new sprinkler systems applications to the SSC. This money is for the rewrite of the sprinkler standard and future amendments.

Building research provided money for a research paper to be written on passive fire protection. Initial funding is for stage one, additional stages will follow, and any residual money from stage one will be used for these future stages.

This represents funds put aside to fund scholarships for students.

#### 14. Capital or Lease Commitments

There were no capital commitments as at 30 June 2018. (2017; NIL). As at 30 June 2018 there is a lease commitment in place for the premises in 34 Triton Drive Albany, Auckland. The agreement started on 26 January 2018 and is for a 3 year term at \$17,500 per year. There are rights of renewal in place with a final expiration date in 2027.

If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the performance report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Incorporated Society to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the performance report, including the disclosures, and whether the performance report represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the Board of Directors regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
