

Passive Fire Protection SIG Update

LEAD TIME MATERIALS

I'm sure I'm not the only one that is experiencing weekly headaches with freight delays and lead time materials. What was once available down the road, can now be a lengthy delay to get a hold of it. The feedback I am getting from suppliers and contractors is that the worst is not over, and we should be planning to deal with this for the remainder of this year.

For the benefit of suppliers it is always great if contractors/clients are able to advise of product requirements early on, and limit last-minute requirements. This allows suppliers time to procure and deal with international freight delays. It is always appreciated by them if their pipeline is accurate.

Similarly for contractors, it is hugely appreciated if suppliers are able to hold more stock in New Zealand and distributed throughout the country. Ordering from overseas once an order is placed by a contractor will simply not support the industry over a long period.

Specification changes to adapt to material delays are likely to be more commonm and contractors/specifiers should be considering confirming availability of materials before specifying a particular product. Otherwise hang in there, it will get better.

Evacuation Consultants SIG Update

Recently there has been a lot of conversation about when an evacuation procedure for a building should be considered. Whilst the regulations are clear, and prescribed when a scheme may be applied for, it is common to complete the procedure document with the scheme application.

If the evacuation procedure is developed at design stage, this allows the building owner, end users and fire engineers to ensure the building design and alarm configuration meets the needs of the intended end users. For example, I recently visited a building with a dementia care area that had large white strobes that activated with the alarm, if consulted, the end user may have chosen a different solution.

It is important to continue to work with building owners to ensure they understand what options they have available to them.

The Fire Information Unit (FENZ) has asked to remind persons reporting on fire drills or training as part of scheme maintenance that they can update these through the portal where they have made an online application. When submitting drill reports by email please can they be submitted as individual attachments as they are attached to the individual address points.

Changes to Regulations on Trial Evacuations and Training Programmes

(Fire and Emergency New Zealand (COVID-19—Fire Safety, Evacuation Procedures, and Evacuation Schemes) Amendment Regulations (No 2) 2020)

The requirement for building owners to conduct trial evacuations or evacuation training programmes will be reinstated from next Monday, 1 February 2021, provided there are no physical distancing requirements in place for the area in which the building is located. Specific exclusions have been included in the changes to accommodate those buildings which are in use as Managed Isolation and Quarantine Facilities.

Building owners are not expected to resume trial evacuations or evacuation training programmes immediately the changes come into force. To work out when the next trial evacuation or training programme notification is due, you calculate a 6-month period that excludes the time from 25 March 2020 to 31 January 2021.

This means, for example, if a building was due to have a trial evacuation conducted by 10 April, 17 days after the suspension began, there will be a requirement to conduct a trial 17 days after the changes take effect which will mean 17 February 2021. This is provided there are no physical distancing requirements in force.

World's First International Sprinkler Monument

A two-metre-high bronze sprinkler will be the world's first international sprinkler monument.

At the centre of a roundabout on what will be called *'Plaza del Sprinkler'* it will greet visitors to Alcobendas, Spain's third largest business city. Alcobendas is just north of Madrid and is the Spanish home to many major multinational companies.

Anselmo Iglesias Poli, a famous sculptor whose monuments are found across Spain, will create the sprinkler. Emilio Rodriguez, owner of Pacisa, a leading sprinkler installer, has secured all the approvals. While he will guarantee the project, this monument will help to publicise the sprinkler concept and as such should ideally be a broad sprinkler initiative funded by as many parties as possible, all of whom will be recognised on the sculpture.


