- Attending New Zealand wide careers events for industry promotion. We will have stands at careers events, aiming first for main centres such as Auckland, Wellington, and Christchurch. These careers events will see FPANZ and industry representatives meeting with careers advisors, parents, school leavers, and recruitment representatives to actively promote our industry and the careers on offer.
- Delivering a dedicated fire industry careers website. This website will be part of our full redevelopment of the current FPANZ website. It will have dedicated information on careers in our industry and relevant qualifications for our industry as well as links to career opportunities and training providers.

Competenz and Qualifications

We have been working even more closely with our industry training provider, Competenz, in the continued promotion of the fees free scheme and getting industry participants onboarded and underway with their qualifications. A full review of existing qualifications by industry subject matter experts will take place shortly. This will be a chance for the industry to review current qualification modules and make minor changes where

We are also now actively working with the dedicated job seekers area within Competenz. This is a new service that links employers and job seekers via a dedicated website and staff. This service is free for our members and provides a recruitment specialist to assist with the process for both employers and prequalified and motivated jobseekers. Membership Process

Having completed the review of how we onboard new members, we will start accepting new members this month. We have some new requirements, mostly around a new provisional membership category. All companies, organisations, and individuals wishing to join FPANZ will first be a 'provisional member' for a minimum of 12 months. Once this provisional period is completed, members can apply to be accepted into the appropriate current membership tier based on staff numbers. We also now have further requirements for references and endorsements from clients and existing FPANZ members. Most of these changes are to update our internal processes and welcome new members in and have them engage with our existing membership in forums such as the special interest group (SIG) meetings, the 'Get it Right' seminars, and the FireNZ conference. These changes do not affect existing members.

FireNZ

Late last year, because of the global pandemic, we postponed the FireNZ conference to 27–29 October 2021. I can confirm that all planning is back on track, with the Energy Events Centre in Rotorua booked. Updated details for exhibitors, speakers, and delegates will again be on our website www.firenz.org. We are already getting great feedback,

and exhibitors and members are looking to reconnect again, having missed FireNZ for a year. We will also have an updated refund and cancelation policy to give both our exhibitors and delegates some certainty about what happens should the event be cancelled at short notice. So, lock these dates in your calendar now, as I'm sure we all look forward to the return of FireNZ and the important networking opportunities we have missed during this pandemic.

'Get it Right' Seminars

In next month's update, we will be launching this year's first 'Get it Right' seminars, so make sure you check out the March newsletter for updates on dates and topics. The first will be a gas flood seminar as industry has been calling for this one. We have lined up some great speakers and content for these full-day sessions that will take place in Auckland, Wellington, and Christchurch.

Changes to Regulations on Trial Evacuations and Training Programmes

(Fire and Emergency New Zealand (COVID-19—Fire Safety, Evacuation Procedures, and Evacuation Schemes) Amendment Regulations (No 2) 2020)

The requirement for building owners to conduct trial evacuations or evacuation training programmes will be reinstated from next Monday, 1 February 2021, provided there are no physical distancing requirements in place for the area in which the building is located. Specific exclusions have been included in the changes to accommodate those buildings which are in use as Managed Isolation and Quarantine Facilities.

Building owners are not expected to resume trial evacuations or evacuation training programmes immediately the changes come into force. To work out when the next trial evacuation or training programme notification is due, you calculate a 6-month period that excludes the time from 25 March 2020 to 31 January 2021.

This means, for example, if a building was due to have a trial evacuation conducted by 10 April, 17 days after the suspension began, there will be a requirement to conduct a trial 17 days after the changes take effect which will mean 17 February 2021. This is provided there are no physical distancing requirements in force.

Passive Fire Protection SIG Update

Competency & Trust

Sadly I am hearing more or more frictions within the industry between Passive Fire Contractors and consultants and Council inspectors.


These frictions often seem to be coming from like minded operators but the boiling point appears to be that Specialist Contractors aren't feeling their expertise is valued or they are constantly being challenged with no respect first offered. Almost a guilty until proven innocent attitude.

It is important that Passive Fire Contractors, Fire Engineers, Third Party inspectors are on the same page as often these will be the only parties involved in a project that care about passive fire or have the level of knowledge required on site regarding passive fire.

There seems to be a growing mentality from inspectors that all passive fire installs are wrong. Inspectors are then hunting down any microscopic detail they can fail or grandstand upon. Likewise at the front end of a project, specifications are being prepared which the Contractor must follow. However, specifications are seldom perfect & there needs to be a mechanism for change or adaption. At present the complaints I'm hearing are that Contractors are the meat in the sandwich on such issues & taking all of the flack. None of which provides a best for project or best for client outcome.

Due diligence, inspection and challenging installations is an important part of Passive Fire protection. However, the starting point should be to first check the competency and credibility of the contractor executing the work. Often these Contractors have more experience with Passive Fire than anyone else involved in the job & have been doing it at the coal face for several years, whereas inspectors may have only recently been given an introduction.

There has been a surge of contractors taking up Passive Fire protection in recent years



If thorough due diligence is done during procurement then there is every chance of a strong relationship that provides best for project and client outcomes.

SFPE is soon to release a CM guide which includes Passive Fire protection. I encourage everyone to digest this and take into practice.

Also I encourage the following questions be asked by Inspectors, Engineers and Councils before making a broad assumption of all contractors:

- 1. Previous Track record?
 - a. Similar size/ scope projects
- 2. Who is the Site Supervisor overseeing & what is their experience?
- 3. Training (NZQA Level 3)
- 4. Accreditation with Manufacturers
- 5. QA Processes
- 6. Insurances (PI & PL)
- 7. Interview meet with them & gauge for yourself their credibility if you've not dealt with them previously.

What is next for your business?


