## FPA Australia backs Senate Inquiry into Product Compliance

FPA Australia is pleased by the announcement this week that a Senate inquiry will be held into the safety and legality of imported building materials in Australia.

The inquiry, co-sponsored by Senators John Madigan of Victoria and Jacqui Lambie of Tasmania and approved by the Senate today, was set up amid rising safety concerns about substandard imported building materials and the lax rules that let them into the country.

High profile incidents have included the apartment fire in Melbourne's Docklands last year that quickly spread via the non-compliant, combustible exterior cladding as well as the recall of non-compliant "infinity" electrical cable, believed to be installed in around 40,000 homes, which can degrade and become a fire hazard in as little as two years after installation.

Senator Xenophon said a key aspect of the inquiry will be the inspection and regulation framework that was clearly failing.

"This inquiry is a breakthrough in addressing what many in the building industry and their clients have known for some time: Australia has become a dumping ground for some of the world's dodgiest and most dangerous building products,"

FPA Australia CEO Scott Williams said the inquiry was sorely needed.

"It is past time that we openly and transparently addressed this pressing and serious issue of building product non-compliance in this country," he said.

"We are a developed nation and are entitled to expect safety in buildings that we occupy. The confidence of the community, that buildings are safe, must be restored."

"As an Association we are committed to presenting solutions to this issue and that is why we have already proposed a comprehensive risk-based framework for product compliance and we will be submitting this to the inquiry."

The Associations discussion paper has already been submitted to all state and territory building ministers including the federal minister for industry.

## FPANZ Passive Group Update

My apologies for not writing an article in June, I was hoping to write a positive article but positive and passive are not common these days, however I am the eternal optimist and know by the time I retire the passive arena will be much improved from today's standard. As I always state in my training, if you don't aim for perfection then you won't even get close.

In the past few weeks we have had more tragic deaths as a result of fires with investigations pending I won't try and comment, however smoke is always the major contributing factor to people dying in a fire. Good Passive Fire protection along with good early warning and active systems will of course reduce the risk of injury and death.

It has been an interesting few months undertaking inspections of old and new buildings and listening to news items and reading articles on fire. Here are some stories with food for thought!

### Fire Engineers Liability Reduced by Independent Inspection

As part of Fire Group Consulting Ltd, we were engaged to undertake a review of Passive Installation work undertaken in the past few months by a company who solely undertake Passive Installation work namely fire stopping and are known to many within the industry and have been around for 20 years. The company is not an FPA member but works in many parts of the country.

The Fire Engineering Company who engaged us to undertake the inspection was in good faith about to sign off the PS4 as a result of receiving a PS3 from the passive installation company. They like many fire engineers don't have knowledge of the fire stopping systems and were hoping for good work from what they thought was a passive specialist. To them and many of the readers it 'looked ok'. The work was questioned (a long story!) and we were called in as an independent to review the installation.

As part of our review we undertook intrusive testing of the penetrations to determine what systems had been used, depth of sealant and annular gap. As previously mentioned fire stopping may look good to the untrained and even the trained eye but unless you see it being installed or undertake intrusive testing then you cannot confirm it has been installed correctly.

The results of our inspection were not surprising to us, but what is shocking is that the labels stated that the systems installed complied with relative AS Standards which NZBC cites.

As a result of our inspection, eventually the builder was able to engage a professional proven passive installation company to complete the work in the coming weeks.

While the Government is hell bent on self-certification, from my observations on building sites and in particular fire stopping we are 20 years away from feeling confident about passive being undertaken seriously.

Here are a few examples of the issues we see in the marketplace that are undertaken by so called specialists in passive fire protection?

#### Conclusion

Fire Engineers / Fire Designers - If you are a Fire Engineer signing off Passive and in particular fire stopping and you don't know what you are looking at THINK TWICE! One day you may be accountable as to why you signed the PS4 even if there was no fire. This is not something of the future it is happening now.

Installation Companies – Don't undertake fire stopping unless you know what you are adequately trained.

#### Positive Note

I undertook some training recently in New Plymouth which was organised by Peter Scantlebury – Manager Building. Peter managed to convince 64 people including Architects, Engineers, Electricians, Plumbers, Builders and others to learn about passive including hands on demonstration. I congratulate Peter in organising this event to help people in his area understand the requirements of the BA04 and how to undertake fire stopping correctly.

We hope to soon have training available for FPA members.

Issues:

1. Sealant used is HILTI CP611A which requires 25mm depth of sealant WITHIN the plasterboard and around the service penetration. As this was only 13mm plasterboard a patch is required as per GIB manual of HILTI Test.
2. Minimum of 10mm annular gap is required around the service penetration.
3. Cannot mix sealants. HILTI CP611A was essentially smeared over existing attempt at fire stopping.



Issues:

- Three different manufacturers products used on these cables, two sealants and a wrap!
- Essentially this is a made up system which is what this particular contractor does often.

## Evacuation Consultants Group Update

I trust my update finds all of you in good health as I ponder that August is already upon us and wonder where this year has gone.

Over the past three months many hours have been invested to write the second edition of Code of Practice (draft) for the Evacuation Consultant group.

Attention has been given to adopt a sustainable long-term view in setting the framework for a professional standard, in the absence of a recognised New Zealand standard. Currently the document is under further review.

The goal and indented review to align the evacuation consultant certification process in accordance is about to begin.

The current knowledge and skill criterion for certification is perceived to be inadequate. The review and subsequent amendments aim to remedy this by including into the future certification criteria extended requirements of relevant technical and legislation knowledge, in particular for Evacuation Consultants wanting to obtain certification Level 3 and 4.

It is encouraging to read the results of the resent released MBIE review, which highlight amongst other issues the need to reconsider the issue of safe evacuation for persons with disabilities, from commercial buildings required under the Building Act and Building Code.

The review also points out amendments to the Acceptable Solutions C/AS3, grouped support housing under the risk group SI. This has affected service providers and may affect the existing evacuation procedure and require change to provision for active and passive fire protection systems for service providers and their related stakeholder(s) to meet compliance.

This MBIE review and subsequent commitment to find a better workable solution is promising.

As the chair of the evacuation consultant group it is my hope that as workable solutions will be considered, opportunities for Evacuation Consultants to communicate with MBIE and share valuable industry knowledge and expertise will continue.

No man is an island, we can accomplish our SIG group goals by sharing and hearing each other's concerns and ideas and getting involved.

Lets make working to create better communication and greater collaboration across our wider industry sector a reality, together.



## HOFFE Survey Project



### Survey responses




### Expected number by 31/08/15









# Calling all Halon Fire Extinguisher Owners



FPANZ is promoting awareness around Halon fire extinguishers and wants to recover these from the commercial sector and from private owners.

Halon has fallen out of favour due to its environmental impact and long atmospheric life time. It is considered to be a potent greenhouse gas and contributes to ozone depletion. However, safety is the main issue as servicing of Halon extinguishers has not been available since 1998 when the production of Halon was banned under the Montreal Protocol.

Over the previous ten years, more than 60 tonne of Halon has been recovered by FPANZ members and this was sent for safe destruction. It is estimated that a further five to ten tonne is still in use. This needs to be recovered now as any unit still in use will be well over ten years old and will not have been serviced.

“Fire extinguishers, just like smoke detectors, need to be checked by a certified agent annually” says Blind

“We do have fears that Halon extinguishers, due to this lack of servicing, may fail to operate correctly in the event of a fire. We are prompting all members of the public to check their boats, cars, workshops, caravans and planes to see if they still have a yellow Halon extinguisher and to exchange this for a unit coloured red”.

“There will be a cost to change, however both the public and the environment will benefit as we can be sure new systems will operate correctly in event of a fire and the impact on the ozone layer will also be reduced” says Blind.

There are now many suitable and cleaner alternatives available and FPANZ members located nationwide will accept Halon units and provide information on the safer alternatives available. Halon extinguishers are easy to identify as they are bright yellow. Replacement units will be coloured red.

“We look forward to gathering as many of the remaining Halon systems and hand held fire extinguishers here in New Zealand and to have the contents safely destroyed” says Blind.

“We will also have greater confidence that owners will be protected in the event of a fire and this will ultimately protect lives”.

Our message is: **“Be Safe Yellow is Out – Red is In!”**

While there, talk to these experts about your needs and how best to protect against fire, including alternatives such as a red fire extinguisher\*, a fire blanket, a smoke alarm, and other effective choices. Often a combination is the best approach.

**So act now and hand in your old yellow extinguisher.** It's a service for the general public and small businesses. A small recovery charge will be set at \$10 per kilogram (up to a maximum extinguisher weight of 2.1 kg in size). A Halon extinguisher larger than 2.1kg is considered a commercial size and will be disposed of at a quoted rate.

*\*There is more than one type of red fire extinguisher on the market. Ask which one best suits your needs.*

## Update on Using FPANZ Logos



# Heads Up



### BACKGROUND

Security alarm monitoring companies frequently offer fire alarm monitoring as an extra service to their clients. These fire alarm systems can be rudimentary, consisting of non-addressable smoke or heat detectors, often on a single loop.

Such systems, even if non-compliant with the relevant fire alarm standards, can provide significant benefit outside occupied hours. However, fires at several buildings that use this form of monitoring have led to significant delays in calling the fire service. Due to the rapid growth of fires once they become established early intervention and suppression is critical to avoid large losses and fire damage.

### INCIDENT DETAILS

The following outlines a few fires in 2014 and 2015 where there were protracted delays in notifying the fire service. This list is not exhaustive.

Incident Details	Alarm and Notification Sequence	Outcome
12/01/2014 Fire started on the outside of a school toilet block, spreading to an adjacent classroom block. The monitoring company notified the key holder who elected to attend first before calling the fire service.	Monitoring Company Notification 05.45 hrs 111 Call (passer-by) 05.51 hrs Delay 6 minutes	Total loss of toilet block, significant damage to a three classroom block.
03/02/2014 Fire in a warehouse. All four detection zones activated in sequence. The monitoring company informed the key holder, who called the fire service passing on second-hand information, excluding multiple activations.	Monitoring Company Notification 22.40 hrs 111 Call (key holder) 22.46 hrs Delay 6 min	Total building loss.
05/03/2015 A small fire broke out in a warehouse. The monitoring company received notification of smoke detection and PIR activation. They informed the key holder who requested a security guard respond.	Monitoring Company Notification 04.12 hrs 111 Call (security guard) 04.35 hrs Delay 23 min	Limited fire damage in the area of origin. Extensive smoke damage to all areas of the building and stock in the warehouse.
27/04/2015 Fire in a school classroom block. Monitoring company dispatched a security guard who arrived on scene after the fire service arrived.	Monitoring Company Notification 01.14 hrs 111 Call (passer-by) 01.18 hrs Delay 4 min	Extensive damage to a classroom.

## FURTHER INFORMATION

The incidents listed above indicate that the potential benefits of monitored fire alarm systems can be undermined if the information is not used to notify the fire service in a timely manner. For two of these incidents, the fire service was notified by members of the public, nullifying the possible benefits of early detection of a developing fire by the fire alarm system.

In the other two examples, investigation by the key holders eventually resulted in a fire service callout, albeit delayed. Critical information available to the monitoring centre was not passed on, which affected the initial fire service response and the delay enabled the fire to cause extensive damage.

In an effort to avoid false alarms, building owners sometimes elect to have their premises inspected prior to calling the fire service. Rudimentary fire detection systems can also make it difficult to identify remotely whether one or several devices have activated.

However, there are a few indications that can be used to help alarm monitoring companies and building owners make informed decisions remotely.

For more advanced systems (addressable or including several detection zones), multiple activations tend to indicate a real fire rather than a false alarm. This is particularly true if the activations are sequential, progressing through the building.

Some security devices, such as Passive Infrared Sensors (PIR) can also react to fires. Therefore, the activation of smoke detection and security sensors in short succession may indicate a developing fire. This information should be passed to the fire service.

## LESSONS LEARNED/RECOMMENDATIONS

The lessons learned are applicable to building owners, security alarm providers and monitoring companies;

Building owners should consider the intended objective in installing a monitored fire alarm system and discuss with their alarm provider an appropriate fire service notification process to minimize delays and protect their buildings.

Fire detection systems provided as an “add-on” to security systems should, where possible, be designed to allow the fire alarm panel to identify individual detectors. This informs the monitoring company of multiple detector activations suggesting a growing fire.

Alarm monitoring company staff should be trained and empowered to make critical decisions based on the information available, including directly notifying the fire service if there is strong evidence to suggest a fire is developing.

All available information should be passed on to the fire service to ensure the most appropriate response.

Where property or business protection is critical, a detection and alarm system designed to NZS 4512 and directly connected to the fire service may be a more appropriate solution.

Alan talked about his life as a burn survivor and tools and strategies to deal with disfigurement.

Alan states "The whole problem with burns is how the public is going to perceive you. You could walk along and people will point you out like you don't see them. What you first learn is that you have to learn to deal with that. We stop them and talk with them and they see that you're a normal person inside and then you explain you were in a fire and they are very interested." Delwyn agrees and adds "I think it's just a natural curiosity. People tend to look at something that looks different from the norm. People don't mean any harm, they are just curious and once their curiosity is satisfied they don't see the burns any more.

Alan reminds us that there are three great healers:

**TIME** ..... **PURPOSE** ..... **LOVE**

- Give yourself some time
- Find a purpose
- Find somebody to love

***"The old person will never be there again. You'll never look the same, you'll never feel the same, you'll never be the same. You have to grieve that loss, give up that person, stop looking for that person or trying to get bak to that person, because you never can. Instead you are reborn, you must look to the future and build a new life."***

## HOT NOODLE DANGER



Two minute noodles can be a convenient snack for hungry kids when time is running low. But, they can be dangerous as well.

The most common burn injuries occur to the legs, chest, stomach, arms and genitals. Not just mild injuries either - injuries involving hot instant noodles can be so severe some kids require skin grafts.

Boiling water is poured over the noodles and then left to sit for a couple of minutes to soften up, or pop them in the microwave to do the same thing. According to the packaging, these noodles are now ready to eat..... but they're not!

Here's the thing - investigations show that the noodles were still at a temperature of 80 degrees celsius when the packaging instructions said they were ready to eat.

Dominic Hannon and Ange Warnock know all about the dangers of this. Their son was injured while making two minute noodles for himself. Brayden now faces a lifetime of surgeries and skin grafts to his face, neck and torso and has lost fingers to hot noodles. Ange also adds that the stove element at the time was super hot, as it needed fixing so possibly contributed to his injury. Brayden now attends Burn Support Groups children's camp annually and his injuries do not hold him back on anything!

Kidsafe NSW suggests that one of the other problems associated with noodles is the fact

that they stick. If a hot noodle attaches itself to the skin it will stick, making it hard to remove immediately. This allows the noodle to burn into the skin longer and deeper. Kidsafe have come up with some safe practices to make noodle time a little safer:

- Heat noodles under adult supervision
- Ensure noodles are not overheated and never boiled
- When microwaving, be careful of the uneven heating of food
- Heated noodles should be removed carefully from the microwave or stop by an adult
- Noodles should be allowed to cool before given to a child or eaten

### BURNS FIRST AID

- **Remove** any clothing and jewellery from the area which isn't stuck to the skin
- **Cool** under running water for AT LEAST 20 minutes
- **Cover** area with lint free cloth or cling wrap (do not cover the face)
- **Seek** medical advice if the burn area is larger than a \$2 coin or on the face, hands, feet or groin area



## Graham’s View

The Canterbury Rebuild, according to media and business commentators, is at its peak – basically it’s as big as it’s going to get. The workforce has nearly doubled in the almost-five years since the first quake - with an estimated 31,000 workers. Every week \$100 million is being spent in the commercial and residential rebuild – expenditure that is expected to continue at this level for several years.



All of this is great news in terms of economic and social progress but what interests me is if the rebuild has peaked (and there’s still some debate about that!) - then it has peaked with a very good safety record still intact.

Many of you will recall the predictions made at the beginning of this process - an estimated 1-2 deaths in the construction sector for every year of the rebuild and a potential \$80 million claims liability for ACC. Whilst it is far from an unblemished safety record, what we have achieved here in Canterbury is worth celebrating.

H & S has become a real focus in the region. As well as the Charter and the Rebuild Safety Forum, we’re seeing other industry groups putting aside their commercial competitiveness to explore common ground where they can make safety gains that go beyond the boundaries of their businesses to effect positive change across the industry.

This is backed up by findings from the WorkSafe-commissioned survey into H & S attitudes and behaviours in NZ workplaces. The just-released data shows employers in the construction sector in Canterbury had a greater focus on H & S than employers in other areas.

I know Auckland is looking at what we’ve done in Canterbury with a view to replicating it up there - remembering their construction boom will likely outlast ours. There’s talk that the Charter concept could benefit other industries – manufacturing and forestry for example.

So whilst the rebuild may be at its peak, there’s still an awful lot of rebuilding to go. It’s great to be able to look back and reflect on what a great job we’ve done to get this far, but to quote a very famous Carpenter, when it comes to creating and influencing a better H & S culture in this industry, we’ve only just begun.

## The Occupational Health Van Returns

ACC provided hot soup and tool box talks and along with WorkSafe staff, had lots of discussion with workers on site – with many reporting poor diet and long hours contributing to increased levels of fatigue.

## Cornerstone Building – small business, big on H&S

Good H & S is “all about attitude” according to Cornerstone Building's Managing Director, Jason Harvey. This relatively young SME has gone from zero to hero in terms of H & S capability since it opened in 2012.

“We started out with the attitude that H & S was important and that we were going to resource it properly. We signed up to the Charter at the first opportunity, we dedicated staff and resources to managing and implementing H & S systems and we've grown a culture that ensures H & S is embedded in our business.”

The company is tertiary-accredited through ACC's WSMP, and has passed and surpassed a number of other stringent government and commercial procurement processes. But they're not just great on paper, they're great in practice too.

“We do it [H & S], we can prove it and we're always looking for ways we can improve it. There are always safer ways or better ways to do things and we're constantly exploring those options. I know lots of small businesses worry about H & S and the perceived cost to business but I'm a firm believer that if you do H & S right, you'll save money.”

Cornerstone Building's H & S Manager, Chris Brosnan, is all about 'keeping it real' for the team.

“Our tool box talks are based on actual situations and hazards our guys have observed. They're real to our business and they're relevant to the guys on site. During these sessions, we ask lots of questions, which promotes

really good discussion and engagement. If people can understand the benefits to them, then they tend to take notice and that carries through to how they act and operate on site.

Cornerstone has also been working with CERA to access red-zoned houses to train staff on emergency procedures and undertake task analysis for working in confined spaces.

“Accessing the red zone houses was a great opportunity to bring our emergency plans to life. We were able to see how our people react instinctively; we could immediately see where we could make improvements and change scenarios – like if there was no power. Exercises like these where we are effectively simulating close calls means we're more likely to avoid close calls in reality.”

Cornerstone Builders were among the first tranche of businesses to sign up to the Charter and they really value their involvement.

“We've found the Charter absolutely brilliant. Great resources, great speakers at the events - we've really benefitted from our involvement. I love that it's industry-led, with the big guys putting their weight behind it. And it's also really good to see government supporting it, especially Worksafe and ACC working together to help improve H & S.”





## Safe Rebuild Update

Safe Rebuild is delighted to be able to confirm that we have ongoing funding for the 2015/16 year. Our half day champion course will continue to be offered free to small to medium sized enterprises involved in rebuilding our city and homes. Last year over 1000 participants attended the almost 40 courses that ran through-out the year. Field Officers were also able to offer ongoing mentoring and support to the companies that requested it to assist them in improving their systems and workplace culture around health and safety.

Two new initiatives occurred this year.

1. One involved Fletcher Living and working with a group of sub-contractors to ensure they meet the standards required by Fletcher Living around health and safety. These companies are now assured of more ongoing work as a result of being engaged in our programme. Field officers provided one on one support to ensure the SSSP process is successful in improving health and safety on sites.
2. 257 Filipino workers attended a health and safety event one Sunday. This was a joint initiative with the Christchurch Migrants Centre, Philippine Culture and Sports and Safe Rebuild.

## THE WORKER'S VOICE

We hit our target of 500 confidential surveys by Week 9 with a total of 535 surveys completed. The raw data is now with independent research company Research First who will analyse the information.

We look forward to sharing that information and more that we will have gathered between now and September with you at the next quarterly Safety Charter event.

We're at the halfway point now – 12 weeks into this project and we have spoken with over 1300 workers at all levels of the construction industry and across all areas of the rebuild - direct employees, contractors, sub-contractors, and labour hire staff.

We're now into Phase 2 of the project and over the next 12 weeks we'll be seeking qualitative data, looking for people's thinking behind their views and responses on H&S.

One way to do this is with focus groups where we look at the information gathered from the 535 surveys and ask some deeper questions about people's responses - again, looking for the thinking behind their response.

We would like to move onto visiting smaller Charter signatories and non-signatories to raise awareness of the Charter and so far the response from the smaller signatories and non-signatories has been very positive.

Thank you all for your assistance and support with the Charter Project on the ground. I look forward to updating you further in the next newsletter.

We'll be testing the site soon and hope to have it live for your comments and feedback in August.




## ACC Data Update

New construction-related claims in Canterbury showed a slight increase for June (546 compared with 539 in May 2015). Those claims that become entitlement claims – that is where a person requires more than 5 days off work – decreased slightly from those recorded in May (80.3 for May; 78.7 for June). The average cost of claims in the first 12 months post-injury also decreased slightly from \$2066 in May to \$1960 in June.

Plasterers recorded the largest increase in claims by occupation – up almost 24% over the past 12 months.

The residential building sector continues to dominate claims, recording just over 160 claims in May.
