Some minor Q&A will be possible at the end via online questions. We still strongly recommend you read this document to assess the changes and whether you wish to submit comments on them. We will also be carrying out more in-depth updates and training seminars in the new year once the final document has been completed and approved for release.

FireNZ

FireNZ is the most important industry event in New Zealand. In consultation with our partners, the Society of Fire Protection Engineers and the Institute of Fire Engineers, and input from long-term exhibitors, we have decided to push the conference out to October 2021. Many factors led to this decision, including the ongoing COVID situation and risk to the event. However, we are confident that, as it will be a long time between drinks since our last conference in September 2019, FireNZ 2021 will be a real banger of an event, and we are already working on our plans. Anyone who submitted papers for speaking at the next conference will receive an update from the committee to formalize speaking slots early in 2021. Exhibitors will also receive updated communications regarding the exhibition, and those who have already booked a stand will have first option to retain their stand allocation.

Membership Update

We are currently in the process of reviewing and rebuilding the membership process, criteria, requirements, and membership tier levels. We feel this review is important to ensure we manage our growth and that we are doing the best for our existing membership base.

The association has seen considerable growth in the past few years, and our membership offering has not kept up with the changes in our membership base. 



HOFFE SIG Update

Well another busy month has gone by, Labour is back in, a Kiwi won Bathurst again, a Kiwi won the V8 supercars championship and finally the whole country is back at level 1. We even have the luxury of international rugby (although maybe not the result in the first game that we wanted) and daylight savings has arrived for those long awaited summer Barbeques and celebrating the AB's win in the second game at Eden Park!!

I believe that one of the standout opportunities that has arisen out of this year's turmoil and one which we encourage you to take advantage of is the free fees now offered for fire related qualifications. I have been getting regular enquiries from HOFFE Technicians wanting to utilize this opportunity to gain professional qualifications and why wouldn't you??? As mentioned previously having documented qualifications and approvals strengthens not only your own personal credibility, but also our Fire Equipment industry as a whole. I believe that as far as practical we should pursue these opportunities, especially when it's free!!

We have also been receiving reports (again) that some new fire extinguishers which are in circulation have not obtained test certificates as required by the Hazardous Substances (Compressed Gases) Regulations 2017 sections 18 & 19. Sometimes this can be an innocent oversight from circumstances such as an overseas vehicle or item of production plant turning up in New Zealand with a fire extinguisher fitted, but unfortunately sometimes it can also be an intentional act. One of our HOFFE group members has reported that he was recently asked by a client to certify a new 4.5kg dry powder that they had purchased elsewhere - he was suspicious of the fire extinguisher so he took it to a CTLA test station in Auckland only to be told that it's not a compliant model and that the FERN number related to a 1kg ABE and wasn't relevant for that model. Obviously, these could be matters where, if Worksafe was to be involved, the outcome could potentially be quite bad for the companies involved.

We are also progressing with the NZS4503 review and as previously mentioned we have received some good input so far with some consistent points raised by different companies. As with most things the review is important but we will also be mindful of the cost of this project as that money has to be recouped!!

As usual companies or individuals wishing to participate in our HOFFE group regular meetings to either keep up to date or contribute to the discussions can do so either in person or by simply contacting the FPA's office who will make the video link available. This is probably even more topical and important with our group now working on reviewing what is arguably our part of the F.E. industries base document NZS4503.

Evacuation Consultants SIG Update

Many of us run fire drills on a regular basis, but how many take the time to look at the alarm panel before and after the drill is run? Do you check for defect warning indicators, or isolations displayed on the fire panel? Do you report these back to alarm agents or building owners?

It is critical that we ensure fire alarm panels have returned to their normal function state following drills. Any defects or isolations should also be reported to ensure the building is fully protected. Where isolations are in place, there should also be a procedure making occupants aware of the need to evacuate, where there is no automated life safety system operating.

Don't forget to take the time to read through and comment on the draft alarm standard DZ 4512:2020. There are parts of this that will impact those of us carrying out fire drills and have an input for fire alarm design.

Last month, we saw one of the first drills run in a hospital environment. This was recorded by Massey University and attended by members of FENZ, Auckland Council and private fire engineering companies. The aim of this study is to better understand evacuation times for those being moved between fire cells requiring varying levels of assistance. We hope to receive a further update at our next SIG meeting.

Our SIG meetings will be held on 9th November, time to be confirmed. Don't forget to get in touch if you have any comments or thoughts on how building design impacts on evacuation for the MBIE project or would like to be involved with collecting evacuation data for Massey and Canterbury Universities.

This series is driven by the ongoing changes we face as an industry and the importance of selecting the right products to meet design and standards requirements.

FPANZ is running a series of one day workshops throughout the country - our aim is to ensure that the industry is continuing to get the latest information and support.

NZS4541:2020

NZS4541:2020 is due to be published on 17 March. This seminar will introduce you to the provisions of the new standard, and will place an emphasis on the new seismic resilience requirements of the standard.

The changes to the seismic provisions are ground-breaking, and will require a new approach to how the designs are carried out, documented, and installed. The day will conclude with a workshop session, to allow designers to have hands-on training in the new provisions.

EARTHQUAKES

Following recent earthquakes events in NZ (Christchurch, Wellington and Kaikoura) the building industry is facing increasing pressure to design to protect the building and occupants against earthquake damage.

Generally, sprinkler systems have performed admirably in these events, however there has been some criticism of how we are designing our seismic bracing systems. The playing field has changed, and the construction sector is expecting more from the fire industry.

The presenters will outline what will now be expected to ensure that systems can be certified.

Public consultation: DZ 4512 Fire detection and alarm systems in buildings

NZS 4512: 2010 *Fire detection and alarm systems in buildings* provides a complete specification for the design, manufacture, installation, documentation, and maintenance of building fire detection and alarm systems, whether operated manually or automatically, in the event of fire.

This edition is a full technical revision which, when finalised, will supersede NZS 4512:2010.

The key areas that this revision has addressed are as follows:

- Significantly expanded specifications and guidance for the design and use of visual alerting devices in anticipation of their increased use for alerting the deaf and hard of hearing.
- Specific provisions for wireless-based detection and alarm technology, networked systems, and smoke detectors in ducts.
- New requirements for power supplies to support the full alarm load, earth fault monitoring, and seismic performance.
- New design requirements for the normal indicator, a standard cabinet key, enhanced EMC immunity, and labelling.
- Acceptance of equipment complying with new overseas standards, including short-circuit isolators and input/output devices.
- Changes to installation practice: increased zone sizes, reduced allowance for detector substitution, increased manual call point spacings, increased fault resistance in large alerting systems, and crimp-pin termination and identification of cables.
- Clarification of cable diversity requirements, manual call point locations, requirements for linetype heat and beam-type smoke detectors, requirements for maintenance access, and Type 5 alerting and hush facilities.
- Additional requirements for commissioning and routine testing, including an expanded escalation and resolution process for unresolved system impairments.
- · Significantly expanded requirements for system documentation, commissioning, inspection, and certification.
- Numerous other changes and enhancements.

This draft is available for public comment for a period of 8 weeks. All comments submitted during this period are reviewed by the standards development committee before the final standard is balloted on.

You can view or download the New Zealand draft standard on the <u>Standards New Zealand</u> <u>website</u>. The closing date for comments is **3 December 2020**.


