Free Fees on Qualifications Update

It is really pleasing to report that our sector has seen the second largest uptake of learners enrolling since we announced the free fees on fire

qualifications. There has also been a great increase in the new level 3 passive fire installer's qualification, with just over 150 learners. Other general enrolments have also jumped to approximately 650 learners. While the numbers are a great improvement on this time last year, it is also important that we keep the momentum going. It is vital that, as an industry, we support our learners and encourage them to keep working once they are enrolled and to complete the qualifications. The future will see increased requirements to be earning credits regularly, and learners who don't will be removed from programmes if they are inactive for three or more months. We have also worked with Competenz to review the level 4 fire alarm installer's qualification to remove some components that have hindered completion for learners living outside the main geographic centres.

SIG Meetings

The SIG meetings are really starting to build in both momentum and attendance. This is due to the number of projects we have underway and the interest they have generated. We have also now moved to a blended meeting format that makes it easier for members from around the country to attend. The blended meetings combine face-to-face meetings in a central Auckland location with the option of using Zoom for those not based in Auckland or not wanting to get stuck in the wonderful traffic we are bestowed with here in Auckland. We encourage you to attend the meetings to be part of the changes we are driving for industry and to have a voice in future directions.

NZS4510 Update

NZS4512 Update

The committee has completed the final work on NZS4512, and the document is now with the editors for final tidy up. At this stage, we anticipate it will be released for public comment around mid-October. If you have an interest in the fire alarm sector, please do download it and review the proposed changes. We will hold several online workshops to facilitate getting comments in and consolidated. Early next year, we will also hold workshops to provide education on the changes to NZS4512 and how they will impact on the sector.

The next round of sprinkler seminars are now booked for November, with the dates at this stage as follows:


Membership Renewal Update

HOFFE SIG Update

Well, another month has passed by and thankfully we are now starting to see an easing of the COVID-19 restrictions that we have all been living under for some time now.

At the time of writing this article we are scheduled to have our HOFFE group meeting & discuss what form the NZS4503 revision will take as well as what items have been proposed to be considered as part of the review. To date the most consistent response has been to please review the definition of a "Competent Person".

Another development has occurred in the Aero Fire situation - as a result of their continued attempts to procure products and operate an article appeared on Newshub on the 12th September about their activities. Included in this article were interviews with Mr Singh and also with Mark van Dorsten of PSL. discussing how they came to suspect that Mr Singh was operating in spite of the court order preventing them from doing so. Thankfully our FPA member companies are well aware of the background and current situation surrounding this company. The FPA continue to encourage member companies to report any activities to the Commerce Commission. Unfortunately, companies who operate like Aero Fire have been proven to bring our industry into disrepute which harms us all. It can be especially harmful when we are trying as an industry group to gain credibility and support for our members with initiatives like the Codes Of Practice, NZS4503

revision and various training options. Unfortunately bad news travels faster than good so if you have any information



please work with the Commerce Commission and/ or report any findings to the FPA who will forward it to them.

We are also receiving more reports of our service companies being asked to certify fire extinguishers which have been brought into the country but have not been tested and approved to the standards and ratings they are claiming. It is important to realize that once you certify and charge for your services you take on a liability and are saying that the fire equipment is fit for use. Do not certify the products if they are of dubious origin and may not be fit for purpose.

As previously mentioned, the free training initiative is available through Competenz for those wishing to become qualified HOFFE technicians - this is a great opportunity that is unlikely to be repeated. As you would expect overall enrolments have risen substantially as a result including a substantial increase in those seeking HOFFE qualifications.

Evacuation Consultants SIG Update

It is great to see that more building owners are taking their responsibility seriously and ensuring maintained evacuation schemes are in place. This has led to extremely high numbers of applications being submitted to the Fire information Unit (FIU) and subsequently caused delays in processing times. Scheme applications are processed in the order that they are received. If you feel your application is urgent this should be communicated in writing for consideration by the FIU. Do not forget that you can also update your training and drill results via the portal, this reduces the administration load of the FIU.

We are seeing some really positive results where evacuation consultants and fire risk management officers have been engaged in new projects from the design stage, this is resulting in better design for the end user, which is reducing variations and making the building more user friendly.

Our SIG meetings will be held on 25th November, time to be

confirmed. Don't forget if you have any comments or thoughts on how building design impacts on evacuation for the MBIE project. Or would like to be involved with collecting evacuation data for Massey and Canterbury Universities to get in touch.

This document has been through strenuous marketing & industry scrutiny including multiple feedback & review sessions as well as MBIE. This process although time consuming has been important to ensure all industry participants are on board with the content and its release.

Despite massive industry request and belief in the document getting it to this stage has not been a breeze and I would like to thank everyone involved with the document especially the original Working Group members who produced the document in good time and also Dave Prosser who diligently saw through its final stages.

Once graphics are completed the document will be marketed and publicly available free of charge for all to access.

It is then the intention that this CoP will be taken on a roadshow (Covid permitting) across the country and its value show cased to Councils,

Fire Engineers, Structural Engineers, Designers, Applicators and builders.

There is an opportunity for discussion around the creation of an NZQA Level 3 Intumescent Coating applicators qualification which is an exciting conversation to be having off the back of the momentum this document will create and the success of NZQA Level 3 Passive Installers qualification.

Well done to all involved to date. We now have a road map to raise the standard of Intumescent Coatings & understanding in NZ.

I am writing to let you know about the work of the Manufacturing, Engineering and Logistics Workforce Development Council (WDC) interim Establishment Board (iEB).

The Manufacturing, Engineering and Logistics iEB was appointed in June 2020 to work with industry to establish the Manufacturing, Engineering and Logistics WDC as a legal entity. Where possible, the iEB will also work with transitional Industry Training Organisations, the New Zealand Institute of Skills and Technology (NZIST) and other providers to provide advice and guidance to inform tertiary education system responses to COVID-19 impacts.

WDCs will contribute to the vocational education and training system by:

- Providing skills and workforce leadership for the industries they represent. This includes identifying current and future needs and advocating for those needs to be met
- Providing vocational education investment advice to the Government
- Developing qualifications, setting standards, and moderating assessments
- Endorsing provider programmes
- Promoting the benefits of educating employees to employers.

The initial focus of the <u>iEB members</u> is establishing the new WDC as a legal entity. We are currently developing options for the governance and establishment of these new organisations.

We will need your support to ensure that the new WDC can provide the vision and influence that support your efforts to develop our workforce. We will be in contact in the future to gather your views on the options identified.

4510 Committee Meeting

UPDATE DATE 17/9/2020 TO P4510 Committee and nominating organisations FROM Chris Mak, Chair – P4510 Committee SUBJECT Update on the revision of NZS 4510:2008 Fire hydrant systems for buildings.

PURPOSE OF THIS UPDATE

The committee revising NZS 4510 has had the kick off meeting. Due to the ongoing disruption of COVID-19, the committee meeting was held via online videoconference on 16 September 2020.

This is an update of progress to date, which is intended to be circulated to the committee members, who, in turn, are encouraged to update their nominating organisation on the progress of this project.

It needs to be noted that committee deliberations are confidential. This is to ensure, among other things, that committee members are not subjected to undue pressure and that assumptions are not made by members of the public as to what may be published.

Nominating organisations are also encouraged to provide feedback to their committee member(s) on any proposed changes.

COMPLETED & UPCOMING MILESTONES

The project is on schedule to be released for public comment in July 2021, with publication due in September 2021.

The following milestones have been completed.

1. Kick off meeting completed, where scope agreed and working groups established

The first development meeting is scheduled in November 2020, when working groups will report back on their proposed changes to NZS4510.

SUMMARY OF MAJOR CHANGES PROPOSED

The following major key changes to NZS 4510 are envisaged:

- 1. Review of the standard to reflect changes in the Building Code's Compliance Documents which may impact on the safety of fire-fighters in their operations.
- 2. Review of Appendix C for low rise buildings.
- 3. Review of certain technical aspects of the standard to align with NZS4541:2020, including seismic design, pumps and combined sprinkler and riser systems.
- 4. Review of construction requirements, including the need to partially commission the riser during the construction phase of a building project.



Over the last two weeks, we have seen the construction industry get in and do the right thing during these trying times. Particularly in Auckland, our people have quickly reverted to the procedures put in place to protect us all when chances of COVID-19 community transmission are higher.

The recent cluster outbreak has reminded us just how quickly this disease can spread and that we can't drop our guard. It is also a timely reminder that we can't get complacent about our Covid-19 health and safety controls either. We need the whole industry to pull together and do the right thing to maintain public and government confidence in our ability to work safely during these heightened risk levels.

The Alert level protocols and tools and resources, developed by our industry and available on www.chasnz.org/covid19, provide a standard way of managing COVID-19 in our construction related businesses. The establishment of these protocols were a key part of getting Government support for our industry to work at Alert Level 3.

We know that most businesses have been doing a good job in applying the protocols but we are aware that it is a constant challenge to maintain them over time, especially if workers see other businesses or even members of the public not applying a similar high standard.

To better help construction businesses understand and apply the protocols, we have developed some simple check sheets that you can use on site or when going to a workplace. These will help you to be confident you are doing the right thing.

You can use these check sheets when explaining how you are controlled COVID-19 to clients, visitors, building inspectors or even WorkSafe. They do not replace the protocols but help make it easier to check you are doing it right every day.

We have also had questions from clients around what they should be expecting from their builder or tradesperson. We have developed this one-page guide for clients you can use when asked questions about COVID-19 and what controls should be in place.
