The popularity of the seminars has seen us put on even more sessions to accommodate as many people as possible. In total, we will be running ten NZS 4512 seminars. 

It was also very pleasing to see that our cricket team overcame good opposition, travel, covid restrictions and even the weather to lift the ICC World Test Championship trophy.





Since the last article we have been involved with the review of the level 3 HOFFE qualification. A couple of interesting points about this review were as follows:

- Our Fire equipment industry training programmes continue on even after Competenz closes its doors.
- The transition takes place after August 2021.
- The free fees scheme is still on offer.
- The level 3 HOFFE qualification only requires 105 credits.
- Generally, a novice person with some practical skills can achieve this qualification within 2 years.

As an example of what shouldn't happen, I was recently on a major high profile construction site in Auckland and, while going over the fire-fighting equipment installed on a new vehicle for the site, I noticed a 9kg ABE fire extinguisher in a heavy-duty fire extinguisher vehicle bracket. It caught my eye because it had bent handles and a twisted safety pin in it which looked like it had recently happened but someone who didn't know what they were doing or was having a very bad day had certified this - a bad day for the following reasons:

- a) The service tag noted NZS4503 as the reference standard yet the hole (only one) was a round hole not a number as required under section 2.8 of NZS4503:2005?
- b) There was no recorded test date at all?
- c) The only hole on the service tag intersected August 2023?
- d) No service safety seals.
- e) The heavy-duty fire extinguisher vehicle bracket had no safety pins in it at all or service safety seals and it was headed into some rough terrain.

Evacuation Consultants SIG Update

As we have just celebrated the shortest day of the year, it is important to consider the environment when carrying out trial evacuations. Many organisations choose to carry out early morning drills so their night shifts can be included, whilst this is encouraged an assessment should be considered to ensure there is sufficient lighting moving from the building to the assembly area, and any vehicles operating in the aera can clearly see the occupants.



Recently Fire and Emergency NZ demonstrated a 'live burn' house fire, this was widely published via television and media platforms. Many of us consider commercial building safety, we should also consider fire safety in other areas that may fall outside the requirements of the evacuation regulations.

Changes to Regulations on Trial Evacuations and Training Programmes

(Fire and Emergency New Zealand (COVID-19—Fire Safety, Evacuation Procedures, and Evacuation Schemes) Amendment Regulations (No 2) 2020)

The requirement for building owners to conduct trial evacuations or evacuation training programmes will be reinstated from next Monday, 1 February 2021, provided there are no physical distancing requirements in place for the area in which the building is located. Specific exclusions have been included in the changes to accommodate those buildings which are in use as Managed Isolation and Quarantine Facilities.

Building owners are not expected to resume trial evacuations or evacuation training programmes immediately the changes come into force. To work out when the next trial evacuation or training programme notification is due, you calculate a 6-month period that excludes the time from 25 March 2020 to 31 January 2021.

This means, for example, if a building was due to have a trial evacuation conducted by 10 April, 17 days after the suspension began, there will be a requirement to conduct a trial 17 days after the changes take effect which will mean 17 February 2021. This is provided there are no physical distancing requirements in force.

Inspectorate SIG Update

Recently I had the opportunity to attend the FPA NZS4512:2021 seminar. It was pleasing to see high levels of engagement and attendance. Like the NZS4541:2020 seminars put on by the FPA the fire alarm sessions are also being attended by senior technicians. I applaud those companies who are investing in the professional development of their site staff.

It is important for all of our industry that quality training is provided to the staff in the field. While there is no getting away from the fact that training does cost one cannot quantify how much is saved when a field technician realises that they need to do something different to comply with the current standard. As inspectors we often hear the expression "But we have always done it this way"; attending training is an important pillar in breaking that thinking. An equally important pillar is reading and considering what is written in the revised sprinkler and fire alarm standards.

For a long time our industry has struggled with formal education paths and training. Training is so often a senior member of staff training the new person; the problem this creates is one person's faults and bad habits are passed along. With the New Zealand Diploma of Engineering (NZDE - Fire) now available there is yet another education path available to our industry. Between FPA seminars for ongoing professional devolvement, the new NZDE strand and the existing New Zealand Certificates (Fire Protection) there are a multitude of education paths available. I would encourage members to take advantage of these training opportunities.

Passive Fire Protection SIG Update

BUILDING (Building Products and Methods, Modular Components, and Other Matters) AMENDMENT BILL

The Government has recently passed the first phase amendment to the Building Act 2004 with the introduction of Building (Building Products, and methods, Modular components and other matters) Amendment Bill. Effective from 8th June 2021.

The Building.govt.nz website states that this is the first phase in an effort to make the Building and Construction Sector more efficient, provide greater robustness of products and improve trust. Future phases will look to tackle LBP scheme and Engineers.

The key changes are:

- Provide minimum information on product supply to allow better informed decisions
- Introduce a minimum framework for modern methods of construction such as prefabrication
- Strengthen the product certification system (Codemark)
- Increase penalties that can be imposed upon **Individuals** or **Organisations**.

Specifically information that a Manufacturer or Supplier must provide is:

- **)** a description of the product;
- details of the supplier, including contact information;
- Information on the scope and limitations of use for the product;
- design and installation requirements, and maintenance requirements;
- **)** a declaration of whether the product is subject to a warning or ban.

Any increase in standard in the Construction industry is a good thing and the implications upon our specific industry will be very relevant and immediate.
