
The updates we provide are sent to the primary contact we have at each member company. As a brief summary of most of last week's emails, I can report that we initially contacted MBIE on behalf of members to ensure that fire protection was classified as an essential service. We sought further updates as to what functions within our industry could be classed as essential and continue to work on logistics for the industry. We communicate with our MBIE contacts multiple times a day and regularly filter the feedback and questions from our members to gain clarity. We will continue this process for the foreseeable future and keep providing regular updates to our members.



## Passive Fire Protection SIG Update

## Advice on Third Party Monitoring & Inspection:

I have fielded several enquiries in recent months regarding the relevance of Third Party Inspection. These questions have come from Building Consent Authorities, Contractors, Fire Engineers, Manufacturers & Clients.

In order to provide a well-considered response I have researched within NZ & also looking at International best practice.

There is no regulation under the Building Act or NZBC that requires Third Party Inspection for Passive Fire. However, In short there is a place for Third Party Inspection for Passive Fire in NZ. We need only look at the Alarms & Sprinkler world to see how the Independent inspection scheme has worked well.

There are a few points that need to be considered when Third Party Inspectors are being engaged.

Looking at best practice advice Internationally & looking at areas outside of Passive Fire there were a few key criteria that were continually referenced as being critical for Third Party inspection/ certification:

#### 1. INDEPENDENT/ IMPARTIAL

- Absolutely no involvement or affiliation with Design & specification
- Absolutely no involvement in procurement
- Absolutely no involvement in Manufacturing, fabrication or distribution
- Absolutely no involvement in installation or contracting


#### 2. QUALIFIED


- Suitably qualified in the area of expertise
- Suitably experienced in the area of expertise

In NZ there is currently no Certification body for Third Party Inspection for Passive Fire. Therefore there is more importance needed for Third Party inspections to prove training, qualification & experience. There is an NZQA Level 4 Passive Fire Inspection qualification run through Competenz which could be considered.

Associations such as FPANZ do not provide any independent certification or accreditation to such inspectors in NZ for Passive Fire.

Other attributes that should be considered when engaging Third Party Inspectors should be:





- Public liability insurance
- Contractual authority i.e what power do they have within the contractual implications of the project
- Compliance authority i.e what power do they have within the compliance of the project

As there is no regulation for Third Party inspectors to be engaged on projects the following is a list of scenarios when a Third Party Inspector may be beneficial:

- Retrospective inspections (particularly when no compliance documentation for installations is available).
- Disputes regarding quality
- Quality concerns
- Insurance
- Client requested
- In house review or auditing
- When a lower experienced or resourced contractor maybe engaged where there is not a high level of confidence.
- When no Passive Fire specialist contractor has been engaged – i.e Main contractor selfperforming or sub trade self-performing
- High risk projects where there is a heavy dependence on Passive Fire systems such as specialised build projects.

Happy to discuss Third Party involvement with any interested parties.

# Employer COVID-19 wage subsidy and leave payment information sheet

#### **COVID-19 Wage Subsidy**

The Government has put together a COVID-19 Wage Subsidy for employers in all regions.

It's to support your business if you are impacted by COVID-19 and face laying off staff or reducing their hours because of COVID-19.

If you are an employer, contractor, sole trader or self-employed you may qualify to get the COVID-19 wage subsidy.

#### To qualify:

- your business must be registered and operating in New Zealand
- your employees must be legally working in New Zealand
- the business must have experienced a minimum 30% decline in actual or predicted revenue over the period of a month when compared with the same month last year, and that decline is related to COVID-19
- your business must have taken active steps to mitigate the impact of COVID-19
- you must make best efforts to retain employees and pay them a minimum of 80% of their normal income for the subsidised period.

## The COVID-19 Wage Subsidy will be paid at a flat rate of:

- \$585.80 for people working 20 hours or more per week
- \$350.00 for people working less than 20 hours per week.

The subsidy is paid as a lump sum and covers 12 weeks per employee.

This subsidy is for wages only. It is to help you keep your staff employed while you consider changes that may be needed while the disruption continues, and to ensure the future viability of your business.

Businesses can only get this subsidy once.

#### **COVID-19 Leave Payment**

Self-isolation is an important way to slow the spread of COVID-19. From 17 March 2020 the COVID-19 Leave Payment will be available to support people financially if they need to self-isolate, cannot work because they are sick with COVID-19 or cannot work because they are caring for dependents who are required to self-isolate or who are sick with COVID-19.

The COVID-19 Leave Payment will be available for eight weeks from 17 March 2020. Employers can apply for this more than once.

It will be paid to employers who have eligible employees and they must pass the payment onto their employees **in full.** 

#### To qualify:

If you are an employer, contractor, sole trade or self-employed you may qualify to get the COVID-19 Leave Payment.

COVID-19 Leave Payment covers full-time, part-time and casual employees, and contractors who are legally working in New Zealand and who:

- need to self-isolate in line with Ministry of Health Guidelines and have registered as needing to self-isolate with Healthline, cannot work from home and their selfisolation is not because they left NZ since the travel restrictions on 16 March 2020 and have since returned, or
- cannot work because the person has been diagnosed with COVID-19, or
- cannot work because they are caring for dependents who are required to self-isolate or who are sick with COVID-19.

## The COVID-19 leave payment will be paid at a flat rate of:

- \$585.80 to a person working 20 hours or more per week
- \$350.00 to a person working less than 20 hours per week.

Employers receiving the payment for employees who are required to self-isolate can receive it for 14 days. As people may be required to self-isolate more than once, employers will be able to apply for this on an 'as needed' basis. It can be paid for the entire period an employee is sick (or looking after a dependent person who is sick) with COVID-19 but the employer must apply every 14 days.

## Using paid leave entitlements or COVID-19 Leave Payment when self-isolating

You and your employee can agree to use any form of paid leave (eg annual leave) to cover their period of self-isolation.

However, employees aren't required to have used any or all their paid leave entitlements before they can receive this payment.

#### Eligible employers and employees

When applying for the Leave Payment the employer will consider whether:

- the employee was legally working for their employer at the time they decide to selfisolate, and
- they were expected to work for the period of self-isolation.

**Self-employed people** who are legally working in New Zealand are eligible for the payment if they:

- are usually earning the minimum wage when they decide to self-isolate, and
- were expecting to work for the period of self-isolation, and
- cannot draw an income for the period of self-isolation.

Some people aren't eligible for the payment, including:

- self-employed people not earning at least the minimum wage
- people not legally working in New Zealand.

**State sector employers cannot receive the payment** as it is expected they will pay employees their normal wages through periods of self-isolation. State sector employers include: Government agencies, crown entities eg Kāinga Ora, ACC.

The following employers can access the COVID-19 Leave Payment:

- Councils
- Kindergartens
- Early Childcare Centres
- Non-government Organisations
- Tertiary Education Institutions such as
  - Universities,
  - Polytechnics/Institutes of Technology
  - Wānanga.

#### Applying for either payment is easy

You apply online for either the COVID-19 Wage Subsidy or COVID-19 Leave Payment at www.workandincome.govt.nz/covid19support

When you apply you will need to give us:

- your IRD number
- your business name
- business address
- the names of your employees
- · your employee IRD numbers
- contact details for your business and your employees.

We will be processing and approving applications as quickly as we can. We are aiming to make payments five working days after we have all the information we need from you – but this will depend on the volume of applications received.

**Audits and reviews** – you will need to declare you meet the criteria for payment as part of your application. All payments will be subject to audits and reviews.
