The passive seminar is aimed around awareness of passive requirements for those not working within the passive sectors. As such, it is not specifically intended for passive members unless they are new to the industry.

MEMBERSHIP YEAR

The current membership year finishes at the end of June, and we will be sending out renewal packs then. Please remember that you are required to review and complete the declaration to ensure your membership level reflects the number of staff you have. We will not be increasing the membership fees for the new year, so it is important that members do pay the correct fee based on their company size. Part of the declaration requires you to confirm equivalent full-time employees, which determines the membership fee. Our ability to continue to deliver services to our members is directly determined by the number of members paying the

correct fees and on time. Also, just a reminder that the new membership process requires that any members who choose to resign and later re-join will need to go through the new process (see the April newsletter for details of what this involves).

PRODUCT SHORTAGES & PRICE INCREASES

In the past couple of months, I have been meeting with members to discuss the implications of product shortages and price increases in the construction sector. Not only do we have less shipping availability, delays caused by the blockage in the Suez Canal, and delays in the Auckland port, but if you add the production slippages from factories due to COVID-19, China's removal of the export tax rebate on many steel products, and global price increases, it really does start looking like a perfect storm.

I also meet regularly with several key members of The Vertical Construction Leaders Group (VCLG), and the storm is not confined to one sector or sub trade but is affecting the entire construction sector, with little respite expected in the near future. We will continue to see how the association can assist its members, and the current best advice we can give is to keep in regular contact with suppliers and your principal contractors. It would also be prudent to review contract conditions during the tender phase and seek to minimise your exposure where possible. We have also raised this issue with other sub trades and the Ministry of Business, Innovation and Employment (MBIE), but there doesn't seem to be any immediate fix to these problems.

CAREERS EXPO UPDATE

As per my last update, we are on track to attend the Dunedin careers expo on 9 June 2021 and the Wellington careers expo on 25 and 26 June 2021. We welcome all members in these regions to stop in and visit us or to register your interest in attending to meet with us and future school leavers and parents.



SIG UPDATES

HOFFE SIG Update

Well yet another month has gone by, the NZ rugby teams are again dominating the Aussie teams (12 wins before a loss) and we are continuing to see more Coronavirus outbreaks overseas. This inevitably impacts on us all, but then I guess this COVID-19 environment is the new normal now.

I was pleased to see a few more faces attending our HOFFE group meeting on Friday, that said with projects like the review of NZS4503 on the go there should be more companies present as this affects many industries including insurance, compliance and of course fire equipment companies, especially those with service people working for them. Amongst those who attended the meeting either in person or by video link there were some good positive discussions held amongst the group and we once again made progress.

I have also had some phone calls regarding the move by FENZ (Fire & Emergency New Zealand) to remove foam from their fire extinguisher line up. Some are interpreting this as meaning that foam fire extinguishers must be removed from service which is simply not the case. Peter Gallagher from FENZ has reiterated at our last two meetings that it is an internal policy decision by them for them. I hope this helps to clear up any confusion as those foam fire extinguishers in use in industry can still be certified, tested and remain in circulation. It is also worth remembering that as far as fire extinguishers are concerned, for many years New Zealand has typically used a 6% - 10% concentration of AFFF up to a maximum of a C6 foam, not C8 foams which are those commented on internationally.

Our next meeting is on Friday 16th July at the Royal New Zealand Yacht Club, starting once again at 1pm, this is the new start time that was agreed to by the group at a previous meeting. We invite those with an interest in our sector to attend either in person or via video link, included in the meeting will be an update on the review of NZS4503 (Hand Operated Fire-Fighting Equipment) - whether you are a FPA member or not you can participate so this is your chance to have input into a widely referenced and very important document.

Evacuation Consultants SIG Update

During our last SIG meeting the topic of training and drills was raised, there was discussion about whether carrying out a fire drill every 6 month was sufficient to ensure staff were confident in applying their evacuation procedures. Whilst maintaining a scheme by running a drill or training every 6 months worked in many cases, a discussion was held around facilities where there is a 24/7 staffing presence, it was noted that running a drill every 6 months would only be inclusive for a small number of the staff. How do you assess the frequency of training sessions and fire drills to meet the needs of your building?

There was also discussion around the preparation, and maintenance of evacuation schemes for residential apartments that had domestic smoke detection. Whilst it is desirable to have a hardwired alarm system installed there is not always a legal requirement. The new NZ4514:2021 standard was discussed which talks about interconnected smoke detection and is available for free download.

I look forward to seeing you at our next SIG meeting, don't forget we have conference calling facilities so you can dial in from anywhere in the country. Keep an eye on the website for meeting dates and locations.

Changes to Regulations on Trial Evacuations and Training Programmes

(Fire and Emergency New Zealand (COVID-19—Fire Safety, Evacuation Procedures, and Evacuation Schemes) Amendment Regulations (No 2) 2020)

The requirement for building owners to conduct trial evacuations or evacuation training programmes will be reinstated from next Monday, 1 February 2021, provided there are no physical distancing requirements in place for the area in which the building is located. Specific exclusions have been included in the changes to accommodate those buildings which are in use as Managed Isolation and Quarantine Facilities.

Building owners are not expected to resume trial evacuations or evacuation training programmes immediately the changes come into force. To work out when the next trial evacuation or training programme notification is due, you calculate a 6-month period that excludes the time from 25 March 2020 to 31 January 2021.

This means, for example, if a building was due to have a trial evacuation conducted by 10 April, 17 days after the suspension began, there will be a requirement to conduct a trial 17 days after the changes take effect which will mean 17 February 2021. This is provided there are no physical distancing requirements in force.

Fire formal interpretations

NZS 4512:2010 Fire Detection and Alarm Systems in Buildings - Definition of Co-located (104)

Question:

Does the requirement for two pieces of colocated equipment to have "common access" mean that they must both be in the same room?

Interpretation issued by the Alarms and detection group:

Yes, when located indoors the two pieces of equipment need to both be accessible from within the same room.

Where the equipment is accessed from outdoors there shall not be any gate, door, fence, wall, or other impediment to access between the two.

NOTE: The 5 m maximum separation limit is a walking distance between the two pieces of co-located equipment and applies in all cases.

This interpretation also applies to NZS 4512:2021 (in publication).

OPINION

QUESTION: Now that it has been published, when will NZS 4512:2021 come into effect?

ANSWER: Progressively...

NZS 4512:2021 has been foreshadowed by MBIE to be cited in the Building Code Acceptable Solutions as of late 2022. Assuming that happens, NZS 4512:2021 will become mandatory for all new installations consented according to C2/F7:2022 after their inception date (whatever that is).

Prior to that date, the new NZS 4512:2021 will apply whenever a Building Consent Authority (BCA) decides to cite it in a building consent, either for a new installation or for alterations to an existing system. The new 'minor works' provisions of 5.5.5 may also help BCAs with consenting policies around small alterations to existing systems.

For engineered alternative solutions and fire reports, NZS 4512:2021 is likely to start being cited immediately because professional engineers have a duty of care to apply the most up-to-date in know-how and good practice.

For installations using wireless detection, duct smoke detection, broad-coverage visual alerting devices (VADs), or networking, a professional duty of care will require the applicable provisions of NZS 4512:2021 to be followed simply because they provide a benchmark for good practice and the 2010 edition was mostly silent on these subjects.

For existing system upgrades and extensions, the 'deemed to comply' provisions of 1.8.4 will encourage the use (at least in part) of the latest technology, testing, and maintenance requirements.

Accredited inspection bodies are likely to start using the NZS 4512:2021 inspection and reporting protocols, forms/certificates and procedures simply because they reflect the latest in good practice.

For manufacturers: new product design, system upgrades, laboratory appraisals, and Register listings will almost exclusively be to NZS 4512:2021 from now on as the new provisions are at least as onerous as NZS 4512:2010. The 4-year lead-time provisions (deadline 13 May 2025) of NZS 4512:2021 will be implemented, applied (and listed) progressively as products are upgraded or replaced.

GENERAL COMMENTS

NZS 4512:2021 offers very few relaxations compared to NZS 4512:2010, and numerous enhancements, so there ought to be few barriers to early adoption among engineers and BCAs. Objections may possibly come from contractors as they get used to the enhanced installation, labelling, reporting, and documentation requirements...

For information, the key relaxations are: minor changes to alphanumeric displays, use of overseascertified addressable devices, increases in allowable detection zone size and MCP travel distances. concealed space zoning, and detector coverage in roof spaces <800mm. Changes have also been made to the criteria and thresholds around heat detector substitution for smoke detectors.

Note also that work needs to be done to either the 2010 or 2021 version, not a 'pick and mix' of the two.

Outstanding Engineering Achievement

The FireNZ award aims to recognise contributions made by the candidate to the promotion of the engineering profession. This could be in recognition of:

- Significant contributions to the advancement of the professional recognition of the fire protection engineer.
- A fire design that represents a novel, artistic and imaginative solution to a problem
- A project that has delivered enormous value and impact to either a community, country or organisation
- An outstanding collaboration between an engineering organisation and one or more other organisations, that results in a better project outcome or has a significant positive impact on a workforce, customers or community
- A breathtakingly clever engineering project or product launched or completed in the past two years that has solved an age-old problem or shifted from the 'always done this way' mentality
- An individual or team for inspiring engineering education or a significant initiative. It may include student or peer support, teaching, research or other significant initiatives that result in an enduring positive impact

Lifetime Achievement Award

The Lifetime achievement / outstanding contribution award is a prestigious recognition of life-long contributions to and career achievements in the field of fire safety in New Zealand.

Young Professionals Award

The Young Professionals award is for a young person who has demonstrated outstanding leadership qualities, excellence in their career, academic excellence and/or has provided a contribution to the fire safety community.

Candidates must be within five years from completion of their most recent qualification at the time of nomination or start of employment in the fire industry. The maximum age of the candidate is 35 years at the date of the award.

Competenz Learner of the Year Award

The Competenz Learner of the Year Award celebrates excellence among learners and highlights trades careers in the fire protection industry. The Award acknowledges learners whose skills, drive, commitment and work ethic has helped them to achieve outstanding outcomes. It's open to anyone who has completed a Level 3 or 4 programme through Competenz between 1 January 2020 and 31 May 2021. Entry details will be available shortly and will be advertised through Competenz.

NOMINATION PROCESS

A nomination from any person or organisation within the fire industry will be accepted and membership of the three FireNZ organisations is not required. Self-nominations are not accepted

FIRENZ AWARDING COMMITTEE

The nominations will be considered and recipients chosen by the FireNZ Awarding Committee which is made up of representatives of the FPA, SFPE and IFE. The judges decisions are final and no correspondence will be entered into.


