Passive Fire Protection Update

As we reflect back on the year the Passive Sig has had great attendance at each meeting and collectively spent many hours inputting into improving the industry.

In the past year, we have focussed on the following three goals:

- Training for FPA members - this consisted of two hand on practical seminars
- BRANZ Passive Guide –our team have spent many hours proving feedback to BRANZ for a document that is intended to assist the industry. We certainly hope our input is taken on board and the document is practical.
- MBIE Passive and Construction Monitoring Review – This is a great opportunity for FPA to have input into the future of what Passive may look like from new installation point of view and post construction (BWOFF Process).
- Education by Passive Tips

The focus of the group has primarily been on fire stopping of penetrations through fire separations, however other areas of passive fire protection e.g. steel protection. This is also an area of concern from what I observe during construction monitoring and next year the SIG needs to review how all parts of Passive Fire can be included.

Passive Fire Protection is one of those areas that does not receive the attention it deserves particularly from an installation point of view, as there has not yet been a disaster that forces change. We are certainly hoping that the proposed actions of the MBIE review will eventually change the way Passive is installed, monitored during construction and checked during the BWOFF process.

Passive Tip of the Month

Design and Build *not* Build and Design

It was mentioned as part of the MBIE review that often we Build and Design not Design and Build. That is so true when it comes to Passive Fire Protection. Too often the tradesman is handed a fire stopping solution by his supervisor which is totally incorrect. e.g. incorrect sealant for a bunch of cables. Because the tradesman has not been trained in passive fire protection he (*often he!*) just does what he thinks best which is often incorrect.

If you are required to undertake any passive fire protection work then ensure you design then build as building and then trying to design will ultimately result in additional costs to get it right.

Light at the end of the tunnel!

Firstly, I would like to thank Ron for all his hard work over the last few years as the Passive Special Interest Group Chair – he has been a huge influence in raising awareness of the problems we face in our industry!

I think its fair to say that the message has really been driven home that many of our commercial properties suffer from passive fire problems, there is a lack of passive awareness during the construction process, many manufacturers information needs to be more detailed to save confusion and there should be allot more industry input at design stage.

The message has hit home!

Going forward – I think its essential the industry moves to more positive ground and starts addressing the issues and provide a way forward!

In my opinion, the biggest problem we face is direction and guidance, inspectors, architects, installers all have little to no guidelines to work too - what is reasonable and unreasonable to expect – what is their scope of responsibility and expectation?

Currently we have a building code which details a standard products should be tested to – and that’s about it!

I witness tension at site level on an almost daily basis – fire engineers, architects, inspectors and construction monitors often pulling in different directions – some asking for the impossible – others delivering the laughable – and why – because nobody has a clear idea of what is reasonable and how products behave in a fire scenario!

In every country I have worked – there has always been a leading light – a body that drives the market forward and I believe the FPA passive SIG is potentially that light.

There is no quick fix – we have lots of work to do and allot to sort out - but I believe its doable!

What I hope to achieve during my term as passive SIG Chair, is develop a series of guidance documents that will become the industry accepted code of practice.

The FPA guidance notes will be written and prepared by industry professionals, based on data and evidence gathered from home and abroad.

It will be written with all investors in mind, from the designer, builder, supplier, installer, inspector, construction monitor to the IQP – all will work to the guidelines issued by the FPA which will set out what is expected to ensure the highest level of passive fire compliance.

I also have other proposals I’d like to put forward to the passive SIG to help move things forward, such as a web site based list of code compliant passive products, that can be easily accessed to check if a product is fit for purpose.

Training is another huge issue – I believe this can only really be tackled once we start to formulate the FPA guidelines.

Trainers need to be aware what industry requires – not what they choose to promote – we must vet trainers, IQP’s and construction monitors to ensure they can prove their independence and industry knowledge.

There is allot of work to do – it won’t be easy and some of my proposals might be rejected – but we have to start somewhere and I believe these ideas are positive!

My brief as Passive SIG Chair was quite simple – get things moving – and that’s exactly what I intend doing – I can’t do it alone – I need involvement from manufacturers, installers, fire engineers, councils, consultants and testing laboratories to help move things along – my goal is to create a fair, safe and level playing field for all and I think that’s what most of us would like to see.

There is light at the end of the tunnel and I’m sure others can see it too – if you’re interested in joining the Passive Special Interest Group and being a part of the way forward – then please contact Scott at the FPA as we welcome the support.

Inspectorate SIG Update

Another year just about done and dusted.

It has been an interesting year with some positive developments from MBIE regarding the "Fire Review Program" that are likely to have flow down affects throughout the industry. Currently there are three working groups dealing with issues around Passive Fire Protection, Construction Monitoring and Post Construction Compliance Monitoring. Each has a selection of industry specialists from key stakeholders. While they are all still a while away from producing any fixes it is almost guaranteed that there is likely to be an increase or firming up of processes dealing with these areas.

On a positive note as the Chair of the Construction monitoring group I have noted that the way that the model that is currently used for inspection and certification of sprinkler systems in held in high regard amongst people involved with all sides of the building industry including the BCA's and Fire Engineering Community.

Water management and health and safety are becoming a bigger and bigger part of our daily lives with many of the jobs that we do involving both. TA's and Water authorities are becoming increasingly restrictive in with regards to what can be done when on networks throughout the country, the Tauranga Council are now requiring notice of any high flows from sprinkler systems during a biennial or annual survey in order that they can assess the need to shut valves to protect parts of the network from having the bio film stripped from pipes and causing water quality issues. Currently this is only adding time to the process for biennials in this area and not cost. One change that has brought in a lot of cost and added time to the process has been a tightening of control from water authorities around access to networks for flowing from street hydrants. There is now a complicated process to follow involving permits to access, traffic management plans, potential letter drops and possible after hours requirement depending on the area the testing is carried out in. This has led to a significant increase in costs on average tripling the cost from three years ago. While the costs in some cases may seem excessive the cost of not following these requirement can be even greater with the Water Supply Authorities having the power to hand out fines of up to \$15,000 for unauthorised access to the network.

Another area that has recently come to the attention of the SIG which is likely to have an increase cost which will flow onto the end user is regarding health and safety with regards to flow testing of sprinkler systems on buildings in city centres and other high traffic areas. Auckland Transport have employed a number of inspectors who are monitoring for infractions where work is causing footpaths to be blocked and foot traffic to be diverted. As an industry group we had identified this as a potential problem and we will be approaching AT to come up with an industry solution. Again it is likely to involve increased costs and delays due to permits and traffic management plans and once a solution has been reached your inspectorate company of choice will be able to help with the exact costs and requirements.

Another significant issue arising in Auckland is that the water supply pressures in the older suburbs seem to be reducing. Designers are warned that it is not prudent to design to the wire, with little margin between the supply and demand pressures.

Worksafe, CTLA, FPANZ Meeting

The SIG group have initiated a meeting with Worksafe and CTLA (Cylinder testing laboratory association) in September and will work through the common issues both parties have. All parties agreed there needs to be more communication we will have a follow up meeting in October to update progress on the points discussed, CO2 valve and cylinder compliance issues there were a number of action points agreed. We have been assured by Kim Comben that we will have Worksafe written response to our questions from back in September this month.

HOFFE Code of Practise & NZS4503

Code of Practice can be sent out for review by members if required. Lance to hear questions from council at next

meeting. Equipment register could be used to provide funding for future updates to the standard. The cost to update standard is between \$100-\$200K. No mechanism in place currently to get funding. Should we amend or rewrite as this effects cost??

The Importance of Component Limits

When designing any mechanical system all the components and parts that make up that system have a performance limit. A sprinkler system is no different and as a collection of numerous components the designer and site supervisor need to remain cognizant of the intended performance parameters that the system will operate under and the parameters of the components they are using in making up the sprinkler system.

Common limits that contractors need to pay attention to are:-

- Temperature ratings of sprinkler heads Vs the environmental conditions
- Load limits of fixings
- Load limits of hanger and brace components
- Pressure limits of pipe and fittings
- Pressure limits of valves, pumps and other auxiliary components

While NZS4541 may specify maximum limits these are maximum limits and it remains the responsibility of those selecting products to confirm that all products are being used within both the limits of the manufactures data and the limits of the Standard. One good example is the standard specifies a maximum allowable spacing between seismic braces but that assumes the contractors selects all components that comprise a brace system are rated for the necessary load imposed.

As the range of products in the market place and solutions continues expand designers and supervisors need to remain aware of the requirements within our industry to deliver quality installations for the success of the whole system may be resting on the performance of a 5 cent part. It is worth quoting a single sentence from the foreword to NZS4541:2013 *"The importance of detail cannot be over-emphasised"*

Since launching in July 2015, the Fire Programme has covered a great deal of ground across various issues to develop solutions for improving the fire regulatory system. I'm pleased to report this work is now close to completion and we'll soon be into the next phase of the programme, which will be to put out a package of proposals for public consultation next year.

Our focus now is on reviewing all the documentation from the various workstreams before we finalise proposals to consult on. This will include Alternative Solutions, Acceptable Solutions and Verification Methods, Internal Surface Finishes, Structural Performance in Fire and Supported Housing. A number of other areas which we've started will be progressed next year, with a wider perspective beyond fire. We'll keep you posted about the expected timing of the consultation closer to release in early 2017.

Internally, we recently farewelled Chris Rutledge as Programme Manager, from whom I took over. We thank

Chris for his contribution in helping launch the Fire Programme and progressing it to where it's at today. We also welcomed on board Dave McGuigan, MBIE's Deputy Chief Engineer, as project sponsor.

Support from the sector has been critical to the progress we've made on the Fire Programme. We've had excellent support from stakeholders, with more than 85 people actively engaged on 10 project working groups. Also, I'd like to extend a special thank you to our external working group chairs.

Once again, I'd like to thank you all for your commitment to the Fire Programme this year – we couldn't have got to where we are today without your input. We look forward to your continued support during the next phase of the programme as we work towards landing on solutions for improving the fire regulatory system that will ultimately benefit everyone in New Zealand.
