Proposed workplace training reforms

On Wednesday 13 February, the government announced the proposed major changes to New Zealand's Vocational Education and Training (VET) system. These proposed reforms will affect all industries, including fire protection. While there is a definite need for review and improvement, the announcement was far more wide reaching than we expected. More importantly, the consultation period of just six weeks is insulting, and I do not believe it gives you, the industry, the opportunity to consider the proposals and respond.

We have further information on this on page 7 of the newsletter, and I encourage you to have your say. I will be attending a meeting with our ITO, Competenz, on 28 February and hope to have more to report shortly after. We will be making a submission on behalf of members, but please consider making a submission of your own to ensure your voice is heard.

Training SIG Update

While the training SIG didn't achieve its primary objective in the timeframe we planned, we have learnt a lot from the process. Given the importance of training and of raising the profile of the industry with school leavers and those in the employment market, the board decided that a reboot of this group was required. We have narrowed the scope to a more manageable list of objectives and to allow for specific funding to be targeted at one or two key objectives as approved directly by the board.

As such, the training SIG has now been replaced with the Training and Careers Development Sub-Committee, a special project team that will focus on developing training material, courses and industry careers. This team will report via a selected specialist directly to the CEO and board. The committee will have two specific goals: raising the profile of careers in fire protection by attending careers days and the like, and the development and completion of a gateway-type programme with all the principles and objectives of the Fire101 pilot.

HOFFE SIG Update

Well it has been discussed and voted on and it looks like the HOFFE group are stuck with me for another year, sorry about that!! We have had our first meeting of the year and agreed some goals for the year as well as discussed current issues. The main goals are the HOFFE listed product register (nearly ready) and the service code of practice.

It was also pleasing to have Shannon and Brendan of Flamestop join us, of interest to the group was Shannon's input as to how the Australians are dealing with the foam issue. In short as Australia has various different states they have often different approaches to issues, however other than the expensive process of incineration there is no environmentally acceptable solution for the disposal of foam.

Obviously, the diluted quantities of foam used for HOFFE are not the focus of powers that be, that said we still need to be sensible, careful and responsible in our own actions remembering that often people's perceptions of our actions (right or wrong) may be what drives them to make a complaint. I believe that as an industry we are quite mindful of the environment and do not willingly set out to cause harm



to the environment in which we live. That said without even considering the potential danger to life from fire, the environmental damage that can be created by using a fire extinguisher (containing 6% foam and 94% water) is most often a lot less than the damage that could or would have resulted from an uncontrolled fire!!!

We have also seen quite a few companies selling and servicing fire equipment who may struggle to meet the definition of a "Competent Person" as defined by NZS 4503. Obviously, we all need to be careful when throwing stones but to benchmark the industry most operating in it should have attained or be working towards a minimum of a Level 3 HOFFE qualification.

Passive Fire Protection SIG Update

The year has started off with a huge work load ahead of us: We have the coatings group working on a new technical guide for Intumescent and protective coatings, NZQA level 3 installers qualification being driven by a separate group with a target delivery date mid-2019, Technical position statements being reviewed for imminent release, New software for the passive equipment register being sourced to enable much easier navigation due to the shear mass of information now listed, and some thought going into a potential new NZQA qualification for designers and specifiers. There's a lot going on!

The drive from the association is a top to bottom structured approach to passive fire protection. If you get the design, the product testing, installation, and the inspection process well defined and with technical guidance and supporting qualifications in place then the life safety bar will inevitably be raised!

It's true to say that some problems still lay with the builders and there is guidance required in that space, but if we can get to a point



where the specification clearly defines that the design be carried out by a person with XX qualification, the products preferably sourced from an industry register, that the installation be carried out by an NZQA level 3 installer then things will improve for sure!

This year we will be targeting builders and others in the difficult coordination space surrounding passive fire protection. We have several "get it right" seminars coming up which we hope will be well attended by all investors industry.

FENZ have said that we need to adhere to the regulations in order to maintain the intent of the regulations in making the signage 'standout'.

Vocational Education Reform



Skills for industry

Competenz Key Messages

The government has released a plan to reform industry training – and this affects everyone who connects with Competenz.

Much of the media coverage about the Vocational Education Reform has focused on the plan to merge all 16 polytechnics, however industry training organisations (ITOs) would also be merged into a centralised national structure.

Under the proposals, ITOs would no longer arrange training or support the learning and assessment of apprentices and trainees in the workplace. The new national polytech would be responsible for delivering all training, including

on-the-job learning in the workplace and off-the-job learning in the classroom.

The ability for businesses and industry associations to influence and control how workplace training occurs and how it fits business needs may be reduced. The

proposed structure splits standard setting from arranging training, meaning training design and delivery would be disconnected.

It is unclear what the proposals mean for niche sectors that don't currently work with polytechnics and instead work directly with Competenz to design effective tailor-made training solutions. There is concern these specialised sectors have been overlooked.

It is also unclear who will be responsible for promoting apprenticeships and industry training to schools, supporting them with trade-related learning in the classroom, arranging and delivering the Gateway programme, and connecting with your industry.

There is no doubt some changes to the system are needed, and funding needs to be directed to where it is needed most to alleviate New Zealand's skills shortages.

But there is concern the government's proposal is trying to fix a part of the system that is not broken.

We have an opportunity to strengthen the system but these proposals suggest too much change, too quickly.

TIMEFRAME

There is a short window to have your say. A Competenz survey is open until Friday 1 March 2019. The information will be used to support its submission to the government.

All submissions to the proposed Vocational Education Reform close on 27 March.

The Importance of Flushing Sprinkler Systems

A sprinkler system is entirely dependent upon water. Pipe sizing, pipe bracketing, sprinkler head design, design densities, the obstruction rules and so on are all predicated on the basic assumption that the required volume of water is available at the sprinkler head. A clean water supply is imperative to the performance of the system and flushing is an important component of ensuring the supply is clean.

As fire contractors know new underground pipe has to be flushed at high volume for a period of time. The volume has to be sufficient to transport any foreign material that maybe lying in the bottom of the pipe. However this flushing doesn't just transport materials in the new pipe but maybe the first time a high volume has been pulled though the towns main; as a result it is not uncommon to drag old debris from the existing network.

One other point to note is the debris doesn't move through the pipe at the same speed as water travels. While you can calculate how long it takes the water from the start point to reach the other end of the pipe stones etc etc will tumble along at a much

slower speed. This slower transport time needs taken into account when deciding how long to flush a pipe for. Lastly, when discussing the need to flush the mains on a project make sure the civil contractor understands you are referring to high volume debris flushing; not chlorination flushing.

The flushing requirement was introduced into the standard when a Risk Engineer working for a broking house noted that there was loose gravel in a 300mm underground site main. An instruction was issued to flush the main, and this was

attempted by flushing through a 65mm stand-pipe. The velocity through the pipe would be obviously very low, in the order of less than 1m/s. An incident occurred on this site, and some 18 sprinklers were blocked by gravel. The details of this incident were conveyed to the Standards New Zealand Sprinkler Committee, who effectively copied the requirements from NFPA13.

I am aware that many a contractor will have been challenged on why flushing needs undertaken. Flushing can be quite disruptive especially as the total volume of water discharged can be significant and normally needs done when the head contractor is trying to construct the foundations. Recently we were flow testing some new fire hydrants on a project and had several very small stones eject from the flow meter, but the big stone was far more of a problem; see

> photo. Just imagine if the fire service had been using the hydrant to fight a real fire; their operations would have been somewhat impacted as the fire hydrant was almost completely blocked.

> Likewise it is quite common to find plastic swarf from the

pipe preparation of polyethylene pipes wrapped around the flow meter after we test fire sprinkler systems. This swarf is a very real concern as it will pass though the sprinkler pipe network until it gets blocked at tees and sprinkler heads. Once this plastic swarf enters a sprinkler system it will stay in the pipe forever.

While it is disruptive, proper flushing is a key part to the foundation of sprinkler system reliability.

Behind the Scenes of Fire Tests

Fire testing is a fickle and expensive business, and once a positive result has been achieved there is little incentive to test again. This in turn means that fire test data can sometimes be rather dated.

But one of life's certainties is change; things never stay quite the same. For example, gypsum is a natural resource and although supplied from the same mine, extraction location and depth inevitably change. Similarly, and despite careful control of incoming goods, additives may subtly change with time. On the other side of the equation fire test standards, furnaces, and data acquisition methods evolve. For instance, the main fire test facility in New Zealand recently converted furnaces from diesel to run on gas.

We must accept that 'creep' occurs and that subtle changes can combine to cause larger effects over time. With this in mind we have, over the last 2 to 3 years, invested heavily in a 'refresh' fire testing and development programme of work, which has culminated in the release of our new Specification and Installation Manual 'GIB® Fire Rated Systems, 2018'.
