Grenfell Tower Fire

We were of course deeply shocked and saddened to hear of the terrible turn of events in London. Obviously, our thoughts are with those who lost their lives, the families, and the wider London community. The loss of life from this tragedy is difficult to comprehend in this day and age. Given we work in the fire protection industry, many of us struggle to accept something of this nature happening. Many media agencies have approached us for comment, and our first media release about the tragedy appears on **page 2**. The association is also waiting for more details to come to light to see what lessons can be learned and how the findings can be used here in New Zealand.

Members' Meetings in Wellington and Christchurch

We will be conducting members' meetings and some SIG meetings in Wellington and Christchurch in the next few months. As previously, the meetings will include an FPA update and a speaker on a topic of interest.

Equipment Registers

The association has operated a fire alarm equipment register for many years, and this is available as a free download from our website. To go with this, we are also close to rolling out two new registers: the HOFFE equipment register and the passive products register. We are launching these to provide industry, councils, facility managers, business owners, and the general public with an easy way to see which product suppliers meet or exceed appropriate requirements, such as standards or testing. If the relevant requirements are not met, then products won't be listed. Our members have been asking for a way to differentiate themselves and their products from lesser products that don't meet relevant standards, and members of the public and many agencies often contact our association asking for recommendations. These registers will be an easy way to raise the profile of companies that list their products. Expect the registers to start coming online in the next few weeks; if you have products to list, get in contact with us, and we will advise you of the process.

Membership Renewal

With the new membership year starting on 1 July 2017, now is the time to review your company's details. We have recently been collecting updated information, which will flow through onto our website in the coming weeks. If the size of your company has changed, please let us know before renewing your membership. Remember, membership tier status is based on your staff levels, so it is important to see where your company fits in and whether you need to increase your tier status if you have added new staff.

Grenfell Tower tragedy less likely in New Zealand

The Fire Protection Association (FPA) of New Zealand and its members were deeply saddened by the tragic events that recently unfolded at the Grenfell Tower apartment complex in London.

We wish to express our deepest sympathy and condolences to the victims' families, and the wider community, while also acknowledging the valiant efforts of the firefighters and other emergency service workers at the scene.

Initial media reports suggest a lack of sprinklers, inadequate fire detection and alarm systems, and insufficient passive fire-stopping in the Grenfell Tower.

FPA New Zealand strongly believes that the correct mix of sprinkler systems, fire and smoke detection, evacuation alarm systems, fire extinguishers, hose reels, and passive fire/smoke protection installed and maintained by competent fire protection professionals is critical to life safety in any building.

A similar building in New Zealand would almost certainly be sprinkler protected and most likely also fitted with smoke detectors, evacuation alarm systems, and passive fire-stop and smoke-stop protection as required by the New Zealand Building Code and local Standards. Such fire protection systems would also be subject to regular mandatory inspection and testing under the Building Warrant of Fitness (BWOF) system.

New Zealand's fire protection codes and regulatory framework are among the most rigorous in the world, refocussed in recent years around life safety. Even so, we are continuously looking for ways to improve them.

The Fire Protection Association of New Zealand and its members await the outcome of investigations into this tragedy. We will ensure that any applicable findings will be used to improve NZ's practices even further in the protection of life and property from the impact of fire.

We are in regular contact with partner associations and affiliated bodies globally. As updated information comes to hand we will communicate this as appropriate.

Fire Protection Shutdowns

A recent fire in a 21 storey building in the Auckland CBD has highlighted the deleterious effect that fire protection shutdowns can have.

What should have been a relatively simple exercise for the New Zealand Fire Service (NZFS), to shift water to the top of building, became quite complex as the NZFS had to run hoses up the stairwell, from the ground floor to the roof; refer http://www.stuff.co.nz/auckland/92738665/ Fire-in-central-Auckland-high-rise-building

Aon encourages fire contractors and construction companies to keep fire sprinkler systems and fire hydrant systems online as much as possible. This includes through the construction and demolition phases as well as during building alterations.

With reference to Part 11 of NZS4541:2013, sprinkler system shutdowns require the permission of the building owner and notification to the NZFS or their monitoring agent. Likewise, NZS4510:2008 requires the permission of the owner and notification to the NZFS. What is not mentioned in either of these documents is whether or not the local building authority should also be informed in the event of a significant shutdown. It could be argued that a significant shutdown has a material effect on the buildings compliance with the New Zealand Building Code and the basis of the original Certificate of Compliance.

Isolations need to be kept to a minimum. For example, sectional isolation valves should be utilised, rather than decommissioning a whole sprinkler system. Aon is aware of construction companies requesting whole floors be isolated during fit out work, even if the sprinkler system is not being altered. This is not prudent practice, especially given that the nature of construction work increases the probability of a fire.

Both NZS4541 and NZS4512- have requirements for sectional isolation tags or labels to be provided at the control valves or panel. This was incorporated into these standards following litigation that resulted after a fire occurred in a partially isolated installation which had not been reinstated after the construction project was completed.

There is a requirement in NZS4510 to progressively commission the fire hydrant system as it advances up the building (there is no similar requirement in NZS4541). Aon is supportive of contractors who wish to progressively commission a fire sprinkler system. Progressive commissioning of the fire hydrant and fire

sprinkler systems aids the NZFS in the event of a fire, probably reduces the damage and increases the onsite safety of the construction workforce.

With respect to the fire described in the Stuff article referred to above, NZS4510 does not allow the riser system to be decommissioned until the contents of the building are removed.

It is beyond the scope of this article to discuss legal ramifications in the event of a financial loss, or loss of life, from a fire during construction. However, given the breadth of interpretation that can be applied to health and safety legislation and the wide nature of the tort of negligence, Aon cautions fire contractors to be very vigilant before carrying out significant system isolations and, if in doubt, to seek their own legal advice.

Finally, it is important to remember that those decommissioning parts of a fire protection system for significant periods need to be aware that any decommissioning could be deemed to be a material fact by the insurers of the building and its contents. When decommissioning a fire protection system you should therefore always notify the relevant insurance broker and/or insurance company to avoid any potential non-disclosure issues. Failure to follow the correct isolation

procedure could result in claims issues and potential litigation should an untoward event occur.

The key message Aon wishes to convey is fire contractors need to carefully consider the basis for every shut down and actively question if shut downs purely for convenience are actually justified, as the risk, safety and legal implications can be significant.

Contractors SIG Update

There has been some progress this year with regards to the FPA delivering to this SIG some meaningful initiatives. It was pleasing to see more participation from members this last meeting. Please feel welcome to contribute by phone, email if and where not able to attend our meetings.

The Fire Training Container Project

A transportable Sprinkler / Alarm training facility. Having done some initial work on this with respect to concept design, budget and deliverability of the item.

A budget was put forward to the FPA Board. the board is supportive of the concept, though requested further information with respect to cost, logistics, and utilisation. Having now thoroughly reviewed the issues, the SIG have decided to put on hold this initiative as it is felt the FIRE-101 industry entry training level initiative is more readily deliverable at this time.

FIRE-101 industry entry training:

This is aimed at new entrants to the industry. Possibly school leavers or those starting their careers in the fire industry. Initially, for end of 2017 a pilot scheme in Auckland. The aim of the course is to provide trainees a broad exposure to our industry sectors, ie Sprinkler, Alarm, Evac, Passive, Potable, Fire fighting, and fire engineering. The course is expected to be full time running for approx 4-6 weeks. Trainees upon completion of the course will be awarded an FPANZ certification. Trainees will be monitored and encouraged to progress further into a specific sector of our industry. The FPA hope to make available a pathway for FIRE-101 certified trainees to forge a career with FPA members.

FPA is now administrating the listing of Sprinkler Contractors.

The FPA member list is published on our web site and newsletter. Given this responsibility, this SIG has outlined our member concerns with respect to listing criteria being strictly administered. Poorly quantified applications will not be accepted as it is the FPA responsibility to maintain records of adequacy, and justify where required, listing or non listing of sprinkler contractors.

To ensure your organisation is appropriately listed, contact the FPA. We recommend you apply for relisting at least two month prior to renewal date.

Changes to NZS4541 (Fire Sprinkler System)

In light of upcoming changes. It is the intent of this SIG to provide our members better representation and interaction on the new standards committee. Kiran Soma has been appointed the Sprinkler Contractors representative on the standards committee. The mandate of the SIG delegate is to inform, and provide a conduit to and from SIG contractors. Streamline and ratify proposed changes prior to the public comment stage. Some work was done last year with respect to this. This SIG will be resuming this initiative. Thank you to those who registered their interest to represent the FPA SIG on the standards committee.

Changes to NZS4512 (Fire Alarm Systems, EWS)

This standard is in need for update. Unlike the sprinkler standard the funding is not readily available. On that basis the FPA has put forward a funding model which all parties appear to agree upon. Implementation of this funding model is expected to be in place by end of July 2017. A future update will be provided. Of major concern is that given the last update was 2010, new technology is now available, though technically not able to be implemented. Clarification from Standards NZ has been sought, though at this stage no guidance has been received.

Evacuation Consultants SIG Update

The presentations around Intelligent Emergency Lighting and Human Behaviour during Evacuation were both well received. Ruggiero Lovreglio delivered a very informative presentation which provoked many conversations amongst the Architects, Fire Engineers, Fire Risk Officers, Technicians and Evacuation Consultants who chose to attend. It was fantastic to see so many people involved in design and evacuation working together.

It is likely that Ruggiero will continue to work with us, and have an input to the Evacuation SIG, this will be valuable especially with Evacuation of High Rise Buildings, and the pending review of the Evacuation Regulations high on our agenda.

The NZFS Fire Information Unit is gearing up for the transition to Fire and Emergency New Zealand (FENZ)

from 1 July. There won't be any immediate impact on evacuation scheme regulations or processes, although a formal review of the Fire Safety and Evacuation of Buildings Regulations 2006 is expected to kick off shortly afterwards. The FENZ transition is also expected to bring new and different work from across the organisation into the FIU which will increase their workloads and may lead to slightly longer turnaround times for evacuation schemes, although still well within the 20 day regulatory timeframe.

Passive Fire Protection SIG Update

Rules are Rules!!!

This month's article relates to the ongoing confusion some parties have regarding exactly what standards are acceptable when it comes to compliance to acceptable solutions within the NZ building code.

- If the building being protected is a *new* build the building code is quite clear. All penetration seals must be assessed to AS 4072.1-2005 - no exceptions!
- If the building is an upgrade AS 4072.1 should be the standard requested in the first instance. But if there are no systems available assessed to that standard we then need to consider other international tested systems such as EN 1366 or BS 476 parts 22 to arrive at a system that will provide the necessary passive fire protection.

One of the challenges we have in New Zealand is that we are a very small market when it comes to passive fire protection. The largest markets in the world are Europe and the USA - which follow the EN and ASTM standards.


We follow the AS standard - which in many instances is very close to the EN standard - so many products in the NZ market that are AS 4072.1 compliant were born out of EN testing.

ASTM testing is very different to AS or EN - so cant be assessed to AS 4072.1-2005 easily!

This, however, doesn't mean EN 1366 - by default - now becomes an acceptable test standard in our country. The manufacturer or supplier must still have the EN tested system assessed to AS 4072.1-2005 to be building code compliant.

This might sound great news that our small market can benefit for the many systems already tested in Europe, sadly not!

New Zealand not only suffers because it is small in size - so



For instance, in most parts of the world they build 60-minute fire rated walls, using two layers of 12.5 or 13mm plasterboard. It is common in New Zealand to build with just one!

Many insulate fire walls internationally use stonewool, but this is not common here in New Zealand! This dramatically reduces the number of EN tested systems available for assessment over to AS 4072.1-2005!

Builders and designers need to ensure that whatever system is being installed, it is assessed to AS 4072.1 -2005 and installed as per the test document.

Most of the problems we see on-site are due to builders having to go back over the project and adjust opening sizes, number of services passing through the fire seal, or in some cases - replacing the product due to the lack of AS 4072.1 - 2005 supporting test data!

With the launch of the FPANZ Passive Product Register just weeks away, this will help to locate the correct code compliant product, identify how it was tested and installed - leading to more cost effective passive fire protection in New Zealand!

Training SIG Update

Kia ora koutou,

The training SIG had our third meeting on 10th June. A lot of research had been done between the 2nd and 3rd meetings. There were 3 main items that were brought to this meeting from that research:

- 1. I was invited to a meeting with E2E (Education 2 Employment) Engineering which is a part of the Tertiary Education Commission. They are tasked to increase the number of engineers in the county by 500 people each year. They have achieved this last year but they are over subscribed in the degree level and above. They are not achieving the required numbers in the Engineering Technician level. We explained that we had a lot of people in this space in the fire industry but they either had no formal engineering qualifications or related qualifications, however they had a vast amount of industry knowledge. we discussed the multiple reasons as to why a qualification for this group of people was essential and they agreed. From their point they are wanting to push for a Diploma in Engineering - Fire Engineering. The target audience initially would be those already in the field but with no qualifications. Areas such as IQP's, Building Officials, Fire Systems Designers, Fire Engineering Technicians and Fire Risk Management Officers. We are now following up the possibility of developing such a course with potential Institutes of Technologies.
- 2. The second meeting was with the Ministry of Social Development which Scott had. This was to discuss the possibility of assisting school leavers/unemployed persons to find work in the fire industry. This may seem an easy task for the Ministry as we do have a shortage of people in the fire industry but we do want quality people though. In order for the this to be of any benefit to us those people would require some initial training and an introduction to the industry. This would tie in with the work that we were planning for with the schools pathway projects.
- 3. Lastly Michael James and I, along with many others in the industry, were part of a survey carried out in 2015/2016 about the Construction and Infrastructure industry in New Zealand. The focus was on how the New Zealand construction and infrastructure industry is labour intensive and is dependent on the availability of skilled labour to meet demand and maintain quality. Therefore, it is critical that careers in these industries are identifiable and attractive to job seekers. It was identified that, while there are multiple entry points to the industry, there was no overarching plan or map detailing the range of roles or the career pathways throughout the industry. As you can see from there work it is a mirror of the fire industry which was a sub group of this work. So it is up to us to change this to make it an attractable career pathway.

The above was brought to the meeting and discussed at length. The outcome from the meeting was that we not have 2 goals. One short term and one medium and one term goal. They are the as follows:

Short Term Goal

To develop an introduction to the Fire Industry program. This will be a short course possibly 1 or 2 days where people are given a brief insight into what the fire industry is and where it could lead you in the various fields. This will be then followed by a 'Fire 101' course which will be a more detailed course on basic fire knowledge and touch on more detail of what each discipline in the fire industry does and has some practical aspect of it too. It will also include some health and safety training. This could be anywhere from 4-6 weeks. This will hopefully eliminate those that are not interested and also identify those that are keen but could benefit from some additional learning prior to taking on an apprenticeship possibly. Following that course we will hold an interview day where our members can then interview those that successfully passed the course and hopefully offer them employment.

This will be then promoted as part of our careers day at FireNZ with the introduction course to follow shortly afterwards. We would then like to start the 4-6 week course in early November so that the interviews could be had prior to Christmas with start dates in the New Year as an example. For this to be successful we need the support of industry and members to help with employment opportunities and also to provide information to your SIG chairs or me as to what you would like to see in our 4-6 week course.

Medium Term Goal

To develop a Diploma in Engineering - Fire Engineering. There are courses overseas already and some of the subjects are currently are been covered in NZ under NZQA but in other courses. This could realistically be developed with in a year ready for deployment to those already in the industry.

Long Term Goal

To be part of the Ministry of Education Pathways program in schools. In order to be part of this we must have a recognised pathway with a developed course of progression from school leaver through to Masters. We already have through Competenz some Level 3 and 4 certificate courses and we will assist them in developing some core subjects to get a Level 4 in Fire Science. Once the Diploma is completed we will then have industry

bench marks for entry into different level of the fire industry and thus creating a defined pathway. Hopefully then we can sign up for the Pathways program. Details on this though are still being worked through.

Our 3 meetings to date have been very constructive and as you can see we have now developed some goals and which I believe are very achievable. With your support I think we can get them across the line. **Ki te kahore he whakakitenga ka ngaro te iwi** Without foresight or vision the people will be lost Nga mihi,

Calling all Halon Fire Extinguisher Owners

FPANZ is promoting awareness around Halon fire extinguishers and wants to recover these from the commercial sector and from private owners.

Halon has fallen out of favour due to its environmental impact and long atmospheric life time. It is considered to be a potent greenhouse gas and contributes to ozone depletion. However, safety is the main issue as servicing of Halon extinguishers has not been available since 1998 when the production of Halon was banned under the Montreal Protocol.

Over the previous ten years, more than 60 tonne of Halon has been recovered by FPANZ members and this was sent for safe destruction. It is estimated that a further five to ten tonne is still in use. This needs to be recovered now as any unit still in use will be well over ten years old and will not have been serviced.

"Fire extinguishers, just like smoke detectors, need to be checked by a certified agent annually" says Blind

"We do have fears that Halon extinguishers, due to this lack of servicing, may fail to operate correctly in the event of a fire. We are prompting all members of the public to check their boats, cars, workshops, caravans and planes to see if they still have a yellow Halon extinguisher and to exchange this for a unit coloured red". "There will be a cost to change, however both the public and the environment will benefit as we can be sure new systems will operate correctly in event of a fire and the impact on the ozone layer will also be reduced" says Blind.



There are now many suitable and cleaner alternatives available and FPANZ members located nationwide will accept Halon units and provide information on the safer alternatives available. Halon extinguishers are easy to identify as they are bright yellow. Replacement units will be coloured red.

"We look forward to gathering as many of the remaining Halon systems and hand held fire extinguishers here in New Zealand and to have the contents safely destroyed" says Blind.

"We will also have greater confidence that owners will be protected in the event of a fire and this will ultimately protect lives".

Our message is: "Be Safe Yellow is Out - Red is In!"

Yellow extinguishers, Halon extinguishers, are so old – if you have one, the chances are they will let you or your family down in a fire.

Halon damages the ozone layer which in turn can affect our health, causing skin cancer, cataracts and other illness as well. Damaging the ozone layer can also impact on our weather, our soil and our crops.

Protect yourself, your family or business, by handing in your old yellow extinguisher. It's easy to do – simply take it to the nearest local approved Fire Extinguisher Service Agent. A list can be found at www.fireprotection.org.nz



While there, talk to these experts about your needs and how best to protect against fire, including alternatives such as a red fire extinguisher*, a fire blanket, a smoke alarm, and other effective choices. Often a combination is the best approach.

So act now and hand in your old yellow extinguisher. It's a service for the general public and small businesses. A small recovery charge will be set at \$10 per kilogram (up to a maximum extinguisher weight of 2.1 kg in size). A Halon extinguisher larger than 2.1kg is considered a commercial size and will be disposed of at a quoted rate.

*There is more than one type of red fire extinguisher on the market. Ask which one best suits your needs.
