Instead, it takes a much more structured approach, including a full support and mentoring network aiming to bring the next generation of leaders into the construction sector.

Like many construction trades, the fire protection industry has been suffering a shortage of skilled workers for a number of years. In my time with the FPA I have been exploring and working on a number of initiatives that could help our industry overcome these shortages. These have included working with FPAA and Competenz to update qualifications and assist in updating training material, working on options for training facilities, and creating career days to improve awareness of the range of jobs available. So this latest opportunity is timely and well worth the support of the FPA and its membership. So far, we have agreed to explore how we can support this programme from within our associated contacts and our membership base. As an industry representative, I feel strongly that we need to support this type of initiative,

so I ask that you contact me directly if you would like to offer your assistance to this programme. I will also be contacting some of you in coming months to explore what areas would best be able to support it.

I look forward to working with Hawkins and their existing sponsors and supporters of the mentoring programme to ensure our industry is part of the solution. Helping Māori and Pasifika youth find a meaningful place in the construction industry will also help address some of the skills shortages we have been facing.

### Membership Benefits Update

I am always mindful that we need to provide additional value for members while delivering the daily functions our members, industry and the wider community expect. ## Passive Tip of the Month

### Is your documentation up for scrutiny?

Due to the litigious world we live in, there are more claims happening on a regular basis due to non-compliant and poorly built buildings. For many in the building industry they don't realise that they are potentially liable up to 10 years.

In addition to builders the others are also being caught up in such claims: designers, peer reviewer's, consultants, engineers, fire engineers, suppliers, trades and Councils. As an expert witness I am personally involved in some claims and I can assure you that it is not a pleasant experience particularly if you are a defendant. Likewise it is not a great experience for building owners as they have been short changed and can face years of litigation with uncertainly.

What is one important thing I learnt so far from the such claims and how could you help yourself for the future. Even if you have done everything right it does not stop you from being sued ! However this advice will assist!

### A Great Paperwork Trail !

While I am focusing on Passive Fire Protection, the advice applies to other disciplines. Apart from making sure you have the correct insurance ( refer to broker for advice ) I cannot overstate the importance of good paperwork which starts with your quote, terms of agreement and acceptance. The acceptance needs to include the fire report and preferably drawing references and specification(s). Once this is agreed, only use

tested systems as per the consented documentation. If for any genuine reason it is not possible to install a tested system as per the consent, then you need to; agree with such parties as Council, Fire Engineer, Passive Specialist the alternative solution (see previous newsletters) and DOCUMENT the changes and all related correspondence. For major variations a minor consent may be required which Council will advise.

On the basis that the passive systems have been installed correctly, make sure you provide a schedule of each penetration / work completed noting the applicable room / area and system used. In addition to the list TAKE PHOTOGRAPHS of the completed work with the date mode switched on your camera. The photographs can come in useful as they will clarify if any future unauthorised penetrations that have been installed through the work you completed. PS3- When it comes to signing the PS3 make sure you include all your paperwork and photos as one document, don't just send the PS3.

The above of course is based on the work being installed correctly as all the best paperwork in the world and photos won't stop some potential intrusive testing in later years proving there was only a smear of sealant applied!



### Fail of the Month

I suspect for the fire rated damper there was a hole in the wall and the contractor decided to use PU Fire Rated Foam to fill the gap. They obviously did not realise the expansion rate of PU Foam. More disturbing is that they left it as it was on a new build!

The other photo also demonstrates total lack of knowledge of what PU Fire Rated Foam is tested for and incompetence by the contractor.

## Inspectorate SIG Update

### Drain testing requirements.

The requirement to conduct a 50mm drain test is sometimes misunderstood by installing companies and testers. The purpose of the test is to crudely confirm that the water supply is performing at a level approximately equal to that obtained during the commissioning flow test. There is no need for the drain test to pass excessive flow rates on systems with lower flow requirements.

Clause 404.8.3 allows the drain valve and pipe to be sized to pass the highest design flow on ELH, OH1, OH2 and OH3 installations. This means a drain smaller than 50mm is permissible on these installations; in fact it may be desirable. Where an ELH installation has a strong water supply and 50mm test valve the volume passed by the 50mm drain is far far greater than the few hundred litres per minute that the ELH design requires and proves very little. For example the installation may require no more than 270 lpm yet the 50mm drain will pass upwards of 2000 lpm; as the system flow test will only be to maybe 500 lpm the 50mm reference pressure is meaningless. On older installations it was common to find test/drain valves like in the photo with the 25mm path being used



for quarterly testing and the 50mm drain being used for system drain down.

Additionally by sizing the drain valve to pass slightly more than the system demand the problems of flooding valve rooms during quarterly testing is reduced. It is recommended that after installing a smaller test valve the pipe is stepped back up to 50mm as this reduces the jet effect where the drain pipe terminates.

Please note OH3S, OH4 and EHH installations must be fitted with a 50mm test drain.

### Evacuation Consultants Group Update

*Greetings Evacuation Consultants, I trust all is well with you.*

For those of you that attend I trust the technical session at our EVAC meeting has been a treat and stimulating while offering valuable insight. For those of you that missed this opportunity to hear Todd O' Donoghue's from the NZFS speaking on "Evacuation gone right and evacuation gone wrong" I offer a synopsis of some pivotal insights shared from his rich repertoire.

I like to take the opportunity to thank Todd on behalf of the EVAC SIG for his contribution to our professional development program.

Perhaps the issues presented are not new, however as a reoccurring theme in the matter of real fire emergency requiring evacuation these demanding our attention and are summed up as:

- Evacuation procedure matters!- determining outcomes for the better or the worse
- Tailored building evacuation procedure and training of relevant persons is the fundamental pathway to equip people and avoid situations were 'every body fend for themself'
- Execution of well managed 'orderly' evacuation and crowd control, depends largely on the level of competency of relevant persons nominated to manage evacuations
- Adhere compliance - fire and building for example in regards to means of escape is vital
- Evacuation can become challenging in community housing, depending on the level of disability and staff availability, in complex buildings, large crowd environments, overcrowding etc.

- 111 calls are important and the ability to communicate in a clear, understandable and concise manner saves valuable time
- Liaison and communication between professionals managing elements of the fire protection system for a building, is a must, to avoid a collapse of the lifesaving systems and exposing occupants and first responders unnecessarily to risk
- Fire and smoke movement/speed behavior differs - environments and building structure for example - low versus high ceilings influence evacuation routes and must be taken into consideration
- Good house keeping practice and a keen eye to minimise the risk of fire and loss of life makes a difference.

For those Evacuation Consultants that have wanted to see our profession been represented at Fire NZ FPANZ has now added a 4 stream - a couch session featuring EVAC Consultants Jenny Maxwell, Ela Langford, Jason King Fire engineer, Alby Yap Architect, Bastien Ballu to communicate on the impact of involving EVAC at the conceptual stage. This information will be communicated in form of an insert to the NZ Fire Brochure and a mail out to all EVAC Consultants. I truly encourage you take up this wonderful opportunity.

In closing please be reminded to nominate a chair for the coming year and take up the opportunity of the last EVAC meeting for this year in December.

Hello to the HOFFE members October update below.

### Major milestones met with HOFFE survey

Todd ODonoghue, National Advisor Fire Risk Manager has confirmed the progress of this project, we encourage all members to download and read the report. The link can be found on both the New Zealand Fire Service and FPANZ web site. Todd has confirmed the NZFS have now completed all the notifications and sign off we had to achieve to get the HOFFE report publically available. The critical next stage is how we use this information to educate and change behaviour FPANZ will be working with NZFS, MBIE, Property Managers, FPANZ Members & Insurance. Todd has initiated a work group including involvement of all of the above stake holders to meet in October we will keep you informed once we have had this initial meeting.

### Worksafe, CTLA, FPANZ meeting

The SIG group have initiated a meeting with Worksafe and CTLA (Cylinder testing laboratory association) in September and will work through the common issues both parties have. All parties agreed there needs to be more communication we will have a follow up meeting in October to update progress on the points discussed, CO2 valve and cylinder compliance issues there were a number of action points agreed.

### HOFFE Code of Practise & NZS4503

Code of Practice can be sent out for review by members if required. Lance to hear questions from council at next meeting. Equipment register could be used to provide funding for future updates to the standard. The cost to update standard is between \$100-\$200K. No mechanism in place currently to get funding. Should we amend or rewrite as this effects cost??

### HOFFE Special Interest Group nominations

SIG Chair positions- no formal process so looking to offer open nominations, but voting only to be done by SIG members. Transparent process. Chairman voted every 2 years and can stand for 2 terms. Invite nominations in next newsletter and voting will be electronically or at the next meeting in December.

### Halon Update

Programme has been extended. One more shipment out this year and perhaps next year. Advertise the fact in the next newsletter. Can FPANZ issue certificate once we receive the cylinders for the customers? Answer is yes. Receipt only issued once it has been destroyed. Extended until June 2017 still \$43.50 per kilo if a large volume discuss price with Scott Lawson, transportation and collection is unchanged and included in destruction cost.

### Commerce Commission & Aero Fire

Peter Simpson from the Commerce Commission and other body/s are helping to potentially stop the likes of AEROFIREs essentially predatory behaviour on what is almost every time, immigrant businesses being targeted by this group. Cases are being investigated. Peter from Commerce Commission to attend our next meeting so have any cases ready (a hand out was supplied to every member). Misleading people and on selling cylinders removed from other customers premises.

# Bulgin Key Switch Replacement Programme

"Bulgin 6083/C patterned key" switches have been specified for many years in NZS 4512 for Fire Brigade controls (Evacuation, Silence Alarms). Prior to that, they were a long-standing *de-facto* standard for Fire Evacuation controls.

Such key switches are mandatory on fire alarm control units, and are also required on any other systems (sprinkler FBAs, for example) which can actuate the fire alarm system alerting devices.

Late in 2014, the UK-based manufacturer of these switches announced their discontinuation, and fire alarm manufacturers for the New Zealand market were required to hastily place final orders. The hunt was then on for a suitable replacement, with the looming possibility of a different key altogether being required – the Standard needing to be changed, and technicians and fire fighters all having to carry two different keys – far from ideal.

To cut a long story short, after heading down a few blind alleys, it was found possible for a modern barrel-style key switch to be adapted by custom tooling to accept the

historical "Bulgin" patterned key. This approach preserves the status quo with keys, and also avoids any need to alter NZS 4512.

Following an open invitation, four parties agreed to share the capital cost of tooling: Ampac, Bensan, Pertronic, and Tyco. Others will be able to purchase key switches from any of these four "tooling consortium" members.

The new switches are expected to be available in November 2016 in both key-removable and key-captive versions. It should be noted that their physical design and mounting is different, and that they are single pole changeover, which will require adjustments by manufacturers to both metalwork and wiring arrangements. They are also longer than the old switches.

While this "good news" story was a joint project, both FPANZ and the Fire Equipment Manufacturers' Association owe a special vote of thanks to David Percy for taking the lead in achieving a practical resolution to what might otherwise have become a major problem.

Introduction by **Scott Lawson**, Article supplied by **Argus Fire Protection Service Ltd**

*With the challenges our industry has been facing in recent years finding sufficient numbers of skilled staff I enjoyed a discussion a few months back with Jacqui Bensemann of Argus Fire Protection Service Ltd. I was interested to hear how they had decided to explore a different option to the recruitment process that took them offshore.*

*As you can read below in more detail the approach embarked on by Argus Fire Protection Service Ltd and also now a bit of an update on how the process went and how some of the new staff have settled into to life in New Zealand.*

In October 2015, Argus Fire Systems Service Ltd. Managing Director, Jacqui Bensemann and General Manager Northern, Bryce Donaldson embarked on an international recruitment trip to the Philippines. Working with the Philippine Overseas Employment Administration (POEA), the objective of the trip was to meet with, and interview, potential Argus team members who are technically qualified to work successfully within our industry. The POEA engages with employers in both New Zealand and Australia to develop partnerships with organisations that can serve as vessels for ethical, international recruitment in industries where a skill shortage may exist.

During the visit, Jacqui and Bryce interviewed 37 candidates and Argus has since employed a number of new team members who took on the roles of Testers, Surveyors, Technicians and Fitters. This visit has also provided first-hand knowledge, and an understanding, on the Filipino way of life and work ethic. It has been more than six months since Argus' new team members joined their respective business units, and as part of keeping their team informed, Argus interviewed a number of Filipino team members to understand how their experience has been so far.

## Herbert

Herbert N. Forbes came to New Zealand from Calaguiman in the province of Bataan, Philippines and currently resides in Pakuranga, Auckland. Herbert's partner Joy, and little ones Ronin and Justine, are based in the Philippines where Joy currently takes care of a small family business - a purified water refilling station and an internet café. Since coming to New Zealand, Herbert says he has already fallen in love with the country and considers it as his second home. "I'm planning to bring my family here in New Zealand and become a resident here since I find New Zealand a great place for my children to grow up in", says Herbert. When asked about his working experience with the Argus

Group so far, Herbert said *"Having friendly colleagues and managers, I can say that Argus is one of the best company that I have worked for"*. And the best, or most challenging thing about his job? He enjoys his job as a Tester where he gets to meet lots of customers and interact with them. Although this is a good thing, he also finds it challenging as he does not want to disappoint them.

### Luis

Luis A. Ortega came to New Zealand from Makati City in Manila, is married and the proud father of four sons. Luis says living in New Zealand has been good so far. *"There is a good climate here, unlike in our place in Philippines. It's too hot during summer season. Besides it has congested roads due to lot of cars and vehicles for transportation in my country"*. What he finds hardest in his adopted home country is familiarisation with the roads and different cities. He found that Kiwis are very disciplined and enjoys the peace, cleanliness and green pasture environment – with no pollution – a bonus of living here. When asked about his working experience with the Argus Group so far, Luis said *"So far it's ok, and the work assignments and the projects are going smooth"*. And the best, or most challenging thing about his job? Luis believes that he and his colleagues are doing well on their job assignments, and they work well as a team to get the jobs assigned to them, done. The hardest thing – a very confident *"Hardest thing...none!"*

Jomer Monton came to New Zealand from Manila, and has been married for 20 years (and still counting) and is proud dad to three children. The toughest adjustments in New Zealand so far have been adjusting to the New Zealand culture and the cost of living. How does living in New Zealand compare to his home country? Jomer says *"A big adjustment with the climate, culture and way of living. The one thing in common is the natural beautiful scenery that anyone will really enjoy"*. Jomer sees working with Argus as a privilege - *"For the past five months I've been here in the company I'm grateful about the contribution of the company not only to the community but to the society it's really an honour to be part of this institution"* says Jomer. He sees the learning opportunities with Argus as the best thing about his job, despite some adjustment challenges he faces working in a new country. When asked about his long terms plans, Jomer said that he would really like to remain in New Zealand and become a permanent resident.

### Victoriano

Victoriano V. Galvez Jr. came to New Zealand from San Ildefonso in the province of Bulacan. Victor is married and has two young children. Victor feels that New Zealand is really an ideal and safe place to live - especially for a family man like himself. He says he *"I have been loving this country already and excited to share this living experience with my family. No evidence of pollution seen, the green sceneries are breath-taking. The people are well educated, shows respect, so polite and well-disciplined. Government rules are well implemented and I didn't feel any discrimination issues. Most of all, there's a lot of opportunities to grow"*. The most challenging aspect of being in New Zealand, Victor says, has been the adjustment period, and being so far away from his family. He is exploring many possibilities that will enable his family to reunite as soon as possible. To cope with this, he motivates himself to be strong, and focus on the better life that awaits his family. His long terms plans include a new life in New Zealand with his family, and seeing positive futures for his children. When asked about his working experience with the Argus Group, Victor said *"Working with Argus has been a challenging one, but a great feeling and everything is worth it. I'm really blessed to be part of the team, the experience and new learning is priceless. The overall management, staff and co-workers are indeed very supportive"*.

### Rey

Rey T. Borlagdan comes to New Zealand from Tabaco City in the Albay province and currently resides with a number of his Argus team members in Auckland. Rey is one of seven children and has four sisters and two brothers. Rey is engaged to April Rose Serrato, who he intends to marry soon. Even as a young boy, Rey heard good things about New Zealand, even that it was probably the coolest and safest place in the world. Other than being impressed by the friendly people, the structured and organised society, and the abundance of dairy stock and dairy product, the one thing that impressed him most is the snow. Rey is very happy to work for Argus and feels lucky that he has been giving this opportunity. He says that, compared to his previous jobs, he enjoys talking about what he does. *"The best thing of my current job as Tester is that you can go anywhere in Auckland city, you can talk to customers and also different people from different cultures who are all very friendly, and the other good thing is testing different firefighting systems"*.


