To start this off, we will be sending out some short surveys on specific topics and proposed projects to gather your views. We know there is uncertainty and that no-one has all the answers, but we see this as an important way to get a wide range of input from our membership base. These surveys will be limited to the primary contact for each member company to ensure we get fair input from each.

"Get It Right" Seminars

We are working on dates for the follow-up seminars and hope to email these out in the next few weeks. If you were enrolled in the seminars that were cancelled, we will contact you directly to confirm your booking. Given the current environment, we will have shorter lead-in times for seminars to try and minimize the possibility of having to change dates or – if we must change them - to allow us to rebook quickly. We might also place tighter controls on numbers at each event depending on the alert levels at the time. Some seminars might have a blended delivery method, with part online and part class based. We have plenty of content and topics that we want to cover, so we are focusing on making it work despite the ongoing uncertainty. We will also ensure our seminars offer alternative attendance and refund options should we be forced to postpone or cancel an event.

Standards updates

NZS4514 – Interconnected Smoke Alarms for Houses: Development of this standard has now concluded, and it is now open for public comment until Wednesday 7 October 2020. Find more on this on page 8.

NZS4512 – Fire Detection and Alarm Systems in Buildings: Development of this standard is in the final stages. Once this stage is complete, we will let you know when it opens for public comment.

NZS4510 – Fire Hydrant Systems for Buildings: Development will start in September 2020. FPANZ has two representatives on this committee: Nicky Marshall and Chris Mak. You can contact them directly or via **info@fpanz.org** if you want to submit comments about this revision.

NZS4503 – Hand Operated Fire-Fighting Equipment:

We are looking to scope the possibility of revising this standard; you can find more on this in the HOFFE update. Again, we welcome input from members on this standard, as it has not been revised for some 15 years.

The past year or so has seen great progress by FPANZ, the Fire Protection charitable trust, and our members in getting these important industry documents updated and kept relevant.

Competenz and Fees Free

It is really encouraging to note the increasing numbers of our members taking advantage of the fees-free programme on all fire qualifications while the option is available, and we will update these figures next month. Of interest is the surge in demand for the new passive installers level 3 qualification, and the numbers enrolled are really pleasing. There will never be a cheaper time to get your staff qualified with NZQA qualifications. Companies with qualified staff will also benefit from the ability to continue to train new staff or upskill existing staff. Formal NZQA qualifications are the foundation of the drive for a regulated fire protection industry, so we encourage you not to miss this opportunity.

Membership Update

Just over 90% of our members have already renewed their commitment to FPANZ for this current financial year, which is really pleasing. We have formalised the process and what is required to renew each year to ensure a more rigorous process and make sure all members are aware of their commitment to the code of ethics, insurance etc.



HOFFE SIG Update

Hi folks,

I trust you are all well and are getting back on top of your workloads! Unfortunately, we are still hearing of businesses that are downsizing, restructuring and closing branches - the flip side is that there are also more and more projects getting the green light and some of these are now underway, offering ongoing opportunities for our members. We have also now seen another Auckland based outbreak of COVID-19, as if it needed to remind us that it is still around! The situation is an evolving one where you almost need a crystal ball to know what's going to happen next! Although it is disruptive for all of us and hard on many businesses, we can take some comfort from the fact that when compared to what is happening in the international community we are still looking pretty good.

It has been pleasing to see that some of our members are generating active enquiries about accessing the free fire equipment industry training initiative that is currently available and has obvious benefits for the credibility of our fire equipment companies and the fire industry as a whole. Competenz have indicated to us that regardless of what happens with the restructuring of the industry training organizations, the NZQA qualifications gained now, and up until the changeover, will still be officially recognized in the future. They also informed us that for those people who are actively progressing (regularly completing unit standards as is normally required), their qualifications when the changeover with

Competenz occurs will still be officially recognised and they will be able to complete their qualifications.



Since our last HOFFE group meeting we have also had a constructive, well attended meeting with a good amount of dialogue to establish whether there was a will to progress the long talked about changes to NZS4503. This is a fundamentally important document for our industry, recently demonstrated when it was used by the Commerce Commission in its prosecution of Aero Fire It is also often used as a reference document for many pieces of legislation. Thankfully, most stakeholders have indicated their active support to progress this freshen up of the standard which is a "corner stone document" for our part of the industry and yet it is now 15 years old! The actual cost for this NZS4503 review is not yet known as the final cost will be dependent on the many factors including, but not limited to, the type and number of changes being undertaken. As ever we are exploring ways to help support and fund this exercise. While we aren't keen on holding BBQs outside the local hardware store we are open to all reasonable fundraising suggestions?

Evacuation Consultants SIG Update



We have recently seen the country move from Level 1 back up the scale to a more controlled environment. Fluctuation between levels is likely to continue for several months. Should we be routinely considering social distancing when we run fire drills? There have been several events reported by the media where a building wide evacuation has been triggered. If we train our occupants as part of the drill, this will improve our response and lessen the risk. One of the considerations will be the additional space that will be required at the assembly area due to social distancing.

Passive Fire Protection SIG Update

Tested Vs Assessed:

With the current codes of practice and Passive products annual renewal being worked through the issue of Tested vs Assessed is constantly brought up in conversation.

NZBC accepts the use of AS4072.1 Assessments as a way of showing compliance as an equal with a tested solution in accordance with AS1530.4.

However there are fundamental differences between a Tested detail and an Assessed detail. In its simplest form an AS4072.1 Assessment is a calculated guess at best.

In a recent conversation with my P.I insurer the conversation regarding selection of Assessed products was raised as to where liability starts and stops with such scenarios. Their advice to me was if I have even an inclining of doubt then stay away, that is my professional duty to protect myself and my clients and their building occupants. This was a statement that doesn't sit comfortably with me as a business operator.

As Contractors, Installers, Specifiers, Engineers, Distributors, Manufacturers, IQP, Third party inspectors we should have a sufficient level of knowledge to be able to identify any gaps. But we also need to have a level of trust in the standards and the authorities certifying these assessments.

The intent of AS4072.1 is to provide the minimum requirements for application of fire resistant products and provide tolerances for assessment of products and scenarios with the obvious outcome being that it allows for reducing costs for commissioning fire tests whilst also providing a level of confidence.

There is detailed content on what can and can't be assessed and what the assessment should consider. Details must be included such as; validity period, full scale test evidence assessment is based upon. There are details of maximum tolerances for assessment scope for example:

- varying cable sheathings can be assessed (4.5)
- In differing plastic pipes can be assessed provided the max previously tested comparison is not greater than 120mm or smaller than 40mm (4.6.4)

and for multiple penetration systems the unit can not be assessed any larger than the device that has been tested in a 3m x 3m furnace (4.9.1).

Even as detailed as AS4072.1 has been written it is still not a perfect document. As stated by Niall Rowan the CEO of ASFP in his presentation at FireNZ 2018 "you can drive a bus through the middle of Assessment standards".

The attraction for Manufacturers and industry to use Assessments is obvious – it is commercially more palatable to do so. However, this comes with a great risk. This risk has been highlighted in the most tragic and devastating circumstances when we look at cladding and the Grenfell Fire. Implications from this locally have had many ACP claddings that were previously assessed removed from distribution and the entire Codemark system called into question.

A critical recommendation from the Dame Judith Hackitt report into Building regulations in the UK following Grenfell was "More effective product testing & regulation".

AS4072.1 was last reviewed in 2016 and reconfirmed. Even in the short 4 years since this was reviewed a lot has changed in our industry (not least of which was Grenfell tragedy in the UK and the determination for the Lacrosse Fire in Australia).

Whilst I understand the need for AS4072.1 assessments within our building regulation framework I can't help but think it is time we had a discussion as to whether we need to curb the proliferation of Assessments in lieu of Testing.

I am writing to let you know about the work of the Manufacturing, Engineering and Logistics Workforce Development Council (WDC) interim Establishment Board (iEB).

The Manufacturing, Engineering and Logistics iEB was appointed in June 2020 to work with industry to establish the Manufacturing, Engineering and Logistics WDC as a legal entity. Where possible, the iEB will also work with transitional Industry Training Organisations, the New Zealand Institute of Skills and Technology (NZIST) and other providers to provide advice and guidance to inform tertiary education system responses to COVID-19 impacts.

WDCs will contribute to the vocational education and training system by:

- Providing skills and workforce leadership for the industries they represent. This includes identifying current and future needs and advocating for those needs to be met
- Providing vocational education investment advice to the Government
- Developing qualifications, setting standards, and moderating assessments
- Endorsing provider programmes
- Promoting the benefits of educating employees to employers.

The initial focus of the <u>iEB members</u> is establishing the new WDC as a legal entity. We are currently developing options for the governance and establishment of these new organisations.

We will need your support to ensure that the new WDC can provide the vision and influence that support your efforts to develop our workforce. We will be in contact in the future to gather your views on the options identified.

Updated Household Smoke Alarm Standard released for public comment

DZ 4514:2020 - Interconnected smoke alarms for houses

This standard provides a specification for the selection, installation, commissioning, and maintenance of interconnected smoke alarms in houses (single household units). This edition is a partial technical revision and supersedes NZS 4514:2009. Allowance has been made for long-life batteries and wirelessly interconnected smoke alarms.

Changes have been made for ceilings with exposed framing members. Testing requirements have been simplified.

The appendices have been edited and updated to provide more clarity and guidance on the selection and location of smoke alarms.



Over the last two weeks, we have seen the construction industry get in and do the right thing during these trying times. Particularly in Auckland, our people have quickly reverted to the procedures put in place to protect us all when chances of COVID-19 community transmission are higher.

The recent cluster outbreak has reminded us just how quickly this disease can spread and that we can't drop our guard. It is also a timely reminder that we can't get complacent about our Covid-19 health and safety controls either. We need the whole industry to pull together and do the right thing to maintain public and government confidence in our ability to work safely during these heightened risk levels.

The Alert level protocols and tools and resources, developed by our industry and available on www.chasnz.org/covid19, provide a standard way of managing COVID-19 in our construction related businesses. The establishment of these protocols were a key part of getting Government support for our industry to work at Alert Level 3.

We know that most businesses have been doing a good job in applying the protocols but we are aware that it is a constant challenge to maintain them over time, especially if workers see other businesses or even members of the public not applying a similar high standard.

To better help construction businesses understand and apply the protocols, we have developed some simple check sheets that you can use on site or when going to a workplace. These will help you to be confident you are doing the right thing.

You can use these check sheets when explaining how you are controlled COVID-19 to clients, visitors, building inspectors or even WorkSafe. They do not replace the protocols but help make it easier to check you are doing it right every day.

We have also had questions from clients around what they should be expecting from their builder or tradesperson. We have developed this one-page guide for clients you can use when asked questions about COVID-19 and what controls should be in place.
