Fires in lodge-style accommodation have made the headlines in the past month, with two in the space of just two weeks in Auckland. It is concerning and a reminder that, as an industry, we must make sure we are doing the best we can to ensure building safety. There is increasing scrutiny of the independent qualified person (IQP) space and on the testing, servicing, and maintenance of fire protection systems in buildings. This is a timely reminder to ensure you and your staff are completing all required works and that correct documentation is being collected and filed. It is also worth noting that, as mentioned in previous updates, there will be more investigation into training of staff and continued professional development (CPD), so now is a great time to ensure you can show that your staff are compliant and keeping up with current developments.

#### **City Garden Apartments**

Another significant headline this month has been the widespread publicity regarding the City Garden Apartments in Albert St, Auckland, which underscores the critical importance of diligent fire safety management in our industry.

On Wednesday 17 April, the residents of City Garden Apartments were understandably alarmed when a 'dangerous building notice' was issued because of significant defects in the fire safety systems supposed to be protecting the 16-storey tower. This notice caused concern and disruption among residents, who were initially instructed to vacate the premises by Monday.

Due to the efforts of some of our members, including a fire protection service and a fire engineering consultancy, the building has now been deemed safe once again.

Some of the key issues that were identified and resolved included:

- I lack of an audible alert tone in all apartments in the building
- Insufficient smoke detector coverage, particularly in common areas
- ) inadequate evacuation procedures.

It is very concerning that the building had been left non-compliant since some time in 2017, primarily because of inadequate servicing and maintenance of the fire systems by

a non-FPANZ-member company. This case should serve as a stark reminder of the grave consequences of neglecting fire safety protocols and the importance of entrusting such crucial responsibilities to competent and experienced professionals. The moral and legal obligations that we sign up for when providing services must not be underestimated. Luckily, there was no loss of life in this situation.

As members of FPANZ, it is incumbent upon us all to prioritise the safety and wellbeing of occupants in all buildings under our purview. FPANZ urges each of you and your staff to remain diligent to ensure that fire safety systems are regularly inspected, serviced, and maintained to all relevant standards and codes to prevent such incidents from occurring in the future. Where owners are unwilling or uncooperative, these matters should be clearly documented and reported to the territorial authority, Fire and Emergency New Zealand, and other appropriate organisations.

Let us all take this opportunity to reaffirm our commitment to excellence in fire safety management and to continue working collaboratively to uphold the highest standards of safety within our communities. It goes without saying that FPANZ members have a duty of care and commitment to the code of ethical conduct all members are bound by. Let's ensure that we all meet our obligations and continue to protect our communities and those most vulnerable who rely on us doing the right thing.

## Dame Judith Hackitt FREng FIChemE

Independent Adviser to the UK Government on Fire Safety

A chemical engineer who has spent more than 20 years in the chemical industry. A former President of The Institution of Chemical Engineers and a Fellow of the Royal Academy of Engineering.

Throughout her career she has championed the importance of engineering in delivering solutions which benefit society. She cares deeply about safety in the workplace and more broadly.

From 2007 to 2016 she was Chair of the UK Health & Safety Executive and in 2017 conducted an independent review for the UK government into building regulations and fire safety in the wake of the Grenfell Tower tragedy. Her recommendations for radical reform received Royal Assent in the Building Safety Act 2022. In January 2024 she was appointed interim Chair of the UK Office for Nuclear Regulation.

Head of Fire Automation, Smoke Control and Signalling, Building Research Institute (ITB)

Dr Wojciech Węgrzyński is with ITB, that is the Polish Building Research Institute in Warsaw. He currently holds the position of the Deputy Head of Fire Research Department and the Professor of the Institute, and a Director at SFPE Europe.

He is an Author of 40 peer-reviewed papers published in all of the primary FSE journals. His main area of interest is the fundamentals of compartment fire dynamics and standardized fire testing, and also: use of computational fluid dynamics in fire, wind and fire interaction and evaluation of the effects of the spread of smoke in buildings. ## **HOFFE SIG Update**

It's funny how it seems that as soon as daylight savings stops we get brighter mornings but it feels like winter has begun. That said our work goes on so we continue to pursue topics of interest to our HOFFE group, while we have our main ongoing project that is the NZS4503 review, we also have other current topics that may be of relevance/interest to our members & their clients, these include:

- a) **Non-Compliant products:** Please report detailed examples of non-compliant HOFFE product that is being imported & sold onto the New Zealand market. There are a number of companies distributing products into our marketplace with claims that cannot be substantiated or are at best misleading. It is worth remembering that in order to get action from the relevant authorities we need good factual information that includes information on what the non-compliance(s) is & how it may affect people &/or property. Please send this information including contacts, any supporting documents &/or images to info@fpanz.org.
- b) **Halon:** The FPA has been able to secure a commitment to dispose of another shipment of Halon, while the majority of the Halon out there has gone now should you or your clients have some Halon 1211 or 1301 that they need to dispose of please contact the FPA directly.
- c) AFFF: another item that is gaining attention at present is the fact that, before the 3rd December 2025, AFFF fire extinguishers must be removed from service. There are now a number of Synthetic Fluorine Free Foams (SFFF) alternatives available on the market to replace these AFFF units although care should be taken to ensure equivalency in ratings, etc. One issue that remains challenging is the disposal of the AFFF. New Zealand does not have a local disposal facility and the AFFF must be exported for destruction (just like Halon). A number of waste management companies are currently working through the permitting process and expect to be able to collect AFFF for disposal in the second half of this year. Current advice is to responsibly store the AFFF pending the disposal pathways becoming available. We understand that some waste management companies, such as EnviroNZ (formally ChemWaste), are providing IBC's to their clients for this purpose. The FPANZ are monitoring developments regarding disposal options and will update members as things progress.

Our next online HOFFE group meeting is on the 19th June.

Progress is happening on a couple of key documents with the Certified Passive Fire Contractor Application document almost complete and the new Code of Practice for Fire & Smoke also underway with the established working group.

For the Certified Evacuation Consultants, the renewal process will start from next month as the annual rollover happens on 30th June 2024. We will be sending emails to the current Certified Consultants approx. mid May to allow time to process renewal applications. Congratulations to our two new Certified Consultants that came through the vigorous application process earlier this year.

We are pleased to announce we are now an approved NZIA CPD Provider and will continue to provide opportunities to upskill knowledge and continue to raise the bar for our industry.

We have a Get it Right seminar coming up in late May titled 'Passive Fire for the Duplex Home/Multi-Tenanted Dwelling'. Field Advisory Bulletin – Pertronic Evacuation Amplifier EVAC50W24 – LED Address misconfiguration.

We have received advice that sites have been found where the "LED Address" has been incorrectly set on the Pertronic EVAC50W24 Evacuation Amplifier. This is a serious issue as it may prevent the evacuation signal from operating in the affected area.

It appears in at least one case that the rotary switch LED address settings were changed as a means of resetting the defect history on the amplifiers and then were not set back to the correct address. Although changing & restoring the address setting is an effective way of resetting an amplifier, there are inherent risks in that procedure. For this reason we are no longer recommending the use of this procedure after commissioning has been completed. All Pertronic manuals & documentation will be updated to incorporate this recommendation.

It should also be noted that the key operated external "Trial Evacuation" switch and the internal evacuation button directly trigger the operation of the evacuation signal and override all amplifier LED address settings. Amplifiers with an incorrect LED address setting will not give any adverse indication on the control panel. If there is any suggestion that amplifier evacuation tone addresses have been changed, we recommend that the panel programming is verified by operating a detector(s) or manual callpoint(s) in the affected area(s).

Almost all fire alarm control panels have DIP switches or similar for setting up the configuration of the panels. If any changes are made to panel or amplifier configuration settings it is essential that the system is appropriately re-tested to confirm correct operation. This is required by clause 5.1.4 of NZS 4512:2021

#### Kia ora

The Government has laid out its priorities for building and construction for the coming year, with reforming the building consent system and increasing competition for building products earmarked as key measures to encourage housing growth. The Government has also put a spotlight on building consent delays by requiring councils to submit data for building consents and code compliance certificates every quarter.

As part of this commitment, the Government has announced a package of initiatives that will increase housing supply by reducing barriers, improving competition in the building system and lowering costs. This package of changes to the Building Act will be made at each level of the building system including standards, certification schemes and compliance pathways.

As some of you will be aware there are a number of formal change processes underway that impact MBIE's building regulatory system teams, including the Building System Performance branch and the Information and Education area. The proposal would mean changes to the structure of some teams, and the disestablishment of roles. Consultation with our people on these changes is underway and final decisions are expected in mid to late May. We'll be able to provide further information once final decisions have been made.

Our events schedule has picked up for 2024, with our team at both the New Zealand Society for Earthquake Engineering conference and the Master Plumbers conference last week. Next month, we'll be at the Building Officials Institute of New Zealand Annual Conference and Expo in Wellington. Look out for us and feel free to come and have a chat!
