## WELCOME

#### Welcome to the first newsletter for 2025

This year is going to be a big year for the association and our members. We have many topics to update you on this month, so please take the time to read the newsletter and, more importantly, ensure your staff also get a copy.

#### FPANZ Turns 50

The Fire Protection Association was formed in February 1975, so this month marks our 50th anniversary. We have continued to grow well in recent years and have a bright future representing our members' interests to stakeholders. To celebrate this anniversary, we will be running many great events for our members over the whole of this year. We will also be publishing a series of interviews about the association and how we were formed. We plan to launch online learning and industry tools, and international visitors from the likes of FPA Australia and the US National Fire Protection Association will present free to our members on global trends through a series of member engagement events. Stay tuned each month for what's happening and how members can participate in these events. If you are located outside the main centres, we will also be recording and/or streaming these events. Many of the events will be free to members and offer CPD hours, so make sure you are part of the celebrations, and use the opportunity to upskill your staff.

#### **Sprinkler Water Supply Issues**

We have reported on issues with water supplies for sprinkler systems several times. Sadly, this topic is only going to become more prevalent as New Zealand's aging water supply infrastructure comes under increasing demand. We have had some good conversations with Wellington Water and have others planned soon with Watercare in Auckland, but this is going to be a nationwide issue, so FPANZ and Aon Fire Protection are working on other ways to engage on a national level as there are too many local organisations to deal with individually for essentially the same problems. However, we do need to point out that there is no quick fix to water supply issues. We are unable to deal with concerns on a case-by-case basis because of the sheer number arising. Some water supply issues are also not as simple as FPANZ asking for more water or pressure to a certain site; this is impractical and **>**

sometimes impossible when it involves extensive repairs to the network. The Sprinkler System Certifier (SSC) representative, Chris Mak of Aon Fire Protection, has some additional comments on page 9 of the newsletter.

#### **FPANZ System Project Updates**

Further to my comments last year, we are well under way with upgrading all our business systems to enable us to provide new and innovative services to our members.

Our accounts system has been successfully migrated to Xero, so our invoices, statements, and accounts payable processes have changed. If you have any questions, please contact Elaine on <u>accounts@fpanz.org</u>. Our bank accounts have not changed, and you do not need to do anything other than note that things will look a little different. We also now have better online payment methods that will flow into online bookings.

The next piece of work, which we will start testing at the end of this month, is a new member management and engagement system. This will provide a greater range of online services and resources for members, such as the ability to book seminars, attend webinars, and access in-house training content, codes of practice, best practice guides, product registers, and so on. All members and their staff will be able to create a personal login to access all these additional exclusive services. Members will also be able to record CPD hours and produce certificates after attending training sessions and update company and contact details whenever changes are needed.

The final system project upgrade will be a new emailing platform that integrates with our new systems, and part of this will enable all members to select what types of communication updates they want from us, how regularly, and in what format (e.g. email, text, etc.). This will also enable us to send reminders to people booked on in-person or online training.

#### FireNZ 2025 Update

We are already starting work on FireNZ 2025. The call for papers is now out, and the **application form** can be downloaded from our website. We are also about to release the exhibitor's information pack. FireNZ 2025 will have some great new changes this year, so don't miss out. Make sure Tuesday 7 to Thursday 9 October 2025 at the Viaduct Events Centre in Auckland is in your calendar. Those of you who attended last year will be pleased to know that we will also be using an enhanced version of the conference app that we used last year. This year it will have even more functionality for delegates and exhibitors. We will also be announcing changes to the FireNZ industry awards, the process for nomination, the selection of winners, and the awards offered.



#### **Formal Fire Interpretations**

We have had several meetings with Standards New Zealand since the change in staff, and we are pleased to announce that the pages for formal fire interpretations are now back online. The links below have all the historical documents and interpretations that have been published. We are still working with Standards New Zealand on what the formal interpretation process will look like in future. We will keep you updated once this has been resolved; until then, technically, no formal interpretations can be actioned. We have received questions from members as to whether FPANZ can undertake this process; however, unfortunately, the association does not have a legal mandate or authority to issue such interpretations.



# HOFFE SIG Update

#### Authors Steve Smith & Lance Hunt – HOFFE SIG Chairs

Well, this year's getting by quickly, just not sure if that's a good or bad thing? As I am sure many of you are aware, due to PFAS under the Fire-Fighting Chemicals Group Standard (2021-HSR002573 long form of the document) this year is also the last year for C6-Aqeous Film Forming Foam (AFFF) to be used in New Zealand.

Our FPA short form HOFFE Guidance Note document (GN01) contains valuable information & definitions that can assist you in ensuring that you and your customers comply with the requirements.

Some of the key points include:

a) In need, you can still use HOFFE that contains C6-AFFF up until the 3rd of December 2025, at which point it must be removed from service and correctly disposed of. Note: while this applies to the AFFF foam solution, any AFFF containers, delivery hoses or hardware, valve-work and/or cylinders will also require compliant triple rinsing, then care must be taken when disposing of the water used for triple rinsing. An example of this process can be found online in the 2015 Agrecovery Triple rinsing guide (<u>Agrecovery-Containers-Triple-Rinsing-and-Recycling-Guide.pdf</u>).



- b) There are AS/NZS1841.4 approved foam fire extinguishers with approved Synthetic Fluorine Free Foams (SFFF) on the NZ market to suit similar applications.
- c) The ratings from an AFFF fire extinguishers are not transferrable if it is filled with a Synthetic Fluorine Free Foam charge.
- d) SFFF has a different makeup to AFFF and different properties, the main difference being that AFFF has fluorinated surfactants that are particularly effective on extinguishing flammable liquid fires (class B). SFFF by comparison contains surfactants that are derived from natural sources such as plant extracts. As such, while still effective on flammable liquid fires it is not generally as effective as AFFF on a class B fire as evidenced by the ratings achieved under the fire extinguisher classification and rating standard AS/NZS1850.
- e) The good news is that new SFFF fire extinguishers are available and that development work is ongoing, the bad news is that these SFFF solutions are formulated differently so they are not drop-in replacements for AFFF fire equipment.
- f) Be aware that care must be taken in disposing of AFFF and that using it for training purposes is not considered acceptable.
- g) Marsden Point Refinery (Channel Infrastructure NZ Ltd) was fined \$169,000.00 in November 2022 for discharging PFAS containing fire-fighting foam into the environment during training exercises.
- h) Failure to comply with the obligations of the Fire-Fighting Chemicals Group Standard is an offence under the Hazardous Substances and New Organisms Act 1996.

On another topic, we are still looking for provable examples of misleading claims and situations where the public are being taken advantage of. These can be sent to the FPA New Zealand office, please include as much detail and traceable evidence as possible so it can be followed up.



### HOFFE SIG Update continued...

We would like to send our congratulations and are pleased to report that HOFFE group member Connor Higgs of Firewatch Canterbury has been appointed to the Fire Protection Charitable Trust Board.

In support of our efforts to fund the review of NZS4503:2005 the Fire Protection Charitable Trusts has issued a MOU for our member supplier companies to sign up to which will help provide funding for the review process. This initiative is evidenced by the FPA logo on the back of the service tags sourced from participating HOFFE member companies.

This documentation should include fire safety compliance certificates, manufacturer warranties, and inspection reports.

We were very pleased to receive a significant amount of interest in the position and thank all of those who applied. Note that we will be repeating the process in future years as trustees retire by rotation, so there will be further opportunities to become involved.

#### **Standards**

We continue our discussions with the FPANZ Hand Operated Fire Fighting Equipment (HOFFE) sector industry group (SIG) for the small levy on fire extinguisher maintenance tags to raise funds for the upcoming project of revising NZS 4503.

We would like to acknowledge and thank the fire equipment companies that have signed a Memorandum of Understanding with the Trust to pay voluntary levies which will go to support the HOFFE sector standards and training - in particular, the NZS 4503 project. To date this includes: FSE (Fire Safety Equipment), PSL Fire & Safety (Phillips & Smith), Safeworld, Firewatch, and Viking Sales and Services.

Both the New Zealand Herald and Stuff reported earlier this month on a dispute between Watercare and Foodstuffs regarding the ability of the public infrastructure to provide adequate volumes for the sprinkler system at the new PAK'nSAVE at Highland Park. The conventions usually adopt in the assessment of a water supply for sprinkler systems indicated that the public supply was more than adequate for the sprinkler system. We are aware of similar issues being experienced around the country with other water supply authorities.

On face value, it appears that some water supply authority engineers may not be aware that the actual fire fighting water demands for a sprinkler system will almost always be significantly less than the design flow, and that if buildings are not sprinklered, the fire fighting water flows will be significantly higher than for a sprinklered building.

The Association has written to Watercare to request a meeting to discuss how sprinkler systems will benefit water supply authorities and reduce the demand not only on the water supply, but also reduce the amount of polluted run-off water, amongst other positive benefits that sprinklers will provide to them. We will also look at outlining other concerns that have been highlighted to us.

We will also be aiming at opening discussions with Water New Zealand, to ensure we are communicating on behalf of all stakeholders, and not only those in Watercare's area.

Separately to this, FENZ are currently reviewing their Code of Practice for Fire Fighting Water Supplies, NZS/PAS4509. We will engage with them and ensure that all members are informed when the public consultation phase opens.

# BUILDING PERFORMANCE

#### Kia ora

The next set of Determinations 2025/001 - 2025/010 are available on the Building Performance website.

The latest upload includes the following determinations that may be of wider interest:

<u>2025/001</u> considers the purported decision to refuse to issue a building consent for reasons relating to the building's use and means of escape from fire.

2025/002 considers an authority's proposed refusal to grant a building consent for two multi-unit buildings in relation to the application of C/AS1 Part 5.

2025/003 considers the refusal to grant a building consent for the construction of a lift in an existing commercial building.

2025/004 considers the compliance of a step on an access route to a toilet facility.

<u>2025/005</u> considers an authority's refusal to grant a building consent in relation to the conversion of one level of an existing multi-storey building.

2025/006 considers the decision to issue a notice to fix for a change of use of a building.

<u>2025/007</u> considers compliance of a masonry block retaining wall with Building Code Clause B1 Structure and the protection of other property.

2025/008 considers an authority's decisions to issue two notices to fix for a change of use and construction of tents without building consent.

2025/009 considers granting of a building consent amendment with a section 75(2) condition.

<u>2025/010</u> considers the refusal to issue a code compliance certificate.
