



#### Final Chance to Register for Halon Recovery Project 30 April

First, thank you to those of you who have been in touch with details on Halon that requires disposal. This is your final reminder if you are yet to register any known Halon with us.

The database needs to be completed by Wednesday 30 April, so we can come back to you with disposal costs.

So, please do let us know or forward any previous emails to <a href="mailto:halon@fpanz.org">halon@fpanz.org</a>.

The minimum information we need from any customers with Halon is as follows:

- Location/town/site, etc.
- Client and owner details
- Photos of the cylinders in sufficient detail for us to see their condition
- Photos of any manufacturer's information tags
- ) Full details of size and volume
- Type of Halon (note that we are only accepting Halon 1211 or Halon 1301)

This is the very last time we will be able to help clients dispose of Halon. It is our industry's last opportunity to clean up unregulated fire protection Halon.

#### Subject: Notifier 50XX Heat Detectors Corrective Action Notice

We refer to your email dated 3 March 2025 from Scott Lawson regarding the Notifier 50XX Model Sensors product range.

We acknowledge that a component substitution was made to the internal composition of the 50XX Model Sensors in 2021 specifically models 5057, 5057WP, 5076, and 5076WP, where the rivets were changed from steel alloy to a copper alloy.

Our comprehensive internal testing process validated that the new copper alloy rivets did not affect the heat sensor's performance within the designed temperature range in compliance with the expected operational parameters outlined in NZS4512:2010. We consulted with internal experts whose assessment supports our position that the rivet material change would not alter the functionality or compliance of the 50XX Model Sensors with NZS4512:2010. As such, the alloy substitution was not considered a significant change or redesign to the product.

In recent weeks, Honeywell has been made aware of some 50XX Model Sensors allegedly malfunctioning in conditions within the usual operating parameters. After undertaking internal investigations to assess this potential performance issue, it has been found that the products with thermal sensors may initiate false alarms when subject to temperature changes, such as when installed on a metal roof, and the false alarm cannot be reset from the fire alarm panel.

Whilst the issue does not pose a threat to safety, Honeywell is nonetheless committed to upholding the highest standards in the industry and will undertake corrective actions with affected customers. The products affected are limited to the Notifier 50XX Heat Detectors models 5057, 5057WP, 5076, and 5076WP, with a date code range from 1031 to 4024 (inclusive) meaning products manufactured between 1 March 2021 and 20 February 2024.

Please note that detectors outside this date code range are not affected. We note that no new detectors with the material substitution have been manufactured or distributed since the beginning of 2025 and all affected stock has been quarantined in our shipping facility.

#### What to do:

Honeywell will communicate directly to our distributors and installers by distributing a technical bulletin in the coming days. The bulletin will outline the procedure for affected customers to follow and the remedy offered in more detail. In the meantime, if customers are in possession of a Notifier 50XX Model Sensor within the specified date code range, they should contact Honeywell.

## **HOFFE SIG Update**

#### Authors Steve Smith & Lance Hunt – HOFFE SIG Chairs

While the temperatures may be dropping it has been pleasing to see a bit more confidence in the business sector and a few more companies spending money pro-actively.

We still get frequent enquiries regarding claims of AS/NZS standards approved fire extinguishers that are approved as suitable for Lithium-Ion battery fires. Of concern are the claims reportedly being made to the client, where it seems to get a bit ugly is that the claims are for a fire extinguisher that is approved to AS/NZS1841.2 (water type primarily for class A combustible fires), these are also being claimed as effective against Lithium-Ion fires. As the AS/NZS framework does not even have a classification nor a test structure within the AS/NZS framework for Lithium-Ion fires no fire extinguishers are AS/NZS approved for these types of fires.

While phrases like "drastically reduce toxic smoke emissions", "drastically reduces the risk of reignition", "effectively stopping thermal runaway" may sound good the reality is that often they cannot get access to the battery risk as the batteries are covered by panels, covers etc designed to protect both the people and batteries from potential harm.

It is also worth being mindful that under the Fair-Trading Act both individuals and companies can be held accountable should claims they have made be found to be misleading and especially if they potentially endanger people.

Another situation which has arisen again is people wishing to put different powders into dry powder fire extinguishers. A recent example which popped up was where a client wanted to change their ABE dry powder fire extinguisher into a BE filled with Purple K dry powder by simply filling it with purple K dry powder, sounds simple??? A couple of things to consider:

- a) It was designed and configured to suit ABE dry powder not the finer consistency of a BE type powder.
- b) It's AS/NZS 1841.5 approval does not cover purple K BE powder.
- c) Its ratings gained under AS/NZS 1850 only apply in its original form.
- d) As stated in NZS4503:2005 section 6.2.9 "Mixing or cross contamination of different types of powders, e.g. Class BE and Class ABE types shall not be permitted. These powders when mixed, may result in a chemical reaction producing water and carbon dioxide capable of generating sufficient pressure to rupture a fire extinguisher. Such reactions may take weeks to become apparent."
- e) For some of the fine consistency BE type powders they either used restrictors in the valves or more restrictive valves and nozzles as the flow rates are quite different.
- f) As life safety, performance and liability are all important factors get tested and approved fire extinguisher suited to the risk(s) and also offer your clients training.

Something that may be of interest to some of you is an article that appeared in Industrial Safety New - Worksafe is reportedly spending \$2.7million on an additional up to 60 new recruits this year to add to its inspectorate. These are described by Worksafe as its "frontline eyes and ears across the country".

In our trade, we work in high-risk environments: penetrating fire-rated walls, installing life-safety systems, and signing off on compliance documentation that will be scrutinised if something ever goes wrong.

While most companies have some level of insurance in place, the real question is "does it actually cover what you do?"

#### **)** What You Should Be Asking Your Broker:

- Does my policy specifically include **Passive Fire Protection works**?
- Is **Product Liability** included? What are the exclusions?
- Do I need **Professional Indemnity** for issuing PS3s or QA packs?
- Am I covered for **retrospective claims** (e.g. a job completed 2 years ago)?
- What's the claim process if a failure is alleged?

#### **)** SIG Advice: Protect Yourself Proactively

- Review your policies annually especially as your scope of work changes
- Document everything: install photos, QA forms, signed scope approvals
- Don't sign off on anything you're unsure about
- Seek legal advice before signing complex subcontracts with unlimited liability clauses

We will be working on a SIG-endorsed Passive Fire Insurance Checklist to help members ask the right questions when setting up cover.

#### Certain fire fighting foams can no longer be used after 3 December 2025

The Environmental Protection Authority (the EPA) is responsible for regulating hazardous substances under the Hazardous Substances and New Organisms Act 1996 (the HSNO Act). The purpose of the Act is to protect Aotearoa's environment, people and communities by preventing or managing the adverse effects of hazardous substances.

After 3 December 2025 there are restrictions on the use of certain fire fighting foams. These requirements are set out in the <u>Fire Fighting Chemicals Group Standard 2021 (HSR002573)</u>.

#### C6 fluorotelomer (PFAS) fire fighting foams

Under the Group Standard, the transitional period for the **use of C6 fluorotelomer (PFAS) fire fighting foams** (C6 foams) ends on **3 December 2025**. At the end of the transitional period, you will only be able to use a C6 fluorotelomer fire fighting foam in a fire fighting system if you have been granted a permission by the EPA under s95A of the HSNO Act (see Condition 18 of the Group Standard).

The requirements for permission to use C6 (PFAS) foams after the transitional period ends is set out in Condition 21 of the Group Standard. As part of applying for permission, you will need to provide evidence explaining why an extension is required to transition from a C6 foam to a suitable PFAS-free alternative. Information about how to apply can be found on our <a href="website">website</a>. Any application for permission to use C6 (PFAS) foams should be submitted as early as possible so the EPA has adequate time to consider it. A fee applies to these applications.

Foams imported or manufactured for this use must comply with the purity requirements set out in Condition 17 of the Group Standard.

C6 (PFAS) foams can still be used for testing, operating or maintaining a fire-fighting system until the end of the transitional period (3 December 2025), provided the conditions of the Group Standard are met. However, C6 foams may not be used for training at any time.

#### Legacy PFAS fire fighting foams in contained fire fighting systems

Legacy C8 PFAS fire fighting foams contain Perfluorooctanoic acid (PFOA)-related compounds (which are any substances that degrade to PFOA). These foams are persistent organic pollutants (POPs), meaning they can remain in the environment and human body long-term.

For this reason, the EPA has been gradually phasing out the use of legacy PFAS fire fighting foams since 2020, and from 1 January 2023 they were no longer able to be used in uncontained fire fighting systems.

From 3 December 2025, legacy C8 PFAS fire fighting foams cannot be used in contained fire fighting systems. There is no mechanism for the EPA to provide an extension to this timeframe.

Specific requirements for the disposal of PFAS fire fighting foams are set out in the Group Standard (Conditions 15 and 22), and for transitioning a fire fighting system to PFAS-free foam (Condition 24).

Failure to comply with the conditions of a group standard is an offence against the Act. The EPA's approach to non-compliance can be found on our website <u>EPA Regulatory Compliance Policy</u>.

# Recognising high quality overseas certified building products and standards

Tēnā koe

The Ministry of Business, Innovation, and Employment (MBIE) is seeking industry input on the content of new regulations needed to implement the Building (Overseas Building Products, Standards, and Certification Schemes) Amendment Bill (the Bill).

You have been identified as a key stakeholder to participate in this targeted engagement.

The regulations will contain the decision-making criteria which must be satisfied for an overseas certified building product or standard to be recognised for use in New Zealand.

Without regulations, changes being introduced by the Bill cannot be implemented and the current regulatory barriers to using high quality overseas building products will remain.

The criteria proposed by MBIE have been informed by a 2024 industry engagement and public submissions on the Bill to the Transport and Infrastructure Select Committee. Our goal is for the regulations to:

- enable a recognition regime to allow access to a wider range of new and innovative building products
- provide the necessary safeguards to mitigate the risk of products being used that could result in or contribute to building failure.

We invite you to provide feedback on the proposed criteria before the regulations are finalised in the third quarter of 2025.

This survey will be open until 5pm Thursday, 17 April 2025.

The next set of Determinations 2025/001 - 2025/010 are available on the Building Performance website.

The latest upload includes the following determinations that may be of wider interest:

<u>2025/001</u> considers the purported decision to refuse to issue a building consent for reasons relating to the building's use and means of escape from fire.

<u>2025/002</u> considers an authority's proposed refusal to grant a building consent for two multi-unit buildings in relation to the application of C/AS1 Part 5.

<u>2025/003</u> considers the refusal to grant a building consent for the construction of a lift in an existing commercial building.

<u>2025/004</u> considers the compliance of a step on an access route to a toilet facility.

<u>2025/005</u> considers an authority's refusal to grant a building consent in relation to the conversion of one level of an existing multi-storey building.

<u>2025/006</u> considers the decision to issue a notice to fix for a change of use of a building.

<u>2025/007</u> considers compliance of a masonry block retaining wall with Building Code Clause B1 Structure and the protection of other property.

<u>2025/008</u> considers an authority's decisions to issue two notices to fix for a change of use and construction of tents without building consent.

2025/009 considers granting of a building consent amendment with a section 75(2) condition.

<u>2025/010</u> considers the refusal to issue a code compliance certificate.
