we develop documents such as codes of practice, position statements, training material, and the like. As such, we have been reaching out to other organisations. The obvious starting point was FPA Australia. We do already have a memorandum of understanding in place, and John Collie, FPAA CEO, and I have been working on several offerings that will benefit members on both sides of the Tasman. We will be focusing on reducing effort and duplication and maximising outputs for deliverables for the industry generally, and we will provide more details on these initiatives in the next few months.

We also found that the passive space was another area in which duplication and wasted effort was an issue. We have a strong passive membership base, and this part of the sector is still growing and maturing, so the need for information, training, codes of practice, guidelines, and other resources is also increasing. Given the size of our association and the fairly small pool of subject matter experts to call on to help deliver this content, it made sense to look offshore to see what the rest of the world has already produced. After considerable research and consideration, I am pleased to announce that we have now signed a memorandum of understanding with Firestop Contractors International Association (FCIA), and this collaboration will greatly assist the passive membership. Justin provides more detail on what this new collaboration means and the benefits for our members on page 7.

## **Joint Standards Update**

Last month, I mentioned that we had been invited to be part of the committee for AS/NZS 1850:2009 and AS/NZS 1841.1:2007. However, there was some considerable cost associated with this invitation. Given the importance of these two standards to our FPA HOFFE members, we have been working on how to ensure FPANZ representation. I cannot disclose the commercial details, but both FPANZ and the Fire Protection Charitable trust and one other financial stakeholder have agreed to meet this financial commitment. The next phase, which will happen shortly, will involve the nomination of committee members to represent the organisations, and we will be seeking input from industry in due course.

# **Get it Right Seminars – Fire Alarms Topics**

Just a quick reminder for fire alarms people: we will be delivering some great content in the August 'Get it Right' seminars. These seminars are essential for alarms techs wanting to increase their skills and maintain some level of continuous professional development. # **HOFFE SIG Update**

It's been great to have a few short working weeks recently, unsurprisingly most people seem to be a bit happier with the long weekends and some even get more chores done!!!

One of the concerns that has arisen in our industry over the years has been the fact that unqualified people are able to get hold of yellow service tags and various types of clippers and use them as evidence of a proper service having been carried out on hand operated fire-fighting equipment (HOFFE). The problem being that the fire equipment then appears (at least superficially) to have been properly serviced and it's not often that the supporting documents are actually requested.

I recently encountered this situation with a bus company who responded to my questions with "well then how come we can get the tags, clippers and seals so easily?" The fact is that we are all private citizens who officially have no more power to change these behaviours than anyone else, that said I took a bit of time with this gentleman and explained the situation using excerpts from NZS4503:2005 and Land Transport Rule 31001 to back up the points I was making. Whether it was to get rid of me or because lunch time was approaching, he told me he accepted my points and would use an NZQA qualified fire equipment company to carry out the servicing in the future.

Ironically, we seem to often encounter this situation with transport and higher risk companies where functional fire equipment is arguably more likely to be required and used to save people and property. In the event that the fire equipment should fail to operate properly it is almost inevitable that the finger pointing/blame game starts, this is where the comparatively small amount saved on the cost of proper servicing starts to look small.

On a different topic we as the HOFFE group would like to thank the Charitable Trust and Elaine for their ongoing support as well as their efforts in collecting the funds from our service tag initiative. As I am sure you are all aware these funds are required for the NZS4503 review and without the money nothing happens.

Our next HOFFE Group meeting is on Wednesday the 27th August, accessible from the FPANZ website.

It is important that members now get behind this qualification and enrol and then support your staff or self through to completion.

Moving forward FPANZ advice and recommendation to authorities including MBIE, BCA's, Clients, Engineers, Architects, Suppliers will be to recognise the Certification scheme as the benchmark for those contractors that have proven to have quality assurance systems in place including trained and qualified staff identified. https://www.fpanz.org/docs/certification

# Certain fire fighting foams can no longer be used after 3 December 2025

The Environmental Protection Authority (EPA) regulates hazardous substances under the Hazardous Substances and New Organisms Act (HSNO Act). These rules help protect people and the environment from the risks posed by harmful substances.

Persistent Organic Pollutants (POPs) are hazardous substances that resist breaking down in the environment, can travel long distances through air and water, and accumulate in the tissues of living organisms, including humans. They may pose serious health and environmental risks, including cancer, hormone disruption, and damage to ecosystems. Certain fluorinated firefighting foams—particularly those containing long-chain per and polyfluoroalkyl substances (PFAS) like PFOA and PFOS—are classified as POPs due to their persistence, toxicity, and potential to bioaccumulate, and are therefore subject to strict controls.

# What's Changing?

From **3 December 2025**, you and your clients must stop using fire fighting foams that contain PFAS chemicals unless you have formal EPA approval.

These requirements are set out in the **Fire Fighting Chemicals Group Standard 2021 (HSR002573)**(1) and cover fire extinguishing systems on fire vehicles and appliances, fixed fire extinguishing systems, and fire extinguishers.

# Which Foams?

# 1. C6 fluorotelomer (PFAS) fire fighting foams:

These (typically newer) foams predominantly contain short-chain (6-carbon or less) PFAS chemicals which are thought to be less persistent in the environment than the older "long-chain" PFAS (like C8). They must meet the purity requirements stipulated under the Fire Fighting Chemicals Group Standard 2021.

However, after **3 December 2025**, you will only be able to use these foams if you apply for and are granted permission by the EPA.

Some of the items the application will need to clearly communicate:

- Why the C6 PFAS foam needs to remain in service (such as the lack of a PFAS-free foam for a certain application).
- What steps are being taken to remove the C6 PFAS foam from service (such as decommissioning the system at some future point in time).
- **)** How any discharge of the foam system will be contained.

Please note that any application for permission to use C6 (PFAS) foams should be submitted as soon as possible so as to allow the EPA time to consider it – don't leave it until the end of the transitional period.

## 1. Legacy (C8) PFAS fire fighting foams:

These (typically older) foams contain long-chain PFOA-related compounds. New Zealand is obligated to phase these out under the Stockholm Convention on Persistent Organic Pollutants; a global treaty to eliminate harmful chemicals of which New Zealand is a signatory.



# Certain fire fighting foams can no longer be used after 3 December 2025 *cont*

From **3 December 2025**, the use of these foams will be **totally banned** – there is no pathway to apply for an extension of time for these foams.

If a PFAS-free foam option is not available for a system containing a Legacy PFAS fire fighting foam, consideration should be given to replacing the existing foam with a C6 fluorotelomer (PFAS) fire fighting foam and applying for a permission as described previously.

# **Legal Responsibilities**

Disposal and system transition requirements are detailed in the Fire Fighting Chemicals Group Standard 2021 (HSR002573).

Failure to meet these conditions by **3 December 2025** is a breach of the HSNO Act, and may result in the EPA taking enforcement action under its **Regulatory Compliance Policy**<sup>(2)</sup>.

Such action may include prosecution. For context, Channel Infrastructure NZ Limited was fined \$169,000 in 2022 after approximately 600 L of fire fighting foam concentrate was used during training exercises at Marsden Point Oil Refinery and ended up in Whangārei Harbour(3).
